According to the annual report of Superintendant of Public Instruction Pattengill, Michigan has 585 grad d and 6,580 ungraded school districts. The school census show 677,676 children and 455,595 pupils enrolled, of whom 248,099 attend graded schools and 207,499 ungraded. There are estimated to be 41,717 pupils attending select schools.

Of the 16,305 teachers, 5,264 are employed in graded schools and 11,041 in teachers, only 778 are men. Total wages paid are \$3,758.905.56, of which \$2,326,-527.74 are paid to graded teachers.

Take 50 hens as a basis. Calculate that each hen will raise you 20 chicks the first season, and you have 1,000 besides the hens. Then figure on an increase of 20 to each fowl the second year, and you have 20,000 chickens. The third year you increase your flock to 400,000, the fourth year to 400,000,000, and the fifth year you are the possessor of 800,000,000 chicks and over 400,000,000 old bens! It is very easy to figure out profits on paper. People may build most gorgeous air castles, but the loftier they are the greater the fall, and the fall is certain.

The only way to figure out profits is by experiment. Get your fowls and commence large or small, as you please. Keep an egg record and an account book, in which place all expenditures and income, and at the end of a year balance up the book and see where you are at. In this connection we advise opening your book about Jan. 1 .- Fanciers' Review.

# THE NEWS.

# Compiled From Late Dispatches.

CONGRESSIONAL. Proceedings of the Second Session.

In the senate on the 17th Senator Hawley (Conn.) introduced a bill for the reorganization and increase of the army. Petitions praying for the passage of a land grant forfeiture bill were presented and the Nicaragua canal bill was discussed .... In the house the army appropriation bill, the bill to protect forest reservations and afteen pension bills were passed. The Carlisle banking bill was reported and a bill appropriating \$60,000 for a statue of Gen. Grant on the east front of the capitol alongside the statue of Washington was in-

THE senate was addressed by Messrs. Hill and Turple on the 18th, the former in advocacy of cloture, the latter in opposition to the Nicaragua canal bill. A resolution looking to union with Canada was introduced by Senator Gallinger .... In the house debate on the Carlisle banking bill was begun. Mr. Springer speaking in favor and Mr. Walker in opposition to the measure. Mr. Bland announced a substitute for the Carlisle currency bill which provides for the free coinage of silven

THE report of Admiral Walker on the subject of Hawaii was laid before the senate on the 19th. A bill was passed to open for settlement abandoned military reservations in various states and territories. A bill was also passed to establish a national military park at the battlefield of Shiloh. The Nicaragua canal bill was further discussed .... In the house the time was occupied in debating the Carlisle currency bill

In the senate on the 20th bills were reported to revive the grade of lieutenant general in the army, to forfeit lands granted to aid in the construction of railroads and to provide a suitable residence for the president .... In the house bills were introduced to amend the national banking act, authorizing the deposit of legal tenders instead of bonds to secure circulation, the circulating bank notes to be exempt from taxation; to provide a residence for the president, and an urgency deficiency bill of \$575,000 to complete the census. A bill was passed to pension the widow of Maj. Gen. Nathaniel P. Banks at the rate of \$100 a month. The currency bill was further discussed.

### DOMESTIC.

John Cronin was hanged on an au tomatic gallows at Hartford, Conn., for the murder of Albert Skinner on October 6, 1893. The apparatus worked successfully.

THE Citizens' stock bank of Slater, Mo., made an assignment with liabilities of \$500,000 and assets of \$250,000. The failure caused the Slater savings bank also to close its doors.

Spain was notified by Secretary Gresham that Cuban discrimination against American goods must be discontinued, on pain of retaliation.

John and Gene Kennedy were hanged at Jasper, Tenn., for murdering James Lowrie, a railway agent at Shellmound, in October, 1893.

JOHN McBRIDE of the United Mine Workers was elected president of the Federation of Labor at its annual meeting in Denver. Indianapolis was selected for headquarters.

WILLIAM STRAUSBAUGH, a maker of spurious coin, and two confederates were captured by federal officers at

AT Gardiner, Me., a house occupied by Mrs. McReady and two children was burned, all three of the inmates perishing in the flames.

"SMILEY" JORDAN, & colored farmhand, was caught in the act of robbing a newly made grave at Mount Hope, Ky.; and shot dead.

WHILE talking with a friend at South Bend, Ind., Edwin Hardman, aged 19, leaned on the muzzle of his gun, which exploded and killed him.

EVANGELIST MOODY was meeting with great success at Lowell, Mass. "Ads." in all the papers called on church members to stay away and give the sinners a chance.

THE Lexow idea has reached San Francisco, where the clergymen are organizing a movement to purify municipal morals.

BRITISH army officers, under the guise of artists and tourists, were said to have made sketches of the territory and defenses in the vicinity of Toledo, O4 and other lake ports. In the United States circuit court at

ERASTUS F. BEADLE, the publisher of dime novels, died at his country home in Cooperstown, N. Y., aged 74 years. THEODORE HUSTON, of Macomb, Ill, United States consul at Paso del Norte, Mexico, died from consumption, aged 42 years.

SAMUEL M. BRIDGEMAN, a veteran of two wars and the oldest employe of Pinkerton's detective agency, died at Evanston, Ill., aged 76 years.

JAMES L. ALCORN, ex-United States senator and former governor of Mississippi, died at his home at Eagle Nest, Miss., aged 78 years.

Douglas Putnam, a great grandson of Gen. Israel Putnam, of revolutionary fame, died at Marietta, O., aged 88

### FOREIGN.

THE number of persons killed in the recent earthquake in southern Italy is officially stated to be eighty-six. In addition 600 were injured.

THE expulsion of Jews from territory nearer the frontier than fifty versts has been stopped by order of the Russian minister of the interior.

THE Corean government announced that Chinese would be allowed to reside only in the treaty ports of Corea. DISPATCHES say that twenty-three Armenian villages were laid in ashes, eleven others pillaged and forty priests

massacred by Turkish soldiers. VIOLENT earthquake shocks in south Hungary threw down houses and drove the residents to the streets.

In an engagement at Halai, Abvssinia, six companies of Italian troops defeated the Arabs, killing a great number of them.

FOUR THOUSAND hungry women and children called on President Caceras. of Peru, and asked for bread. A riot ensued and many persons were killed and wounded.

During a riot among government troops at Rio Grande do Sul, Brazil, many soldiers were killed. A number of the men deserted.

# LATER.

THE United States senate was not in session on the 21st. In the house Mr. Wilson (W. Va.) introduced a bill repealing that portion of the new tariff act which imposes a differential duty of one-tenth of 1 per cent. a pound on sugars imported from countries paying a bounty on sugar exported. A bill was passed for the relief of homesteaders in Wisconsin and Minnesota whose property was devastated by the forest fires last year. Mr. Springer introduced a substitute for the Carlisle currency bill.

FIRE in Cleveland, O., destroyed buildings and their contents valued at nearly \$250,000.

In New York Police Capt. Schmittberger, of the force, gave very damaging evidence before the Lexow committee against high officials.

CALVIN J. CHRISTIE was hanged at Kalispel, Mont., for the murder of Mrs. Lena Cunningham last April.

THERE were 349 business failures in the United States in the seven days ended on the 21st, against 349 the week previous and 334 in the corresponding time in 1893.

New York bankers were credited with a movement to have Secretary Carlisle removed by the president.

A GASOLINE stove exploded in the home of James A. Forsythe, a farmer living near Vilas, O. T., and he and his wife and two small children were fatally burned.

WILLIAM G. CULBERSON, mayor of Mount Vernon, O., dropped dead on the street while going to his office.

Two hundred people left Elberton Ga., for Texas, where they go, they claim, to better their condition. Men women and children composed the party.



Startling Revelations of New York Police Corruption.

NEW YORK, Dec. 22.-Capt. Schmittberger was recalled as a witness before the Lexow committee on Friday. He created a sensation by his answer to the second question asked him, which was: "Do you recognize the binding character of an oath?" He replied: "I do; I have come to tell the whole truth."

Capt. Schmittberger said he was wardman under Inspector, then Capt. Williams, in the Tenderloin precinct. Inspector Steers detailed him as precinct detective under Capt. Williams. Patrolman Price, who is now a captain, looked after the disorderly houses. Under Price these houses were allowed to run because they paid for protection.

Mr. Goff then named Tom Gould's. the Star and Garter, the Fashion, and other once famous Tenderloin places.

"These places," said the captain, were the resort of criminals of the whole city who came there to meet | ward. women."

"Who was the man to whom the protection money went directly?"

"Captain, now Inspector Williams." "Would it be possible for these places to run openly without the toleration of the captain?"

"No sir, it would not." He was made captain later on, taking charge of the thirty-seventh precinct, the steamboat squad. He was aware of the practice of collecting money from steamboatmen. Bob Vail told him that he had collected for Capt. Gastlin, and that he (Schmittberger) was a fool if he did not continue the practice. He assigned Vail to the task of making these collections, and received from him \$180 a month for two months. He gave Vail 20 per cent., and said the latter lied when he testified that he insisted on having all of the money collected. It was the common custom for the captain to make money out of his precinct. He had a list of those from

together with the amounts. He gave part of his collections to Inspector Williams. He continued:

whom collections were to be made,

When Capt. Gunner left the precinct, I asked how much he paid the inspector. Gunner told me he gave Williams between \$50 and \$75 a month. He said he placed it in an envelope and gave it to Wardman Campbell, who gave it to Price at headquarters, for the inspector. I knew Williams well, and did not think it necessary to have an intermediary, so I handed him the money myself in an envelope at headquarters. I paid him money during the three months I was in charge of the precinct, from \$50 to \$100 each time. I thought it prudent to pay him, because it was in his power to send men to raid the policy shops. The money was paid to enable the law to be violated. I påid no one but Williams. The liquor dealers paid to be allowed to sell liquor on Sunday. Some of the identical money I received was given to Inspector Williams. I presume the inspector knew of the existence of policy shops outside of my information. The shops were never raided. Had I not been interested I could have driven the policy shops from place to place. It was an understood thing that I was not to enforce the law. I felt safe as long as I paid Williams."

Witness next took charge of the Twenty-seventh precinct, on Eightyeighth street, near Avenue A. He collected there about \$800 a month from three pool-rooms and ten policy shops. He did not pay any attention to the liquor dealers. It was understood that the liquor dealers paid Tammany Hall instead of the police. They were to give support to Tammany Hall, politically or by other means instead of paying the police.

While at the Twenty-seventh precinct witness paid Williams \$200 a month out of the money collected. Williams was aware of the existence of the poolrooms. He gave Williams during the nine months he spent in the Twenty-seventh precinct about \$1,800. It was the custom of the captains of precincts to pay the inspector of their districts.

He received orders from Commis sioner Martin to let certain houses alone. On one occasion witness received a complaint about a house run by a woman named Sadie West. He sent an officer there. The West woman told him she was a friend of Commissioner Martin. The next day Martin sent for witness, and told him to send the officer to apologize to the West woman for raiding the house. Witness protested, but Martin was obdurate, and he then did as he was told, and the officer apologized.

Witness was transferred to the Tenderloin district in December, 1893. Georgiana Hastings ran a house of illfame there. She did not pay for protection, but he was informed that if he interfered with her he would be Friday night by the police. Posten worsted, as certain public officials, some of whom graced the judicial

bench, were visitors there. Mr. Goff asked the witness if there was anything further he wished to tell. He replied: "I have told all I thow about the police department and three weeks ago returned to Chicago have made a clean breast of every; almost penniless. thing. ## TRADE IS DULL.

Same acceptance of the second parties of

Hampered by Mild Weather, Gold Withdrawals and Uncertain Legislation. New York, Dec. 22.-R. G. Dun &

Co.'s Weekly Review of Trade says: "But for the large exports of gold and uncertainty about financial legislation, the indications would be more encouraging. Some increase is seen in orders given to manufacturing works, though until the year ends the force actually at work naturally diminishes. The holiday trade has been rather poor at most points, partly owing to mild weather. There is distinctly more confidence shown about the future demand for industrial products, though prices are not better.

"Domestic exports increased a little, though exportable staples are not better in price. In November the excess of merchandise exports over imports was \$29,573,891, besides \$2,931,031 silver, and December returns indicate as large an excess. For this reason the exports of \$5,332,071 in gold since last Friday and the withdrawals of about three times as much gold from the treasury, are the more noticed. Money continues to accumulate here, and there is no enlargement in the legitimate demand for commercial loans, though some offerings of paper, apparently to prepare for yearly settlements, have excited

"Prices of agricultural products do not improve. Wheat is unchanged for the week. Corn fell 4 cents for the week. Cotton has declined a sixteenth, to 5.69 cents, and receipts from plantations continue larger for December than in 1891, when the crop was over 9,000,000 bales. The theory that producers will not market at current prices does not fit the facts.

Large orders for manufactured products have appeared and yet, except in boots and shoes, the general tendency of prices is down-

The withdrawals of gold from the treasury have been over \$21,000,000 since December 8 and are attributed in part to replacement of bank receipts, which were reduced by the purchase of bonds. Yet it is plain that the desire of foreigners to get gold instead of stocks, and of Americans to get gold instead of notes, rapidly takes from the treasury whatever was gained by selling bonds.

"Failures have been somewhat more important, the reported liabilities for the second week of December amounting to \$2,714,607 and for two weeks of December the aggregate has been \$6,480,401, of which manufacturing liabilities were \$2,466,114 and the trading liabilities \$4.071,529. But last year the liabilities in failures of the same two weeks were \$11,679,996, of which no less than \$5.174.494 were of manufacturing and only \$5,301.784 of trading concerns. The failures for the past week have been 349 in the United States against 344 last year, and 30 in Canada, against 37 last year." Bradstreet's says:

"The volume of general trade continues small, as expected from evidences of shrinkage within the month. Unusually mild, unseasonable weather continues to check distribution of coal, heavy clothing, shoes and rubber goods northwest, south and throughout the central western and eastern states, although at larger cities the favorable reports as to holiday goods and specialties at retail are for the great part the outcome of bright, mild

"Jobbers and other wholesalers as a rule report commercial travelers off the road, and that little is doing except to take account of stock. The outlook for trade after the holidays is fair, although larger Chicago dealers report stocks on hand larger than expected, except amyng jewelers, who have unexpectedly enjoyed a heavy trade.

"From a dozen of the more important western and northwestern trade centers distribution of staples is reported quiet or moderate in volume except from Cincinnati, where there a slight gain. Collections are only fair at Detroit, Omaha and Kansas City, but at Chicago and St. Louis they are more prompt. Demand for funds at Chicago, as at Buffalo, has made the market firmer, packers being relatively best borrowers. Dealers in furs and jobbers in most staples at Detroit. Minneapolis. St. Paul and Milwaukee report that this, the mildest December for many years, has greatly interfered with trade."

# TO END THE WAR.

China Sends Peace Envoys to Treat with the Japanese Government.

SHANGHAI, Dec. 22.—On account of the terrific loss of credit abroad and the unimpeded progress of the Japanese armies China, on the advice of the foreign powers, has determined to surrender absolutely to Japan. Through the friendly offices of the United States the preliminaries to this end have been arranged and two high plenipotentiaries have been appointed by the emperor to proceed to Japan.

WASHINGTON, Dec. 22.-Minister Denby cabled the state department Friday that the Chinese government has appointed two peace commissioners, Chang Yin Huan and Fhao, who will proceed at once on their mission from Peking to the Japanese capital. There is some speculation here as to whether an armistice will be declared, pending the consummation of a treaty of peace. Such a course is usual in the case of wars between civilized countries, but there is reason to believe the Japanese are indisposed to trust the Chinese in the smallest degree, and if an armistice is arranged it will be upon such conditions as to insure the Japanese that they will lose none of the advantage of position which they now hold.

# CAUGHT IN CHICAGO.

Arrest of a Man and Woman Accused of Serious Crimes.

CHICAGO, Dec. 22.—Robert Posten, who wrecked the packinghouse firm of Underwood & McCoy here a year ago and his companion Hattie Collins, who is under indictment in New York city for stealing \$1,400 from Clara Harmon at the Union Square hotel last year, were arrested here disappeared in October, 1893, with the \$30,000 which he got by filling out blank checks, being the confidential man of the firm. # MICHIGAN STATE NEWS.

Michigan Grangers.

The representatives of 11,000 Michiigan grangers met in Lansing to attend the twenty-second annual meeting of the state grange. In his annual address Grand Master George B. Horton, of Fruit Ridge, deplored the unprofitable condition of agriculture and recommended that, as there was little prospect of improvement, more attention should be given to the work of bringing the expenses of government and home down to a level with the ability of the farmers to pay. Officers were elected as follows:

### Wheat Fares Well. "

According to the state crop for December wheat has not made large growth this fall, yet it goes into the winter in very good condition. The average is, for the state, 24 per cent., indicating that about one-fourth of the crop will be fed. The average for the southern counties is 25 per cent., the central 21 per cent. and northern 22 per cent. The number of bushels reported marketed in the four months, August-November, is 4,740,367, which is 1,618,-004 bushels less than reported marketed in the same months last year.

### Health in Michigan.

During the week ended December 15 reports sent in by fifty-seven observers in various portions of the state to the state board of health indicated that diarrhea and inflammation of the kidneys increased in area of prevalence. Typhoid fever was reported at thirtythree places, diphtheria at forty-two. scarlet fever at seventy, consumption at 229, measles at eight and smallpox at Detroit, Royal Oak, Manchester, Sebewa, St. Johns, Adrian, Danby, Marquette, Chester and Watersmeet.

### Michigan Census.

The census taken last summer shows that the total population of the state June 1 was 2,241,454, an increase of 147,565, or 7.04 per cent. since June 1, 1890, and 387,796 or 20.92 per cent. in ten years. June 1 last there were 1,670,797 native born citizens and 570,-857 foreign born citizens. The per cent of increase since 1884 was 7.79 and 4.92 respectively. Of the total population of the incorporated cities 551,365, or 67.16 per cent., are native, and 269,-667, or 32.84 per cent., foreign born.

## Killed His Wife and Himself.

Kazmerz Herner murdered his wife and then ended his own life at Manistee, it was supposed, during a fit of anger, the result of a quarrel. The murderer dressed himself in his best clothes, lighted candles on a table, and opened his prayer book. He then seated himself before a mirror and sent a bullet into his brain. Herner was a German, 45 years old. This tragedy makes the fourth fatality in the family during the present

The neighbors told him a young man, who, from the description they gave, Cunningham knew to be his wife's cousin and a former lover, had forced her to go away with him.

# Gets Damages After Twenty Years.

Elroy M. Avery, member-elect of the Ohio legislature, has secured a verdict for \$1,500 damages from Henry C. Spaulding, of Detroit, for malicious prosecution and personal libel. The controversy has lasted for twenty years and had its beginning over a gold watch which Michigan cavalry raiders secured from Confederate Gen. Brown in 1865 in Georgia, and which Spaulding swore Avery stole.

# To Swear in Officials.

It has been the custom in the past for state officials elected to be sworn in as suited their convenience, but this year Gov. Rich proposes to bunch the ceremonies. He has invited the newly elected officers to meet in the executive chamber in Lansing the afternoon of December 31, and Clerk Hopkins, of the supreme court, will administer the oath to all at once.

### THE BOY BRIGADIER.

History of the Young Staff Officer in the

Thomas W. Hyde, who is known as "The Boy Brigadier," was the youngest staff officer in the late war. At its close he was a brevet brigadier general, at the age of twenty-three, and therefore the youngest man in command of a brigade in the army.

When a boy of eighteen years, in the autumn of 1860, he left Bowdoin college to go westward to take his place, with two others, in the newly-founded University of Chicago. Young Hyde had influential friends in the western city. He met Mr. Lincoln several times both in Chicago and Springfield, and was invited to join the presidentelect's party to Washington, but was obliged to decline the invitation.

When the war broke out, Hyde enlisted in the Chicago zouaves, and was assigned to company D, which remained behind when the first three companies went to the front.

He had the advantage, however, of a thorough military training. Later, he enlisted in the Yates phalanx, but hearing of the recruiting in his native town-Bath, Me.-he returned home to go to the front with his own fellow townsmen.

After the battle of Bull Run he was active in recruiting a Bath company of the Seventh Maine regiment of volunteers. In the interim he taught Bowdoin students the zouave drill. When the company went to Augusta the boy of nineteen was the captain.

A meeting was held in the senate chamber to choose field officers by ballot. In spite of his extreme youth he was, at the age of nineteen, chosen major because he was the only man in the regiment who could drill a company. In his recently published book, Gen. Hyde thus describes how the colonel was chosen:

"We looked at each other askance, being hardly acquainted as yet, and finally I proposed that we put some regular officer in nomination as colonel, as none of us knew much about the business. This was seconded, and some one had the name, taken from an advertisement, of Edwin C. Mason captain of the Seventeenth infantry, recruiting at Portland. So we chese him colonel.'

Col. Mason could not get leave of absence from his recruiting service, and as the lieutenant colonel had not returned from the seat of war-he was with the Vermont volunteers-the regiment proceeded southward, under the command of Maj. Hyde.

The Seventh Maine became a part of the Third brigade of Gen. Smith's second division, Sixth corps, of the army of the Potomac.

As a regimental officer, Maj. Hyde served in all the earlier Virginia engagements, under McClellan. He was at Yorktown, Williamsburg, Mechanicsville and all the battles of the pen-

At Antietam the Seventh Maine, which had already distinguished itself, did splendid service, and was thereafter sent home to recruit.

Gen. Smith, who was then the commander of the left grand division, appointed Maj. Hyde inspector general, and as a staff officer he served until almost the close of the war.

In the later campaigns he was brevet briggdier general, and as such commanded his brigade in the Wilderness, at Cold Harbor, Spottsylvania and Ap-At the time of Lee's surrender the

### The New Jerusalem.

Twenty years ago the "Jerusalem Wagon" was famous in Jackson and Ingham counties. So much attention has been drawn to it by E. Everett Howe's new novel, "The Chronicles of Break'o Day," that old residents in the vicinity of Munith are again relating the history of the singular vehicle. Experiments on animals show that portions of the liver, spleen, kidneys, lungs, and to a certain extent of the brain, may be removed without loss of blood and without fatal results.

An American iron company has captured a \$3,000,000 contract from the Russian government for supplying armor plate for two new battle ships against competing bids from the armorplate manufacturers of England, France and Germany, including Krupp. The contract is the largest awarded by any European government in recent years, and the fact that it comes to the United States is a fine advertisement for American enterprise and skill.

# THE CURRENCY BILL-

Secretary Carlisle's Measure Discussed in the Lower House of Congress. On December 18 Mr. Springer (dem., Ill.) in committee of the whole opened the debate on

the currency bill. The great importance of the pending measure, he began, could not be more effectively emphasized than by referring to the report of the comptroller of the currency, which showed that last year there were 8,000,000 depositors in national banks having a capital stock aggregating \$1,069,000.000. Their deposits amounted to \$4,220,000,000. Mr. Springer declared that the committee had given the subject the most careful consideration. It had carefully examined the recommendations of the president and the secretary of the treasury, had called before it some of the ablest financiers in the country, and the result had been the presentation of the pending measure as a measure of financial reform.

Mr. Mahone (rep., Pa.) thought that if half the banks should fail and the other half be assessed to redeem the failed banks' notes, the solvent banks would be bankrupted to aid the insolvent banks, to which Mr. Springer replied: "If all the banks should fail under this system the note holders would be secure.'

Mr. Walker (rep., Mass.) said the bill presented by the secretary of the treasury had not one feature that could be enacted, except after remodeling, without endangering the financial interests of the country. He then spoke of value of the said vessels or their contents, or his own bill and its superiority over the Carlisle bill, and expressed his hope that his bill would be passed in place of the Carlisle bill.

Mr. Hall (dem., Mo.) said it must be distinct-

ly understood by members that the Walker bill was not under discussion and that when they came to vote they must vote either for the Carlisle bill or a continuation of the present system. Mr, Hail contended that the Carlisle bill was opposed by the national banks because they preferred the Baltimore plan. Why? # A MISSOURI BANK FAILS

Slater Institution Goes Under, with Heavy Liabilities-Savings Bank Closed.

SLATER, Mo., Dec. 18.—The Citizens' stock bank, capitalized at \$100,000, closed Monday and is in the hands of C. P. Storts as assignee. Joseph Field, cashier of the institution, also made an assignment for the benefit of his creditors. The failure is a bad one, and will catch many creditors heavily. Among them are said to be various St. Louis and Chicago institutions. The bank's liabilities amount to about \$550,000, and assets, excluding considerable worthless paper, will not exceed \$250,000.

The failure was precipitated by a call of the state officials for a statement, which showed that of the capital stock and \$250,000 of deposits there is in the vaults of the bank less than \$2,000. The failure caused great excitement and precipitated a run on the ter savings bank, capitalized at \$50,000, and resulted in the bank being closed also.

Secretary Gresham Submits Information of Behring Sea Award.

WASHINGTON, Dec. 22.-Secretary Gresham Thursday afternoon furnished the house of representatives full information touching the payment by the United States to Great Britain of \$425,000 for damages growing out of the Behring sea controversy in compliance with a resolution in the house. In transmitting the papers to the speaker, Secretary Gresham says in explanation of the matter:

"The Paris tribunal of arbitration held that the United States had no right of protection of property in the fur seals in Behring sea outside the ordinary 3-mile limit. Under article 8 of the convention of February 29, 1892, whereby the questions which had arisen between the two governments concerning the jurisdictional rights of the United States in the waters of Behring sea were submitted to arbitration, the arbitrators unanimously found that a number of British sealing vessels were seized in Behring sea or warned therefrom by cruisers of the United States on the days and at the places in the special finding mentioned, leaving for future determination the questions as to the either of them, and the question as to whether the vessels mentioned in the schedule to the British case, or any of them, were wholly or in part the actual property of citizens of the United States.

"If the plan of settlement recommended by the president in his last annual message is not acceptable to congress the remaining controverted questions must be determined either by the organization of a joint commission or by negotiations between the two governments Experience has shown that international commissions are slow and expensive. Should such a course be resorted to, the evidence would be found mostly on the Pacific coast widely scattered and counsel would be needed to examine and cross-examine witnesses. The question of indirect or consequential damages having been withdrawn from the tribunal of arbitration, the pending claims are for British vessels actually seized in Behring sea or warned out of it by cruisers of the United States.

"It will appear from the submitted correspondence that the agreement to pay a lump sum of \$425,000 in full settlement of all demands authorized to be made under the treaty and award was proposed by this government. The amount is considerably below the damages claimed by Great Britain, exclusive of the interest for a number of years. If this agreement does not receive the approval of congress and the disputed questions are submitted to an international commission, it is believed that the amount allowed and the expense of the tribunal, including witnesses and the taking of their testimony, will largely exceed \$425,000.

"In view of all the facts and what may be reasonably expected as the result of a commission, the undersigned submits that a prompt and final settlement of the vexatious controversy by an appropriation of the lump agreed upon is advisable.

### AWFUL OUTRAGES.

A Correspondent's Version of the Atrocities of Port Arthur.

NEW YORK, Dec. 21.—The World prints the following special advices from its correspondent, James Creelman, who was with the Japanese army, dated Port Arthur, November 24, via Vancouver, December 19:

"The struggle for the emancipation of Corea has been suddenly turned into a savage war of conquest. It is no longer a conflict between civilization and barbarism. Japan for the last four days has trampled civilization under the feet of her conquering army. The taking of Port Arthur and the possession of one of the most powerful strongholds in the world was too great a strain upon the Japanese character, which relapsed in a few hours back into the brutish state from which it was awakened a genera ion ago:

"Almost the entire population found in Port Arthur has been massacred and the work of butchering the unarmed and unresisting inhabitants has been continued. China is now at the mercy of the island empire."

After detailing the circumstances of the fighting which ended in the capture of Port Arthur, the correspondent tells how the Chinese mutilated the corpses of the Japanese dead. He says: "I saw the Japanese dead on the road with their heads gone and their bodies mutilated. Several corpses were without hands, two had been butchered like sheep and their hearts and livers torn out.

"As the Japanese troops moved on they saw the heads of their slain comrades hanging by cords, with their noses and ears gone. There was a rude arch in the main street decorated with bloody Japanese heads. A great slaughter followed. The infuriated soldiers killed every one they saw. No attempt to take prisoners was made. Women and children were hunted and shot as they fled to the hills with their protectors. The town was sacked from end to end and the inhabitants were butchered in their own homes. The van of the second regiment reached Fort Ogunsan and found it deserted. Then they discovered a junk in the harbor crowded with fugitives. A platoon was stretched across the end of a wharf and fired into the boat until every woman, man and child was killed. The torpedo boats outside had already sunk ten junks filled with terror-stricken people. I am satisfied that not more than 100 Chinamen were killed in fair battle at Port Arthur, and that at least 2,000 unarmed men were put to death."

# FEARED EXPOSURE.

Discovery of a Shortage Leads to a Tragedy in lowa.

COUNCIL BLUFFS, Ia., Dec. 18 .- John Huntington, remittance clerk in the Citizens' state bank, of this city, shot and seriously wounded F. N. Hayden, of Chicago, and A. Cromwell, of Minneapolis, respectively superintendent and inspector of the Fidelity and Casualty company, of New York city, and then committed suicide by shooting himself through the head Sunday morning at about 11:15 o'clock in the private office of the bank, at the corner of First avenue and Main street.

There was a shortage in the bank accounts of \$500, and this caused the act. The shortage dates from last July. On the 19th of that month four \$500 checks passed into the Citizens' bank. Only three of those checks have ever been accounted for. A most searching investigation was held, and resulted in the production of strong circumstantial evidence that the amount had been misappropriated by Huntington.

Seven Blocks Burned.

NEW ORLEANS, Dec. 21.-Fire at Napoleonville, La., destroyed seven blocks, including most of the business portion of the town. Loss, \$125.000.

### Cornstalks.

The Wisconsin experiment station has been feeding cornstalks in competition remarks that the introduction of laborwith hay. The result showed that one saving machinery has been the most pound of hay was about equal to thre pounds of stalks as ordinarily fed from the stack. The test with cut corn fodder showed that 858 pounds was equal to freding value to 1,343 pounds fed whole, the difference between the cut and the uncut varying from 12 to 60 per cent. according to the variety of corn.

At the New Hampshire station the experiments with corn fodder that had been shredded, and with crushed fodder at the Missouri station, were very satisfactory, the cattle enting it with but little waste, and it proving equal to hay. Of course the value of corn fodder depends upon the harvesting at the proper stage of growth and it being properly cured. Its value then is given as about three-fouths that of good hay. Cost depends upon the method of cutting and preparing it. Modern fodder cutters perform the work quickly and perfectly, while the shredders permit its being fed into the machine as rapidly as wheat bundles pass through a thresher, from which it comes in fine condition.

Numerous experimints turned out favor adle to corn fodder. Fed with clover hay it has given excellent results. In feeding to milch cows, as compared with hay, the test were satisfactory. Summed up, as food for stock, with ground grain and bran, the corn fedner crop is pronounced one of the most valuadle grown on the farm if utilized to the best advantage.

## thee Making by Machinery.

potent cause of the changes that have en wrought in the shoe manufacture within a decade. The genius of invent-ors has devised implements for doing pretty much all the work that is required from the cutting to the finishing of a shoe, and doing it so neatly that the inexperienced cannot distinguish handwork from machine-work, and the experienced know perfectly well that the latter is for all practical purposes as good as the former. The instruments first contrived for sewing leather were crude and imperfect; there were so many little defects about them that they were not regarded with favor, and did not do satisfactory service. But by degrees the faults have been so completely remedied that they do their work admirably, until now three-quarters of the handsomest shoes sold in the country are put together by machinery. In the factories the hands are distributed into "teams," each team constructing a particular part of a shoe, many men contributing in their several ways to its configuration. Of course the closest attention has to be given to all the details: it is essential that the materials should be selected with discriminating judgment: that the cutting should be so skill fully done that there may be no waste of stock on the one hand, and no inferior material used on the other.

## Rus ian Longevity.

From a correspondent who has passed some years in Russia, we learn that in the village of Vellkotti, in the St. Petersburg Government, an old woman is living who has just attained her one hundred and thirtieth birthday. The old lady is in the enjoyment of good health, but complains of her deafness (and no wonder). Her hair is still long and plentiful, considering her age. She spent her youth in great poverty, but is now pretty well off. She has outlived three husbands; and had a family of nineteen children, all of whom have been married, and are now dead, the last one to die being a daughter aged ninety-three. 
