Night Long Distance Rates In Effect Earlier

Minimum long distance telephone rates between most points, both within and outside of Michigan, were made effective one and a half hours earlier Saturday, June 1, when the effective hour for night station-to-station calls was advanced from 8:30 p. m. to 7 p. m. The change was made for the purpose of offering more time and more convenient hours for making calls at the night rate, according to W. M. Schroeder, manager in this area for the Michigan Bell Telephone Company. The company applied to the Michigan Public Utilities Commission for and received from it authority to make the change in intrastate rates. The change in the night rate period on calls to points outside of Michigan is made effective under tariffs filed with the Federal Communications Commission by the American Telephone & Telegraph Company.

Beginning June 1, also, night rates were offered from 5 p. m. to 5 a. m. on overseas calls to points in Europe; the rate for a three-minute call being 50 less than that for a day call.

Under the proposed new tariffs, station-to-station day rates for long distance calls, both intrastate and interstate, remain in effect from 4:30 a. m. to 7 p. m., as previously. Evening rates, which have been in effect from 7 p. m. to 8:30 p. m., and which were about 25 per cent. lower than day rates on calls to points more than 50 miles distant, were eliminated; and night rates, which are about 40 per cent. lower than day rates on calls to points more than 50 miles distant, are now in effect from 7 p. m. to 4:30 a. m.

Van Wagoner Denies US-12 Labor Violation

Murray D. Van Wagoner, state highway commissioner, has announced that an investigation by his office has shown no violation of Federal labor regulations on the US-12 relocation project between Jackson and Chelsea. The commissioner's announcement came in answer to criticism from certain quarters of the treatment of labor on the Grass Lake cut-off project. The criticism charged a general violation of codes and regulations, displacement of labor by new types of equipment, and discrimination against Michigan relief labor.

Commissioner Van Wagoner pointed out that the state highway department "is merely an agency" of the Federal government in carrying on the present construction program. If contractors follow Federal regulations, he continued, the state highway department is powerless to order new relationships with labor.

"We admit," the commissioner said, "that the use of a new type, large machine on the US-12 relocation project has displaced man labor to some extent but the contractor is within the Federal regulations in using this

equipment. I am not so sure that it would be better to discard this machinery on a work relief project but the state highway department has no authority to order the change."

The commissioner denied that contractors on the project were employing Indiana labor at the expense of Michigan and Jackson county unemployed. "What has happened," he said, "is that the contractor has used Jackson county labor on Indiana projects and returned with these same Jackson county men on the Jackson portion of the US-12 project. The fact that they have returned to Jackson county in trucks bearing Indiana license plates has perhaps misled some people."

A check-up by the commissioner showed that 61 out of 66 men employed on the Jackson county portion of the relocation were from Jackson county.

Substantial changes are anticipated in new Federal regulations covering projects under the public works program, according to the commissioner. The changes, however, will not affect projects now under construction.

Construction of grading and drainage structures on the US-12 relocation should be completed sometime in July, Van Wagoner said. Surfacing of the road probably will be placed on the Federal aid program next year, he added.

The present phase of the project covers 10.2 miles with three contracts totaling \$225,500. When the relocation is completed a series of bad curves on the present route through Grass Lake will be avoided along with a grade separation at Leoni.

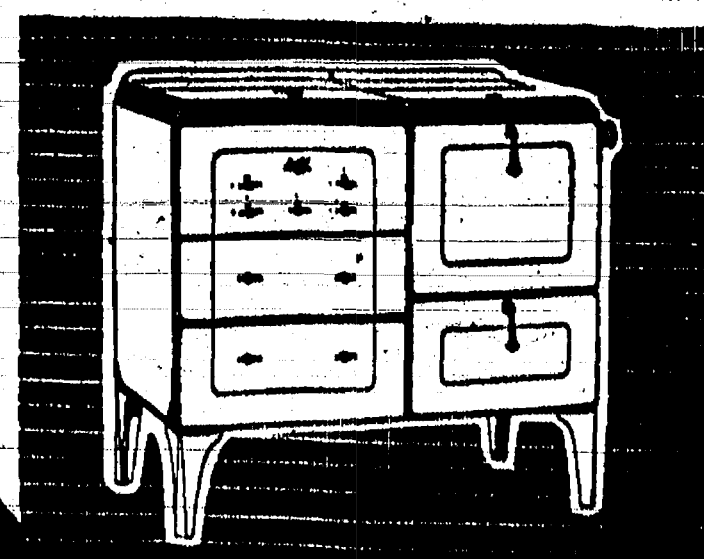

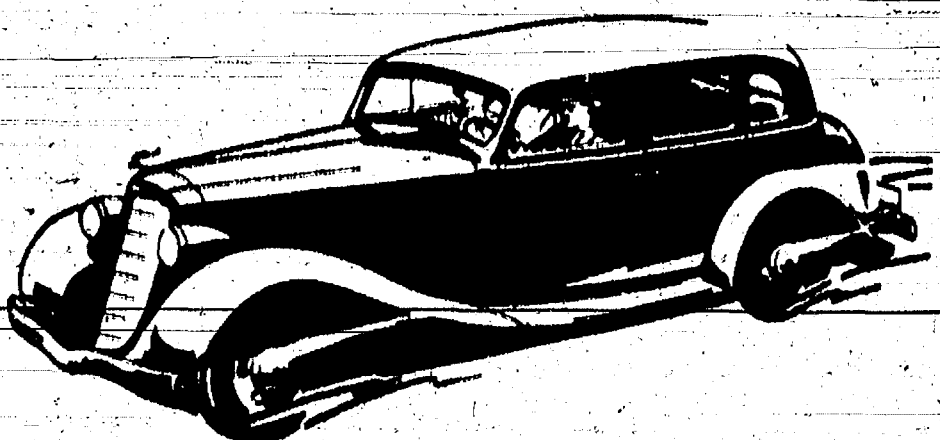

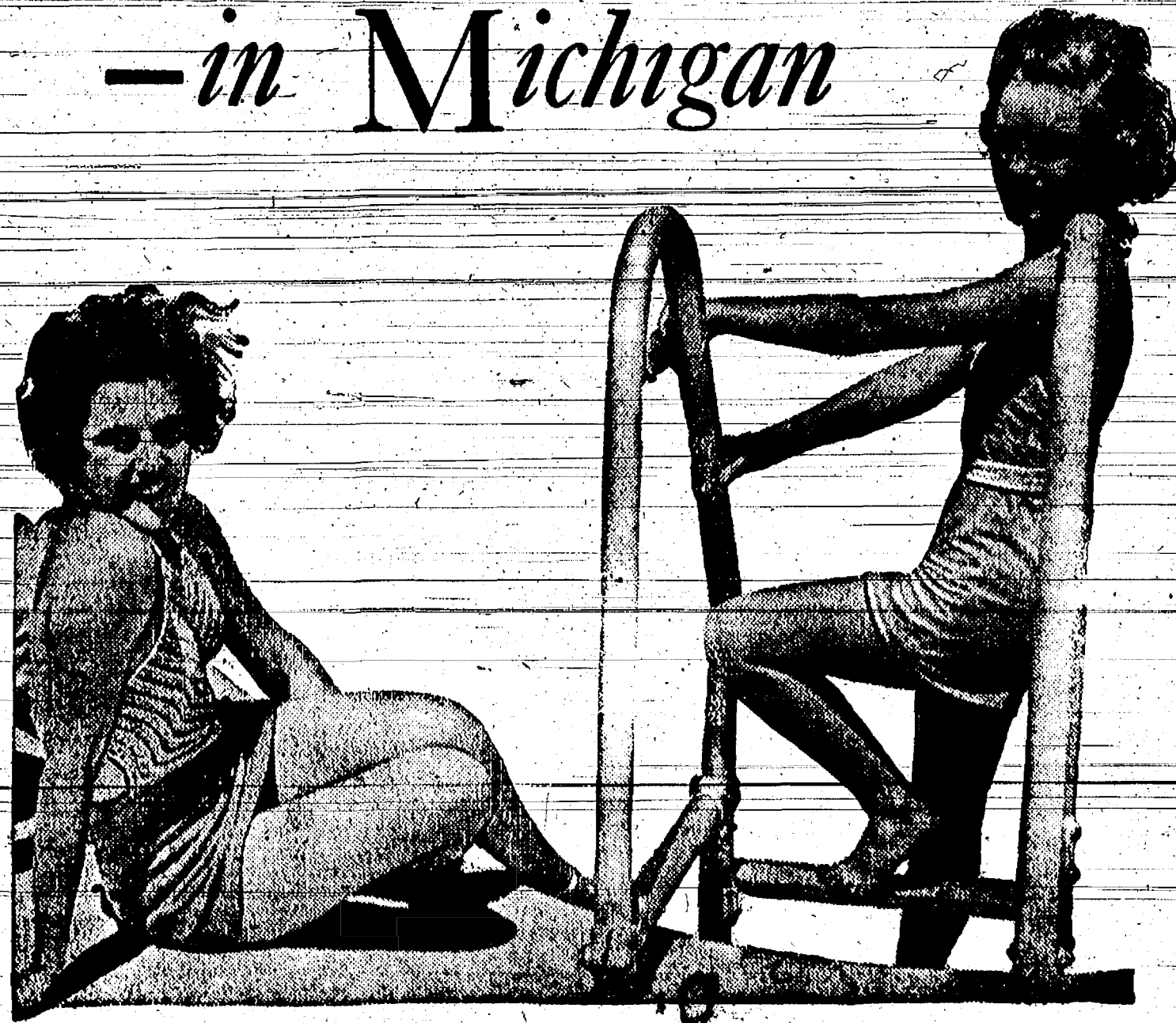

After holding school for four years in the homes of the community, a school house was built in 1835, the location being a short distance west of the present site. This building served the needs of the district until 1860, when a two-story brick school was erected, which was destroyed by a cyclone in 1923. The present building was completed in 1924. Officers of the district are: A. B. Steinway, director; Leigh Luick, moderator; William G. Luick, treasurer.

1935 Under Was As Banner Scouting Year

That 158 Scouts have been added in the 54 troops and that 434 advancements have been made during the first five months of 1935 is revealed in a June first report issued to members of the Washtenaw-Livingston Boy Scout Council. Two new troops have been organized and registered and several more are in process of organization. An average of one new Scout a day has been added to the Council Scout membership.

Active, consecrated work on the part of more than 300 volunteers who are leading Scouting in the two counties was commented upon by Scout Executive Walter MacPhee. Special commendation is made of Scoutmasters and Assistant Scoutmasters, as well as of the Field Commissioners assigned to the various troops, to aid and counsel them.

The report shows that 156 Scouts have advanced to second class rank; 43 have advanced to first class rank and 225 Merit Badges have been earned.

"We are serving more than a thousand boys but twice this number of boys in the council are waiting eagerly for the chance to become cubs, Scouts or senior Scouts," Mr. MacPhee said. "All of our committees are at work trying to create conditions so that we may soon reach this larger number. The report especially commends the committees on Court of Honor; Finance; Leadership Training; Camping; Troop Organization; Civic Service; Reading Program; Community Education; Cubbing; Senior Scouting and Health and Safety."

The Decoration Day program held at the public school auditorium last Thursday was especially well attended and a very fitting service followed at the local cemetery.

Conrad Lehman, a veteran of the Spanish American War, acted as the introductory speaker and introduced Rev. Henry W. Lenz who offered the invocation. This brings to mind that only recently the Dunkle-Baldwin bill was introduced into the legislature of the State of Michigan, being sponsored by the American Legion and demanded that all instructors in public educational institutions be required to take an oath of allegiance prior to their acting as an instructor or teacher.

A new feature in the program was that of a soldier's grave on the rostrum which was decorated with flags and flowers in memory of the departed comrades of former wars.

The benediction was given by Rev. P. H. Grabowski and the procession proceeded to the cemetery where the usual service closed the ceremony for the day.

Preceding the closing services at the cemetery all former soldiers' graves were decorated with an American flag and a small bouquet, this being done by the Legion post and taking in all the cemeteries in Lyndon, Lima and Sylvan townships.

Various committees included: Program, Walter Kalmbach; sports, Truman Lehman, Erle Notten, Milton Bohne; Table, Mrs. Truman Lehman, Mrs. James Cadwell and Mrs. Irving Kalmbach. The date set for the 1936 event is the fourth Sunday in June.

Mrs. Truman Lehman was in charge of the program for the day. It consisted of a welcome by little Duane Bohne, and assembly singing with Mrs. Loveland at the organ; accordion and drum selections by Dale Loveland and Erle Notten; recitations by Harriet Holminger and Hilda Gebhardt; vocal duet by Walter Kalmbach and Mrs. Oscar Kalmbach; musical festival songs and folk dances by school children, directed by the teacher, Mrs. Marie Rowlinson.

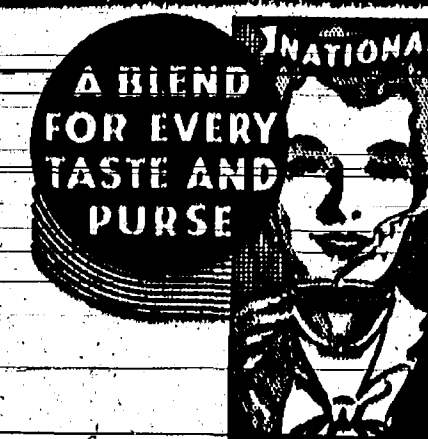
