That is the deduction of H. H. Musselman, head of the agricultural engineering department at Michigan

Electricity in Michigan has had such an unprecedented increase in use in rural areas in the last nine years that this new hazard alone requires exceptional watchfulness, says Professor Musselman. An incidental shock may be so light that the current user fails to realize that a well grounded circuit can easily take life.

Even the haymow still is a trouble-

In the haymow, says Professor Musselman, haste can easily cause accidents. Precautions include such simple things as fixing safeguards and rails around chutes, using care in pitching feed down from the mows,

and causes the majority of farm accidents, Makeshift repairs, taking chances, using machinery without guards or with guards removed are included in accident causes and all of them related to haste.

Machines take top toll as farm hazards. The older hazard from working with farm animals still is second. Unruly bulls and horses that kick are in this class of troublemakers.

The moral of which, says Professor Musselman, is to take the time to do a job correctly, so that one will have the time to complete other necessary farm work instead of being crippled or temporarily laid up because of ac-

Shortage of Rabbits Due To Mild Winter

Lansing-Wide dispersal of rabbits in open fields and on hillsides near swamps during the recent season is amounts. credited with causing many hunters' complaints of a cottontail scarcity by Paul Hickie, mammalogist of the department of conservation.

Warm weather and lack of snow during the cottontail season failed to drive the rabbits to the usual winter cover where hunters expected to find them, he explains. On a recent inspection trip through southwestern sounties he found rabbit signs fairly

Few orchardists have reported rabbit damage to date; but since damage to trees is dependent on deep snow and ice crusts, the report is not conclusive for this winter. Areas where damage by rabbits was reported were well hunted in season. There were no rabbit damage reports in areas where centers are asking the stocking of





SMALL TOWN HOSPITALS NEW YORK CITY.-It is hard to write a word unfavorable to the President's plan to have the federal government begin building small "experimental" hospitals in towns that do not have such service. I have lived in such towns myself. Even in larger towns which have had such hospitals, I have been made personally and painfully aware of the backwardness of some doctors who do not or cannot keep in touch with the rapidly improving and developing medical profession.
It is desirable to have hospitals in

many other things desirable. If it is just and proper for the government to favor one small community by building a hospital for it. how can it refuse to build one in every town in similar circumstances? That wouldn't be a matter of \$10,000,000.

Furthermore, the mere building of a hospital is only a beginning. The cost of maintaining is high. If it had been only a matter of providing buildings, the billions that have gone through WPA into some far less worthy projects could probably have built all the hospitals that are needed-especially in the old federal and civil works administrations, where billions appropriated in part for national defense went for raking leaves.

Hard-boiled as any criticism of this project must seem, congress owes a positive and pressing duty to examine in all its implications before it opens any more expanding spigots into the federal treasury. It has all the earmarks of the Arab's camel which began by persuading its master to let it stick just the tip of its nose under the tent to get it out of the cold, and wound up by wearing the tent as a horseall in the chill of the outer dark-

Washington was right when he warned us that there is no softhearted altruism in the selfish and unscrupulous fenagling of European diplomacy-especially in times of war and danger. France sent us help in our Revolution, but it was only because it was a terrible blow at her enemy-England.

We can rely on nothing in these times but our own hard-boiled common sense and the strength of our own right arm. They are enough
