

### Lansing—It's a giddy merry-go-round!

First, Michigan farmers are given instruction in better crop methods and better soil management practices. They are told to turn under green crops for manure, keep soils covered in winter with legumes and winter wheat and winter rye, keep hillsides and knobs covered all seasons in order to lessen erosion and conserve fertility, and increase acreage production through the use of fertilizers and select seeds.

Result: Forty-four of Michigan's leading crops showed a better average ranking in 1939 than they did in 1938. While losses occurred in national ranking for acreages, there were actual gains in national ranking for production—and that meant growing more food on less land.

Top rating was achieved nationally by cherries, late strawberries, late celery, field beans, peppermint and spearmint, and cucumbers for pickles. Peach output moved from eleventh to fifth place; alfalfa seed, tenth to fourth.

### What About Surplus?

Second, agricultural production under stimulation of better practices has resulted in an increasing surplus.

That's where the state department of agriculture enters the picture with its program to inspect and grade Michigan food products, to educate the consumer to the superiority of Michigan products through advertising and thus to absorb any surplus without resorting to ruinous low prices which would be below cost of production.

Another government agency which is helping to move surplus farm production is the Surplus Commodities Corporation, a federal organization. Supplementing the state relief allocations of the state welfare commission to county welfare commissions are federal allowances of surplus food commodities.

The Surplus Commodities corporation also enters the Michigan market and buys carloads of surplus food for shipment to other states for supplemental relief use.

A third activity of this corporation is now in operation at Grand Rapids where food stamps are available to persons on relief for purchase of designated surplus commodities in lieu of direct distribution of these commodities from food depots. Persons who receive orange stamps for purchase of food also receive free 50 per cent more in blue stamps which can be used for purchase of surplus commodities.

It is another subsidy, of course, financed by the federal government to help both the needy and the farmer. So far, the food subsidy scheme has had an amazing degree of popularity.

### Farming Advance

The advance in farming has brought revolutionary changes.

Mechanization has forced more than 1,000,000 farmers to leave American farms in a recent period, according to Dr. Alexander, head of the Farm Security Administration. (Recall the exodus in "Grapes of Wrath.")

Yields of corn in the ten corn belt states were, in the years 1936 to 1939, 22.8 per cent above the 1929-33 average.

Yields of cotton lint are 35 per cent greater per acre today than they were 10 years ago.

According to the secretary of agri-

culture, "One hundred and fifty years ago it required 19 people living on the land to support themselves, and 1 person in town. Today 1 person on the land supports himself, 3 people in town, and 1 overseas."

And yet, if government statistics are to be believed, farmers comprise 25 per cent of our total population, yet they receive only 11 per cent of the national income. With a European war shutting off part of normal exports of food overseas, the surplus problem together with the lack of farm-industry parity prompted the United States senate recently to appropriate \$85,000,000 for food stamp subsidy as part of a \$951,884,000 appropriation for farmers through parity payments (212 millions), soil conservation checks (438 millions) and so on.

### Civil Service

That civil service may become an issue in the 1940 state campaign was previously indicated by Democratic leaders who defended the Murphy civil service act and deplored the Republicans' revision of this act.

Another straw in the wind is seen in the action by the Michigan Merit System association which took a first formal step last week to write civil service principles into the state constitution itself.

If 165,000 signatures are obtained to petitions, Michigan voters will have the opportunity in November to approve or reject an amendment creating a non-salaried, bi-partisan civil service commission of four members, each appointed by the governor for eight-year terms and automatically assessing 1 per cent of the state's aggregate payroll for personnel administration.

Whereas approximately one-half of the state's salaried workers were removed from civil service classifications by the 1939 legislative act, the proposed amendment would permit only two exempt positions "for each elected administrative officer and each department, board and commission."

### Retail Grocers

At the annual convention of the Michigan Retail Grocers and Meat Dealers association at Lansing, Attorney-General Thomas Read declared that the time has come when Michigan citizens must choose between economy through elimination of "some of the less-essential state functions" or increased taxes to pay for "more from your state government."

Read echoed statements made by Governor Dickinson when he said that pressure groups who "browbeat legislators for special favors" were responsible for further centralization of power at Lansing.

Retail grocers and meat dealers voted to support the food stamp plan, referred to earlier in this column.

Gains by independent retailers were shown last month in reports to the federal department of commerce from 22,988 independent stores in thirty-four states indicating that sales in March were 23 per cent above those in February, 1940, and 6 1/2 per cent greater than in March, 1939. The number of independent stores increased 190,000 between 1929 and 1935.

### Manufacture of Glass Wool

### Best Plan Is To Swat Fly Before He Flies

It takes an entomologist to figure out that it's almost a useless gesture to swat flies or to hang up sticky fly-paper.

At least C. B. Dibble of the Michigan State College staff says it is far more important to prevent breeding of flies than it is to wave a swatter. Of course he admits that once they are inside the house or barn then swatting or spraying has some merit.

If given opportunity, a new hatch of flies will appear every three days from April to November in Michigan, according to Dibble.

Trash or decaying organic matter is responsible for most flies. So now is a good time to do some cleaning-up as a blessing for both household and barnyard, the entomologist reports.

Straw stacks ought to be capped so that they shed water, for moisture is one of the necessities for rearing new crops of flies. Manure should be hauled frequently and spread thin so that it is dried quickly. Garbage ought to be kept covered, or if buried, should be a foot under the soil surface.

Milkhouses, homes, and other buildings ought to be screened if possible. Dry feed lots help control the pests, for if wet feed lies around on the ground a breeding place is set up for flies. Dibble recommends a feed lot that can be washed off if refuse collects.

So that is his recipe for fewer flies.

Cleanliness, he promises, is far more important than flypaper, traps or swatters. One other pointer is that the use of lime in refuse is not a preventive, but that a sprinkling of borax will prove effective.






