## Factory Employees Help Men In Service

Something rather unique in the way of substantial remembrances and appreciation shown to servicemen and women which up to this time has been quietly carried out by the employees of a local factory would have served for an example for groups in much larger places than Chelsea.

Since the beginning of the draft, when only a few men from the factory were drafted, and their service pay was still only \$21 a month, the Employees' Association of the Federal Screw Works, Chelsea Division, has sent each one of the 167 men and women who had been employed at the plant for three months prior to entering the service, a monthly check for \$15 for a period of eight months.

It had been the intention to keep this up for the length of time each was in the service, but with the beginning of the war so many were called into the service that it became impossible to do this for eight months while they were becoming accustomed to life away from home and old friends was lightened to a great extent for each one by the knowledge that former fellow employees at the Federal Screw Works in Chelsea were thinking about them. Letters received by the association from all over the world told about how much this was appreciated.

The Employees' Association, in the beginning, had only the money received from the profits on the sale of candy and soft drinks in the plant, and the three per cent return on premiums which the association received from the insurance policies of employees insured through the association, but when so much more money was needed, a plan was devised whereby each employee, at the end of the deduction of fifty cents a week from his or her pay check to be turned over to the association secretary and treasurer, Olie Johnson, who has faithfully administered the task of sending out these checks each month during the entire time since the plan was put into effect. This has been a small task, keeping the addresses up-to-date alone being quite an undertaking for such a large group.

Elmer C. Burns, of the estimation, production and engineering department at the Federal Screw Works, Chelsea Division, is president of the association.

As a fitting climax to this wartime project of the association, which altogether amounted in collections for this purpose, to about \$29,000.00, the remainder of the sum left after the deductions from pay checks was discontinued in September, 1945, and amounting to \$10,668.00, was divided up between 165 servicemen and women that Mr. Johnson has been able to locate, to date. Each one receives an amount arrived at by adding up the total months of service of the entire group up until September, 1945, and dividing the amount left (\$10,668.00) by this number (total months of service of the group) which made the amount per month of service to be paid to each individual, \$2.10, counting each one's months of service from the date of induction until the plan was discontinued last September.

Checks have been distributed during the past month to all those whose addresses were known, and there are still quite a number to be sent out when correct addresses are available. Each one who left for the service while an employee of the company (providing they had been employed at least three months) received the monthly checks for eight months, and in addition shared in the final distribution of funds. Those employed less than three months at time of induction shared only in the final distribution. All shared in this final distribution regardless of whether or not they returned to the Federal Screw Works to work after discharge.

ations thereto, to continue until the payment in full of the principal and interest of the bonds; subject to prior lien as set forth in ordinance 35 of the Village of Chelsea.

The new revenues so pledged shall be and remain subject to said statutory lien until the payment in full of the principal and interest upon said bonds. The holder or holders of such bonds representing the aggregate not less than 20 per cent of the entire issue then outstanding may, either at law or in equity, by suit, action, mandamus, or other proceedings, protect and enforce said statutory lien and enforce and compel the performance of all duties of the officials of the borrower, including the fixing of sufficient rates, the collection of revenues, the proper segregation of revenues and the proper application thereof. Provided, however, that said statutory lien shall not be construed to give any holder or owner of any bond or coupon authority to compel the sale of the public improvement, the revenues of which are pledged thereto.

If there be any default in the payment of the principal or interest upon any of said bonds, any Court having jurisdiction in any proper action may appoint a receiver to administer and operate said system, including appurtenances and extensions thereof, on behalf of the Village and under the direction of the Court and by and with the approval of said Court, to perform all the duties of the officials of the Village more particularly set forth in Act No. 94, Public Acts of Michigan, 1933, as amended, and the within ordinance.

The holder or holders of any such bonds, or any coupons therefrom, shall have all other rights and remedies given by said Act No. 94, Public Acts of Michigan, 1933, as amended, and the within ordinance.

Section 6. The Village Council may redeem said bonds or any bond before the maturity date thereof by paying the bondholder of record the sum due on the principal and interest on the interest-bearing date, provided written notice is first served on the holder, or registered owner thereof, as the case may be, at least 60 days in advance of the payment date, and if said notice is served on the holder or registered holder, then said notice of redemption shall be published in a paper having state-wide circulation, and which regularly carries financial investment news as a part of its content, at least 30 days prior to the payment date. Said bonds are callable in inverse numerical order beginning with number 22.

Section 7. These bonds shall be executed by the Village of Chelsea in such form and nature that a holder thereof may transfer them as negotiable instruments in accordance with the law merchant and the Uniform Negotiable Instruments Law, or may request the Waterworks Department, or such other department or official interested in the books for said water works and sewerage disposal systems to register them in his name on the books of such department. Said bonds may, at the option of the holder, be registered in the name of the principal only.

Section 8. The improvement, enlargement and extension of the water works and sewerage disposal systems shall be under the immediate operation of the Superintendent of Waterworks of the said Village of Chelsea, subject to the approval and regulations promulgated by the Village Council of Chelsea.

The Village Council reserves the right to issue additional bonds of equal standing and priority with the bonds hereby authorized, for extensions and improvements to said system, when the revenues of the preceding fiscal year, after payment of operating expenses, shall equal 110% of the combined average annual revenues of the principal and interest of all bonds of this issue outstanding and any additional bonds that may have been issued pursuant to this section, together with the additional bonds so to be issued.

Section 9. The rates for services furnished by the water works and sewerage disposal systems shall be levied upon each lot or parcel of land, building, or premises having any connection with the water works and sewerage disposal systems on the basis of the water used thereon therein as the same is measured by the Village water meter therein used, and shall be collected at the same time, and in the same manner as provided for the payment of water bills. The Village Council may classify users of water from the water works and sewerage disposal systems according to the quantity of water used, and may charge such rates in each class as they may deem reasonable and just with the privilege of raising or lowering the rates after 30 days notice to the consumers and users of water from the water works and sewerage disposal systems.

The rates and charges for the use of the water works and sewerage disposal systems in accordance with ordinance 42, all charges for such water used or consumed shall constitute a lien on the property served by the water works and sewerage disposal systems, and if such rates are not paid they shall be collected in the same manner as the general Village taxes.

Section 10. The rates and charges fixed by the Village Council are estimated to be sufficient to provide for the payment of the interest and principal of all outstanding bonds at such time or times when the same shall become due and payable, to create a bond and interest redemption fund therefor, to provide for the payment of the expenses of administration, operation, and maintenance of the said water works and sewerage disposal systems as are necessary to preserve the same in good repair and working order, to build up a reasonable reserve for depreciation thereof, and to build up a reserve for reasonable and proper improvements, betterments and extensions thereto other than those which are necessary to maintain the same in good repair and working order. Such rates shall be fixed and revised from time to time as may be necessary to produce these amounts, and it is hereby covenanted and agreed at all times to fix and maintain such rates for services furnished by the water works and sewerage disposal systems, and regulations governing the operation and management of the water works and sewerage disposal systems and

the collection of the service rates as it shall deem to be necessary and proper. The Waterworks Department of the said Village of Chelsea may make such further regulations for the management and protection of the water works and sewerage disposal systems as it may deem reasonable and necessary, but these shall not conflict with or be inconsistent with the rules and regulations promulgated by the Village Council, or with or in violation of any regulations by the Village Council and the Waterworks Department shall have the same force and effect as ordinances of the Village.

Section 12. The water works and sewerage disposal systems shall be operated on the basis of a fiscal year commencing on January 1 and ending on December 31.

Section 13. The gross revenues of the water works and sewerage disposal systems including all appurtenances and extensions thereto, are hereby pledged and ordered to be set aside and distributed monthly or otherwise into separate funds as follows:

(A) Operation and Maintenance Fund. The amount of the gross revenues sufficient for the payment of the current reasonable and necessary expenses for operation, administration, and maintenance of the water works and sewerage disposal systems, which sum shall include insurance.

(B) Bond and Interest Redemption Fund. There shall be next established and maintained a Bond and Interest Redemption Fund (hereinafter called the Bond Fund) which shall be used solely for the purpose of paying the principal and interest of the bonds. The Village Council shall set aside a sum equal to 110 per cent of the aggregate of the principal and interest of the bonds becoming due each year, and such sum shall be deposited in the Bond Fund. The amount by which each such payment exceeds such aggregate amount of interest and principal shall be held in the Bond Fund as a reserve for deficiencies in the amount of the Bond Fund provided with the provisions hereof, and in no case shall it exceed the statutory requirement of section 31, Act No. 94 of Michigan, 1933, as amended, provided, however, that no further payments shall be made into the said Bond Fund after the date when the bonds have been retired so that the amount then held in said Bond Fund including such reserve for deficiencies is equal to the entire amount of the interest and principal that will be payable at the time of the maturity of the bonds, which then remain outstanding. If in any fiscal year the Village of Chelsea shall fail to pay into the Bond Fund the full amount hereinabove stipulated, then an amount equivalent to such deficiency shall be set apart and paid into the Bond Fund from the first available revenues of the following fiscal year or years. If the Village shall fail to make any such payment into the Bond Fund as aforesaid during any fiscal year, any sums then held in the Bond Fund shall be reimbursable therefrom from the first available payments made into the Bond Fund in the following fiscal year or years in excess of the required payment for the current fiscal year. The amount of the Bond Fund as hereinbefore provided shall be deposited in a Federal Reserve System member bank.

(C) Depreciation Fund. Out of the remaining gross interest and revenue of the water works and sewerage disposal systems there shall be set aside a reasonable sum sufficient to build up a reserve for depreciation of the existing system, and in no case shall it exceed \$3,000.00 per annum.

(D) Contingent Fund. Out of the remaining gross revenues there shall be set aside a reasonable sum to serve as a reserve for reasonable and proper improvements, betterments and extensions to the existing system.

(E) Surplus. Any remaining revenues together with any surplus accumulated in the Operation and Maintenance Fund which may be in excess of the cost of operating and maintaining the water works and sewerage disposal systems during the remainder of that particular year and the balance of the year shall be transferred to the Bond Fund in excess of the amount necessary for probable replacements to be needed during the particular year and the next ensuing fiscal year, as determined by the Village Council, and any monies in the Contingent Fund in excess of the amount necessary for reasonable and proper betterments to the Water Works Plant during the particular fiscal year and the one next ensuing shall be transferred to the Bond Fund to be used for the purpose of redeeming bonds or used to purchase outstanding bonds, and if used to purchase bonds in the open market, which are not yet due, such bonds shall purchase for not more than the fair market value and shall thereupon be cancelled, provided however, that any such transfers from the Operation and Maintenance Fund and/or the Depreciation Fund to the Bond Fund shall be an abatement of the Bond Fund requirements as hereinbefore mentioned.

Section 14. The gross revenues derived from the operation of the water works and sewerage disposal systems shall be deposited in the Federal Reserve System member banks, duly qualified and doing business in the State of Michigan in the separate and special funds above-mentioned. All such monies shall be deposited in a bank shall be deemed to be special and not general deposits.

Section 15. Said bonds shall be sold and the proceeds applied in accordance with the provisions of said Act No. 94, Public Acts of Michigan, 1933, as amended after publication in the Michigan Investor at least 14 days before the time of such public sale, the time and place of such sale.

Section 16. The Chelsea State Bank of Chelsea, Michigan, is designated as the depository for the proceeds of the sale of such bonds and for the revenues of the water works and sewerage disposal systems, and such monies shall be deposited in said bank to the credit of the appropriate funds.

Section 17. The Village of Chelsea shall have as security for the collection of the water rates, charges, rentals, or assessments to be levied due for the use or consumption of water supplied to any house or other building or any premises, lot or lots, parcel or parcels of land by the water works and sewerage disposal systems of said Village, a lien on property

supplied as aforesaid. Such lien shall become effective immediately upon the distribution of water to the premises or property supplied as aforesaid. The official records of the Village Clerk or Waterworks Department shall constitute notice of the pendency of said lien.

Section 18. The lien created by this ordinance shall have priority over all other liens, except liens created by the mortgage of a house or other such other liens accrued or were recorded prior to the lien herein created.

Section 19. The provisions as to this lien for security shall not apply in any instance where the taxes have been legally assessed, containing a provision that the lessor shall not be liable for payment of water bills accruing subsequent to the filing hereinafter provided for; provided, that an affidavit with respect to the execution of such lease shall be filed with the Village Clerk or Waterworks Department, and twenty (20) days notice shall be given by the lessor of any cancellation, change in, or termination of the lease.

Section 20. Where such an affidavit has been filed with the said Village Clerk or the Waterworks Department by any lessor, the lessee shall deposit with the above-named Village Clerk, the sum of \$10.00 before the filing of said premises described in the affidavit. The Village shall hold such deposit during the tenure of said lease, and at the termination of the lease, the Village shall return such sum to the lessee, and if the lessee is left after paying any damages incurred by the Village, and after payment of delinquent water bills including the final bill when service is discontinued.

Section 21. All unpaid water rates, charges, assessments or rentals which upon the first day of April of each year shall have remained unpaid for a period of six months or more shall be reported by the Village Clerk or Waterworks Department to the Village Council at its next regular meeting in the month of April. The Village Council shall thereupon order the publication in a newspaper published in the Village of Chelsea, a notice to all owners of property within the Village of Chelsea, of the unpaid rates, charges, assessments, or rentals which have remained unpaid for the period of six months or more as of the said first day of April and which shall not be paid within the time fixed in the notice, to be transferred to the tax roll and assessed upon the Village tax roll against the property on which the water was used from the waterworks or sewerage disposal system for which the unpaid rates, charges, assessments or rentals accrued, to be collected in the same manner as the lien created by the Village taxes on said tax roll, and if the same shall remain delinquent and unpaid after the expiration of the time limited in the warrant for the collection of the same, the unpaid rates, charges, assessments, or rentals shall be returned to the county treasurer to be collected in the same manner as the lien created by the village taxes on delinquent tax roll of the Village of Chelsea.

Section 22. The Village may discontinue water service from the premises or property against which the lien herein created has accrued and shall not be turned on again to said premises or property or to the occupant of the premises until the full amount of the same shall have been paid, provided that where an affidavit of lease has been filed with the Village Clerk or Waterworks Department in accordance with the provisions of Section 18 of this ordinance, any such unpaid rates, assessments, or rentals shall be deducted from the deposit provided for in section 20 hereof, and where such unpaid rates, charges, assessments, or rentals exceed the amount of such deposit, the Village may discontinue the water service from the premises or property leased and as to such lessee individually until the same are paid and the amount of the deposit herein provided be re-established in full; provided further that such amount of the deposit on such premises or property shall cease upon the termination of the lease of which affidavit has been given and removal of such lessee from the premises or property.

Section 23. In all cases where water service has been discontinued as to any premises or property because of non-payment of any water rates or charges, the Village shall charge a "turn-on" fee of one dollar at the time the water is turned on.

Section 24. All unpaid water rates or charges may also be collected by suit brought in the name of the Village of Chelsea against the owner or occupant of the premises or property, or both.

Section 25. The bonds hereby authorized for the financing of the water works and sewerage disposal systems shall be substantially in the following form:

This bond is one of a series of 22 bonds of like date and tenor, except as to the date of maturity, aggregating the sum of \$22,000.00 issued pursuant to the authority of Act No. 94, Public Acts of Michigan, 1933, as amended, and the within ordinance which bonds do not constitute an indebtedness of said Village of Chelsea, Michigan, for the purpose of improving, enlarging and extending the water works and sewerage disposal systems in said Village of Chelsea, and is payable solely out of the revenues of said water works and sewerage disposal systems, including all appurtenances and extensions thereto. The Village of Chelsea hereby covenants and agrees to fix and maintain at all times while any of such bonds shall remain outstanding such rates for services furnished by the water works and sewerage disposal system as shall be sufficient to provide for the payment of the principal and interest on all such bonds when they shall become due and payable, to create a bond and interest redemption fund therefor, to provide for the payment of the expenses of administration, operation, and maintenance of the water works and sewerage disposal systems which is necessary to preserve the same in good repair and working order, to build up a reserve for the depreciation of said water works and sewerage disposal systems, and to build up a reserve for improvements, betterments, and extensions to the said water works and sewerage disposal systems other than those which are necessary to maintain the same in good repair and working order.

This bond is a self-liquidating revenue bond and the principal as well as the interest due on this bond are exempted from any and all state, county, city, incorporated village, municipal, and all other taxes whatsoever under the laws of the State of Michigan, and is secured by the statutory lien created by the provisions of Act No. 94, Public Acts of Michigan, 1933, as amended, and the within ordinance, and payable solely from the revenues of said water works and sewerage disposal systems, including all appurtenances and extensions thereto, and is not a general obligation of the Village of Chelsea.

The Village Council reserves the right to issue additional bonds of equal standing and priority with the bonds hereby authorized, for extensions and improvements to said system, when the revenues of the preceding fiscal year, after payment of operating expenses, shall equal 110% of the combined average annual revenues of the principal and interest of all bonds of this issue outstanding and any additional bonds that may have been issued pursuant to this section, together with the additional bonds so to be issued.

This bond may be registered as to principal only on the books of the Waterworks Department of the Village of Chelsea in the name of the holder, and such registration noted on the back thereof in like manner, but the registration of delivery may be registered by registration to bearer. Such registration shall not affect the negotiability of the interest coupon.

**Michigan's Peach Crop Helped By Recent Rain**

Recent rains gave an additional boost to the peach crop in most of the peach growing areas of Michigan and more than likely, will help Michigan break all peach production records this season. Charles Figg, Director of the State Department of Agriculture states that according to the Federal-State Crop Reporting Service, last year's record peach crop of 4,400,000 bushels, which broke all previous records, is expected to be exceeded this year. Their estimate as of August 1 shows 4,280,000 bushels. If this record production materializes, it will be 70 per cent over the 1945 average.

This year's crop will be of especially good quality. New methods have been developed which have aided materially in the control of brown rot of peaches, and the dry weather has helped control insect pests and diseases.

The early peaches are now being harvested. The harvest of the major portion of the crop in southwestern Michigan usually starts this week, with the peak of the season around Labor Day. Now is the time for consumers to be making plans to secure their supply of quality Michigan peaches.


