Michigan MIRROR

Newspapers of Michigan each year salute Michigan agriculture through a "All-Michigan Dinner" sponsored by the Michigan Press Association, Inc., in cooperation with the Michigan Department of Agriculture.

Annual climax to the State Convention was held Saturday evening, Jan. 21, and again newspaper editors learned new facts about the remarkable and varied history of modern Michigan.

For example, the baked potato was served to dinner guests as a reminder that Michigan holds the national championship potato record for 1949, if not for all previous years, in the remarkable yield of 1,038 bushels per acre on the Manistique county farm of Paul Van Damme.

D. L. Clananan, farm crops extension specialist at Michigan State College, has searched American records of high yields on irrigated land and can find no previous claim of such heavy production.

Van Damme reported his high yield in late September, 1949, and it was checked by R. H. Kaven, Marquette county agricultural agent. The yield of 1,038 bushels of potatoes came from a six acre plot of recently cleared land on the Van Damme farm.

Thus a Michigan farmer again has established a remarkable food record of high production.

A half century ago Michigan was recognized as a leader in the potato production of the United States. With the growth and new developments in this culture in other parts of the nation, Michigan now ranks 10th.

During the past year 17,160,000 bushels of potatoes were produced; most of this production being in the upper half of the lower peninsula and the upper peninsula.

Twenty-five years ago considerable of Michigan's supply of potatoes was produced in the southern half of lower Michigan. This acreage has almost disappeared and judging by the acreage now in the upper peninsula, it appears that most of it has moved up there.

It may not be news to readers of the Michigan Mirror that 90 per cent of the usual crop of the nation. As usual more than likely shipments will be made to every state east of the Rocky Mountains and an important supply will go abroad to meet foreign trade needs.

Cagers Win Game from Flat Rock

Bound Back Nicely After Defeat by Milan Last Week

Chelesa High's basketballers vaulted back into the league title picture last Friday night as they subdued the Flat Rock Rams, 30-19, to partially redeem themselves after a very dismal and disappointing showing the week before when they bowed very meekly to the name Milan, 46-30.

Your reporter missed the Milan game on Friday the 18th, so an eyewitness account of the game isn't forthcoming, but from all we have heard about it, they were beaten by a name before they were by a team. Chelesa got only seven points during the whole first half, while Milan was getting 21—and that's the whole story of the defeat. During the intermission the boys discovered that they hadn't been bitten, scalped, or even scratched, remembered that during the whole first half they had seen none of the Big Reds with more than two legs or two arms, and decided that it was safe to play basketball after all—but by then it was too late.

During the second half it was bucket for bucket as the Bulldogs scored 23 points to Milan's 25, apparently if the team had decided on the bus ride down to Milan what they decided at halftime, the outcome might at least have been close.

Scoring honors went to the victors John Taylor with 12 points, while Marty Tobin meshed 10 in the losing Bulldog cause. Incidentally, Milan's 46 points were the most made against Chelesa's usually efficient zone defense. Other nights this year when the offense sagged, the defense filled the gap, but the name Milan butchered both.

Last Friday night it was a much different team, and consequently, a different and more satisfying ending, as the Bulldogs throttled a fine Flat Rock quintet, 30-19, in a fine defensive show. The same Bats as in the last period, but against Lincoln a week before and was considered a title threat, so the Bulldogs had to play ball to win as convincingly as they did.

Marty Tobin contributed eight points to match the Rams' high man, Center, Denny Blue, who starred Ram forward, who poured in 22 points against Lincoln, so completely that he garnered four points that was a very disillusioned and disgruntled young man at the final horn.

Sale of 1950 Auto License Plates Is Still Lagging

A. D. Mayer, manager of the Chelsea branch of the Department of State, was notified today that there are 2,153,645 automobile owners in Michigan who have not obtained 1950 license plates for their vehicles.

At the close of last year, an average of 11,000 people daily were securing their plates, while this year the average has been less than 8,000. Making the job of licensing even more difficult is the fact that there are 170,000 more motor vehicles owned in Michigan now than in January of last year.

Disregarding the revenue from the sale, which reverts to the counties of the state on a quarterly basis and which is not adversely affected by the delay of motorists, there are nevertheless two very good reasons why we urge the public to secure plates early. First, such action will enable them to secure more rapid service, and second—

Delegation of Local People Visit New Elementary School in Comstock

Twenty-five local people and school officials went to Comstock last Thursday afternoon to inspect two new elementary schools which are of a similar type of construction as the one for which approval has been sought here last fall. Comstock is divided by the river running through the center of the town and a new school has been erected on each of the two sides of the town.

One school has eight classrooms and the other nine rooms. Neither has a gymnasium at this time but plans are included for their addition later, the Chelsea delegation was told.

Cost of the new schools was approximately \$150,000 each and the district was bonded for \$350,000. The valuation of taxable property in the district is in the neighborhood of \$7,000,000. The school census at Comstock lists 1400 persons of school age while 1200 pupils are actually attending school.

For purposes of comparison it was noted that Chelsea's property valuation is almost \$6,000,000; the bond issue sought for the proposed 17-room school with 40x80 foot all-purpose room and stage, a kitchen, showers and rest room facilities; visual aids room; library; office space and health unit and for necessary work on the present school was for \$350,000; the school census here is 800 with 675 attending school.

Visitors at the Comstock school said they were impressed with the class-rooms which are built with the same directional lighting and radiant heating that were part of the Chelsea plans.

A class meter was used in the class-rooms by the Chelsea visitors. Between 3:30 and 4 o'clock it was found that in no part of the rooms was the light less than 15 foot-candles (a foot-candle is a unit of light measurement, being the amount of light given by a standard candle at a distance of one foot). Lightest parts of the room measured as high as 75 foot-candles. It is said that 10 foot-candles of light is considered good reading light.

A representative of Lewis C. Kingcort and Associates, Inc., of Kalamazoo, was at the Comstock school when the Chelsea people were there. He told them he had shown the proposed Chelsea plan to the head of the U. S. Department of Education who declared

Polio Funds Campaign Is Lagging

Mile O' Dimes Board To Be in Place Saturday

Chelesa's March of Dimes campaign is moving rather slowly according to Mrs. Walter Mohrlock, local chairman. Factories and organizations have been personally contacted by Mrs. Mohrlock in an effort to spur contributions. Generous contributions are needed if Chelesa is to equal amounts raised here in former years. Response on the "Mile O'Dimes" board in front of the Chelsea State Bank last Saturday was gratifying, Mrs. Mohrlock said. The board is to be in place again on Saturday of this week.

According to figures of the National Foundation for Infantile Paralysis 41,000 cases of polio were added in 1949 to the previous toll of four severe epidemics within a period of six years.

Of the more than 41,000 people stricken in this past year, 80% needed help, in whole or in part, from the National Foundation for Infantile Paralysis. This nationwide organization, supported entirely by money that is contributed to the March of Dimes, has helped meet the cost of care and treatment for more than 150,000 polio victims in the past twelve years. Its 2,800 chapters in every part of the nation form a great bulwark of resistance against the ravages of polio. Your own chapter stands ready at any time to help you and your family, if polio should strike. It stands ready with funds contributed to the March of Dimes to see that no person need go without the best available care and treatment because of lack of means. It does not ask that you be destitute. It does not ask that you drastically reduce your standard of living or go into debt. It asks only that there be a real need—and that need is met quickly and efficiently.

March of Dimes funds paid for patient care for hospitalization, for special equipment and appliances, for dozens of items of expense necessary to treatment of patients. The dimes and the dollars contributed opened special polio wards—paid for beds, cots and mattresses, for medical supplies, respirators, and hot pack machines, for crutches, braces and wheelchairs. They paid the salaries and maintenance of physical therapists and nurses, and financed the recruitment of medical personnel from all over the country to serve in hard-hit areas.

Demands for assistance in this record-breaking epidemic wiped out the local treasuries of National Foundation chapters in 44 states. But even when local funds were gone, service continued with additional March of Dimes money poured into the fight from the epidemic emergency funds of the Foundation's national office.

County Chairman Named for 1950 Red Cross Drive

Herbert P. Wagner, business manager of the University Food Services, has been named chairman of the Washtenaw county 1950 Red Cross campaign for funds, it was announced today by Cecil O. Cream, chairman of the Red Cross Board of Directors in Washtenaw county.

Mr. Wagner served the Red Cross in the same capacity last year.

The goal for the county this year, according to Mr. Wagner, will be \$56,580, which is approximately the amount contributed last year.

The national quota for 1950 is \$67 million, which is slightly larger than last year's quota because there are now less reserve funds to apply than were available last year.

This amount, it was pointed out, will enable the national chapter to meet the increased demand of the national blood program and the need of service men and veterans and their families, which are continuing at a uniform rate.

All possible reductions have been made in the budget of the local chapter, Mr. Wagner explained, but it now takes more dollars to buy the same degree of service than it did a few years ago. The local chapter also has a smaller amount of reserve funds, contributed during the war, to apply to the current budget.

The chairmen of the various branches in the county, and the quotas, will be announced next week, according to the county chairman.

Brief addresses followed by the 1949 team captain, Robert Vogel, and the newly elected 1950 captain, Donald Schrader.

The guest speaker of the evening, Earle Edwards, end coach at Michigan State College, gave a very interesting analysis of the games played by State during the 1949 season. This was followed by movies of the Michigan State—William and Mary game.

Miss Pierce Dies Last Thursday

Funeral services for Miss Alma Jane Pierce, who died at her home Thursday evening after a short illness, were held at the Stannan Funeral home at 2 o'clock Sunday afternoon. Rev. W. H. Skentelbury officiated and burial followed in Oak Grove cemetery.

Miss Pierce, who was 93 years old on September 16, 1949, was the sole surviving member of a family of eleven children, all of whom were born on the Pierce farm, just south of Chelsea, which had been owned by the Pierce family since 1832. The farm was sold last month. The land grant deed, assigning the farm to Miss Pierce's grandfather, Nathan Pierce, was signed on August 1, 1833, by President Andrew Jackson. Her parents were Hiram and Catherine Cassidy Pierce.

When Miss Pierce was about 20 years old she taught school for a short time in the Merkel school on Heim road. Following the death of her parents, Miss Pierce with a sister and brother, Miss Mary and Max Pierce, operated the farm until 1915 when the sisters moved to the present home at 115 Pierce street. The brother left for the west at that time. He has not been heard from since May, 1918, and is presumed to be dead. The sister died about 20 years ago.

Two years ago Miss Pierce gave to the village a portion of the farm, land adjoining South Main street now being improved as a site for a public park to be called Pierce Memorial park.

She was a member of the Congregational church.

Survivors include cousins, nieces, nephews, grandnieces, grandnephews, great-grandnieces and great-grandnephews. The nieces and nephews residing in this vicinity are Elmer, Charles, Paul and Miss Alta Pierce, Harry Prudden, Mrs. Charles Wortley and Mrs. E. M. Eismann.

(Continued from page one) In this one year, the National Foundation and its chapters paid out \$31,000,000 just to care for victims of infantile paralysis. That amount—\$31,000,000—is more than the entire nation contributed to the 1949 March of Dimes. "Is it any wonder," headquarters spokesmen ask, "that your National Foundation has gone broke in keeping up with its obligations to the Stricken?" They continue as follows: "What is to be done? Shall we cut off help to many of those who depend upon us for assistance? Or shall we continue to fight this disease with every weapon at our command? The answer is obvious. We cannot neglect a single call for help. We must raise more money. We must have money to train polio specialists, and to educate the public against fear and panic. There is no easy way out. If we want to win this fight we cannot stop giving. So, when you join the 1950 March of Dimes please give more. Give more than you have ever given before."







I wrote that over an article in the Clarion last week, but I didn't like doing it. After all, the man it was aimed at—Slim Henderson—is a good friend of mine.





MICHIGAN MIRROR (Continued from page one) nearly one-third of the total agricultural income, was represented by a dairy snack bar presided over by the 1949 dairy queen, Miss Jane McKimmy, 17, Beaverton high school student. Approximately 140,000 farmers in Michigan have one million cows daily producing milk supplies for use as a health-giving beverage, butter, cheese and other dairy products. Last December 49 a four year old Holstein cow, "Mimow Creek Eden Repeat," completed one year lactation period during which time she produced 35,243 pounds of milk. This set a new national record for volume of milk production, and it gave to Michigan another championship honor in the field of agriculture. If all of the butter fat produced by this one cow had been processed into butter, it would have totaled 1,530 pounds!
