Michigan MIRROR

Selection of the Upper Peninsula as the location of the 1950 National Convention of the Outdoor Writers Association of America is a timely reminder that this region of approximately 16,000 square miles, larger in area than any New England state except Maine, is perhaps better appreciated by out-state travelers than by many native sons and daughters of Michigan.

This observation is prompted by an enthusiastic letter written by Clay Perry, author of *Chesire*, Massachusetts. Perry, a native of Wisconsin and a long-time resident of Massachusetts, has made five trips to the "Fabulous Upper Peninsula." He wrote an article for the *Saturday Evening Post* in 1941 entitled, "As Easy As Falling Off a Log," dealing with the log-birding event at Gladstone held annually around the Fourth of July.

Perry writes: "I doubt that there is a similar sportsman's paradise in the middle of the United States that can compare with the Fabulous Upper Peninsula. Nowhere have I ever visited in this country and Canada is there so much to offer as Michigan's Upper Peninsula."

"There is fishing unequalled anywhere else in its variety for inland waters. Trout, bass, lake trout, wall-eyed pike, pickerel, perch, etc.

"You can find more deer in the Upper Peninsula than almost anywhere else in the United States. As for scenery there are no better wonders of the Upper Peninsula to see. Among them is the famous Big Spring, Kitchitikiippi, near Manistique, the Pictured Rocks at Munising, all of the beautiful shores of Lake Superior and Michigan, Mackinac Island, historic, scenic, luxurious and its Great Lakes no automobiles allowed, only horse-drawn carriages and bicycles."

Evidently the Outdoor Writers Association agreed with the enthusiasm of Clay Perry as they accepted an invitation of the Escanaba Chamber of Commerce to hold the 1951 National Convention at Escanaba, central headquarters for the Upper Peninsula.

The writer of the "Michigan Mirror" is also not a native son of Michigan. We have traveled extensively throughout Michigan, particularly in the Upper Peninsula, and we frankly share Mr. Perry's spirit of friendliness to this vast North Country region of Michigan. If you have not visited this region in many years, it is probably not at all, we would like to suggest that you begin your travels through this "Fabulous Upper Peninsula" by a visit to historic Mackinac Island, thence north to Sault Ste. Marie to take a glance of two of the Canal and Locks whose Centennial will be observed in 1955.

Your trip well should include a day to visit the Tahquamenon River falls near Newberry, accessible either by boat from Soo Junction or by highway. At Munising be sure to take a boat ride to the Pictured Rocks. Thence west to Marquette for a view of the huge rock formations. In 1844 deposits were discovered in 1844 near Negaunee by William R. Burt.

Continuing west you arrive at L'Anse-au-Loup, entrance to the picturesque Copper Country. This is the land of the beautiful Keweenaw Peninsula and the one-time center (1889) of the greatest copper-producing region in the United States. The Calumet and Hecla company financed with \$10 million capital, produced over \$160 million in dividends from the most productive and richest mine in America.

Drive out the Keweenaw Peninsula to Eagle Harbor, take the Brockway Mountain Scenic Drive to Copper Harbor, visit Fort Wilkins State Park, and return by the central route back to Houghton. Thence to Antonogon, and Silver City where you drive to the Porcupine Mountain State Park and climb by easy trail to an escarpment giving a breath-taking view of the Lake of the Clouds. If time permits, continue west to Iron River, Crystal Falls, and Iron Mountain.

On your way back be sure to visit the Big Spring, Kitchitikiippi near Manistique at Indian Lake. Thence eastward over the US-2 Shore Drive to St. Ignace. This stretch of pavement is new and it affords one of the most beautiful views of Lake Michigan in the entire Upper Peninsula.

We would not suggest that you attempt such a circuit in only one week's time, two weeks would be ideal. We will guarantee that having made the circle, from the Sault to the Copper Country and thence southward by way of Escanaba to St. Ignace, that you will join Clay Perry in an acclaim for Michigan's vast North Country, beyond the Straits of Mackinac.

GRASS FIRE—A junk dealer's acetylene torch which he was using to cut apart a car he was wrecking to haul away, started a grass and brush fire Friday afternoon that burned over a 30-acre plot on the Louin Wheeling farm on Sylvan road in Sharon township and spread 30 feet beyond the fence on the McAtee farm to the north. Four Chelsea firemen went out with the fire truck and neighbors in the vicinity helped fight the fire which burned for two hours before it was brought under control. Tractors were used to plow fire-breaks around the area thus preventing adjacent wheat fields from being burned. Extra Care Needed...

At this time of year a word of caution is appropriate in regard to the dangers involved in open fires. All farmers, land owners, and city dwellers as well, are reminded that although the grass seems to be green, it is actually dry enough now to burn like tinder. Once a grass fire gets started now it becomes a real problem, especially if there is any breeze blowing.

The pictures on this page are graphic proof of what can easily happen.

Be extra careful in burning anything outdoors. Always call your fire chief or conservation officer before attempting to burn an area where the fire might possibly spread. They will investigate the conditions and issue a burning permit, if it seems safe. Try to do any burning after 4 p.m., and when there is little or no wind.

Remember that if a fire gets out of control and you have no permit you are liable for prosecution and possibly very heavy damages.

Soil Conservation Practices Studied at Niles Farm

A twilight meeting on soil conservation practices was held at the farm of N. H. Miles of 20735 Scio Church road Tuesday evening, July 18. Miles is co-operating with the Soil Conservation district in some pasture fertilization work and also a top dressing of fertilizer on a hay field. He has a rough piece of pasture land growing largely brome grass. It was in alfalfa, but the brome has not been taken over, and pasture has not been too "hot," so he tried out some top dressing of fertilizer this spring. Part of the field was treated with 75 to 100 pounds of 33% nitrogen fertilizer to the acre; another part with 150 to 175 lbs. to the acre and the third part without any fertilizer. This demonstration really tells the story of what can be accomplished by the use of nitrogen fertilizer on old grass pastures. He has been keeping about 20 head of cattle, mainly, on this six acres and that is pretty good pasture for any farm land. He also has a demonstration (Continued on page ten)

Youths Must Register with Draft Board

Mayor William E. Brown, Jr., chairman of Selective Service Board No. 85, at Ann Arbor, said yesterday that three full-time clerks and a number of volunteer workers are rapidly bringing selective service records in this area up-to-date. The board has been inactive for four years, one girl working on a half-time schedule being the only clerk during that time. Plans to move to new and larger quarters are almost complete, Brown said, and announcement of the new location will be made as soon as negotiations are completed. At present, the office is in the Municipal Court building.

Brown stressed the fact that a large number of 15-year-old boys in this area are draft delinquents, most of them unknowingly. He advises all boys of draft age who are at all in doubt as to their draft status to telephone the Selective Service office at Ann Arbor and ascertain whether they are properly registered and classified. The telephone number, calling from a Chelsea telephone, is 20-2-9186.

Brown said all 18-year-olds must be registered within five days after their eighteenth birthday. The penalty for non-registration is severe, Brown said, but so far, the board has been lenient, especially when the violations were inadvertent. All draftees are required to notify the board of change of address; if they marry; have any children or dependents not already listed. Brown said many of these requirements are not only necessary compliance with the law but are to the advantage of the draftee himself in fixing his draft status. Because of the backlog of correspondence, Brown said, it is better to telephone the Selective Service office for any information desired.

Brown said that Board No. 85 has been assigned a quota of 102 men for pre-induction examinations but no date was set as to when the men should be called.

Postal Department Changed Name from 'Kedron' to 'Chelsea'

Change Announced in Letter from U. S. Senator A. Felch

Just 100 years ago today, July 20, 1850, Chelsea officially received its present name, according to photostatic copies of correspondence on the matter owned by Archie Wilkinson. Previous to that date, the post office address had been Kedron because of the creek at the north end of the village which reminded first settlers of the brook Kedron mentioned in the Bible. It is possible some of these first settlers, who came from New York state, were from the village of Kedron—there, at least, they knew of the little eastern village which reminded them of the settlement here was named after it.

Elisha Congdon, one of the two Congdon brothers who platted the village, was postmaster in 1850 and, as noted on the copy of the communication from the post office department, was "continued as postmaster of Chelsea." The first Chelsea post office was probably situated in the first building erected within the village by Elisha Congdon and located on the site of the present Daniels' Buick garage. The building was later moved to the corner of East and Jackson streets and remodeled as a two-family house. It is now owned and occupied by Mrs. Mary Eder, according to records in the possession of the Chelsea Public Library.

New Contract To Give Lower Electric Rate

At Monday's regular meeting of the Village Council a new contract was signed with Consumers Power company; an ordinance was passed creating a fire district and governing the starting of rubbish fires in the village and a new subdivision was approved within the village.

The new contract with Consumers Power company, which supplies Chelsea's electric current, is expected to save Chelsea approximately \$2200 annually, based on the 1949 volume of electricity purchased here. The new contract was only recently made available by Consumers and Chelsea became interested in this advantageous contract on the basis of a letter from the company to Consumers Power company, dated August 1949, which stated that the electric current used during 1949, the year's bill for the same amount of current, under the new contract, should be in the neighborhood of \$39,000. By using such a large amount of current the village gets the benefit of the company's "large consumer demand" rate. A revised method of billing on the part of Consumers makes possible this reduction in cost for all users of such large amounts as Chelsea used the past two years.

To date, Chelsea's domestic users of electricity have been averaging bills 50 cents per month higher than in most Consumers' territory.


The Chelsea Electric Light and Water department, together with Village Council committees, will require some time to revise the rate schedules here before the new rate can go into effect, village officials stated.

What the new contract means to Chelsea users is that there will be some reduction in the rate for domestic users and a revision of the rates for commercial use when the revised rate schedule is completed.

The previous contract with Consumers was negotiated in 1943. The ordinance creating a fire district regulates burning of rubbish, leaves, etc., not only in the business district, but throughout the village. The ordinance is printed in full on page 9 in this issue of *The Standard*. It goes into effect in 20 days. In the meantime, village workmen are preparing a pit on the sewage disposal plant property where storekeepers and others may take their rubbish and burn it.

The subdivision approved at Monday's meeting is called Palmer Subdivision No. 1 and consists of the area bounded on the north by the cemetery; on the east by Essex road; on the south by Washington street in the eastern part of the village.

Documentary Evidence



OFFICIAL NOTICE of the change in name from "Kedron" to "Chelsea" was given in a letter from the Post Office Department dated July 20, 1850. A photostatic copy of this document is shown above, the text of which is as follows: "Sir: I have the honor to inform you that the Postmaster General has this day changed the name and site of Post Office at 'Kedron' to 'Chelsea' in the county of Washtenaw and State of Michigan and continuing Elisha Congdon Postmaster thereof. Very Respectfully, your obedient servant, E. S. Warren, 2d Assistant Postmaster General."

The above communication was sent to Darius Pierce by Alpheus Felch, U.S. Senator from Ann Arbor, with an accompanying letter (of which Mr. Wilkinson also has a copy) reading as follows: "Washington, July 22, 1850."

Your letter relative to the Post Office at Kedron was duly received and in reply to my communication to the Department on the subject I have just received the enclosed letter. I know nothing of the application for the change of name or location of the office until the receipt of this letter. I presume it is on the application of your people, but if not, and not agreeable to those who do business at the office, I trust you will inform me. The community who do business at the office should arrange these matters. Very Respectfully yours, Alpheus Felch."

"Washington, July 22, 1850. Dear Sir: Your letter relative to the Postmaster at Kedron was duly received and in reply to my communication to the Department on the subject I have just received the enclosed letter. The newest weapon in the battle against infantile paralysis is demonstrated by Dr. Ethel T. Calhoun, medical director of the Sister Kenny Polio Center near Pontiac. It is an electro-phrenic respirator, which can be used in place of an iron lung in certain bulbar polio cases. When the pen-shaped conductor the doctor is holding is touched to the phrenic nerve, electric current forces the patient to breathe. The Kenny Center, which is supported by the United Fund, is the only hospital in Michigan where the famed technique of Sister Kenny is employed and patients are accepted from any part of the state. 

Frankfurt—The time of year has arrived in Benzie county when the discussion of the weather as a general topic of conversation is superseded by "What is the price of cherries going to be?" This year the question is a vital one as it now shapes up with the figures 6 cents to 8 cents per pound for red sour cherries being the most often predicted. Most growers in Benzie county claim only a normal crop and some state that they won't have the tonnage they raised last year.

There is one possible bright spot for local cherry growers and that is the fact that the Federal government has become interested in the possibility of some support price.

Cherries is one of the few crops the U. S. government has never supported in price.—Benzie County Patriot







Ordinance No. 51
AN ORDINANCE CREATING FIRE DISTRICT, THE PROHIBITION OF OPEN FIRES OUT OF DOORS IN SAID FIRE DISTRICT, OUTSIDE THE FIRE DISTRICT OF OPEN FIRES OUT OF DOORS FOR THE PURPOSE OF BURNING RUBBISH OR ANY FORM OF WASTE MATERIALS, AND TO PROVIDE PENALTIES FOR THE VIOLATION THEREOF.

THE VILLAGE OF CHELSEA
ORDAINS:

Section 1. No person, persons, firm or corporation shall, within the Fire District hereinafter defined, create or knowingly permit on their premises, open fires out of doors, for the burning of rubbish, waste paper, leaves, wood, or any form of waste material, for the purpose of disposing of the same, or for any other purpose.

Section 2. The fire district, within the meaning of this ordinance, is defined as follows: North limit is the New York Central Railroad; the south limit, the alley between Orchard and Summit Streets; the east limit, 100 yards east of Main Street; and the west limit, 100 yards west of Main Street.

Section 3. It shall be unlawful for any person, persons, firm or corporation, within the Village of Chelsea, outside of said fire district, to build an open fire out of doors and leave the same unattended, or to build an open fire within fifteen (15) feet of any structure, or to build an open fire when weather conditions are such that such fire would be a hazard to surrounding buildings and property.

Section 4. Any person convicted of violating any of the provisions of this ordinance shall be punished by a fine of not more than \$100.00, or by imprisonment for not more than 30 days, or both such fine and imprisonment.

Section 5. This ordinance shall take effect and be in full force twenty days after its publication. Dated: July 17, 1950.




LIMA SHEPHERDS 4-H CLUB


