

Michigan has been in the furor of political prognostication. Who's going to do what—and when?

That far and the smoke has cleared away enough for normal vision, Secretary of State Fred M. Alger Jr. of Grosse Pointe is still the only avowed G.O.P. candidate for governor.

Friends of Lieut. Governor William C. Vandenberg of Holland insist he will be a candidate. And linked to Vandenberg by persistent rumors is the name of Mackinac Island, chain store legislative agent and former state senator from Menominee in the UP, as a possible candidate for lieutenant governor. This smiling Irishman is chairman of the citizens' committee for reorganization of state government and is committed to governmental economy. He holds the confidence of both Alger and Vandenberg, and knows Michigan politics thoroughly.

Owen J. Cleary (now G.O.P. state central committee chairman) was thought to have gubernatorial aspirations for a while, but does not now rank him as a candidate for secretary of state, the job now held by Alger.

Kit Clardy, Lansing attorney, suggested that he might run for U.S. senator "if there is a demand" to oppose Blair Moody, the active young campaigner appointed by Gov. Williams to succeed the late Sen. Vandenberg. Clardy, once defeated for U.S. representative, still has his eye on that spot.

John B. Martin Jr., of Grand Rapids, current auditor general still has the inside track for the senatorial G.O.P. nomination. Kelly (Bill) in the background, well camouflaged, Arthur Vandenberg Jr. is being boosted by one or two groups—but both have yet to declare themselves and get campaigns under way.

The new federal tax bill is going to cost Michigan taxpayers some \$276,830,000 more in taxes. Individual income taxes will account for an additional \$128,870,000 under the new measure, and corporations must raise an additional \$92,117,000 more than they are contributing now. Miscellaneous taxes, \$55,993,000.

Michigan stands among the top contributors to Uncle Whiskers tax kitty, along with New York, Pennsylvania, Illinois and California. Reason: concentrated industry and agriculture.

More price hikes are feared in the automobile industry, nullifying any advantages gained from easing of credit terms. Sales also have increased and dealers are again wiping their usually doleful eyes.

Believe it or not, there seems to be a trend in Michigan toward greater governmental economy. In 1950, 32 counties spent less than in 1949. In 1949, only 19 counties showed a drop in expenditures. (Continued on page eight)

Grid Squad Wins Game from Saline

Will Meet Dundee Friday Evening on Local Gridiron

The Chelsea Bulldogs handed the Saline Hornets a 12-0 defeat in Chelsea's third victory of the season last Friday night on the Hornets' home field. In the first quarter the ball was handed back and forth between the two teams, neither being able to move for more than one first down in a series.

In the second quarter the Bulldogs returned a punt to the 45-yard line. Two plays later, with only three minutes to play in the second quarter, Alfred Knickerbocker went through center, broke loose, and carried the ball 50 yards for pay dirt. Bureis missed the conversion and Chelsea led 6-0.

Chelsea then kicked off and Saline returned the ball to the 35-yard line. On the first play Gonsler threw a long pass which Chelsea's Captain Don McClellan intercepted on the 45 and returned it to the 27. Chelsea rolled for a first down on the 17 and another on the 6, where it was first down and goal to go. Two plays later, with second down and two yards to go, McClellan smashed through center for a TD. Bureis again missed the try for the extra point and the Bulldogs led 12-0 at the half.

In the third quarter Saline put on a long drive from their own 25 to Chelsea's 32 where they were halted by the on-charging line of the Bulldogs. Gonsler and Graft sparked the drive and went for four first downs before the drive was halted.

That was the only threat until late in the fourth period when Richard Bureis intercepted a pass on the Saline 25 and ran to the 9. But the drive was stopped by Saline's tough line and they took over on the 5. On the first play linebacker George Winchester intercepted a pass on the 5 where again it was first and goal to go. But the clock ran out and the final score read Chelsea 12, Saline 0.

For Chelsea, McClellan and Knickerbocker were outstanding on offense while McClellan, Len Hoppe and Moody were outstanding on defense. For Saline, Gonsler and Graft starred on both offensive and defensive.

The next game will be with Dundee on Friday, Oct. 5, at 7:30 at Chelsea Athletic Field. This contest between two fine ball clubs should provide plenty of excitement.

Reserves Defeated

The Milan Reds gave the Chelsea Bulldogs their second setback of the season, 7-6. Chelsea's Bulldogs scored midway in the second quarter following a successful passing attack. Milan scored in the following period on a plunge over center. The extra point was good.

World War Not Probable Slosson Says in Lecture Here

Will there be a third world war?

Probably not, according to Dr. Preston W. Slosson, who addressed an audience of nearly 80 people at the library last Thursday. If it comes, he opined, it must come from behind the Iron Curtain because no democratic nation could prepare for a blitz war even if it tried to make a surprise declaration of war would be like the man who tried to blow medicine down the throat of a horse—only to have the horse blow first," he declared. The democratic process gives due notification to the enemy.

"Furthermore," he stated, "no nation ever launches a war it can not even hope to win." He went on to point out that while Russia and China have the manpower, the western world has the equipment, the social organization, the morale, and the industrial capacity to win.

He said also that the western world can work and hope for a series of liberal revolutions among the Russian-dominated states, but warned that it would be most unwise to build policies upon such hopes. He also pointed out the

strong significance of the peace negotiations in Korea, while the Reds have not availed themselves of the opportunity to secure a real armistice, they have also missed several good opportunities to bring the negotiations to a complete halt. Even that little means something. The western world faces a long period of strain, which will exist until Russia ceases to be a menace.

Also touched upon were the coming British elections, the situation in Iran, the strange contradiction of Tito's anti-Russian attitude, the Spanish alliance, the admission of Greece and Turkey to the Atlantic pact, and other items.

"When asked why we send our sons to die in distant lands, the answer is plain: we don't want them to die anywhere. But if they must die, they might better die protecting a far distant frontier than on as close as our own coastline."

Balmer has owned his antique car for about two years and put approximately four months of spare time work into its restoration. He bought it at Coldwater junk yard.

The car created much interest at the Hillsdale fair because it was at Jonesville, in Hillsdale county, that the old Deal cars were manufactured.

Balmer is active in the Detroit branch of the Veteran Motor Car club of America which has its headquarters in Los Angeles, Calif., as the Horseless Carriage club.

Largely through his efforts, a number of antique cars will be brought here by club members in Michigan and Ohio for Saturday's Community Fair parade. The Balmers sent out 70 invitations to club members to appear in the parade and are hopeful that half that number will find it possible to come.

Gas Company Improvement Plan Complete

Completion of a two-year program to improve natural gas service to Chelsea was announced today by Charles R. Henderson, district general manager for Michigan Consolidated Gas Company.

The village is now being served by a new eight-inch line from Dexter which replaces a four-inch line. The new line and new gas regulators at the distribution station on Railroad street were put into use Sept. 29, Mr. Henderson said.

The new pipe line will enable Michigan Consolidated to more adequately serve the village with a uniform supply of gas for many years. House regulators were also installed as part of the local \$146,000 improvement plan.

The increased use of gas in the village, where 82 per cent of the homes are heated by gas and 90 per cent use it for cooking, water heating or refrigeration, made the improvements necessary, Mr. Henderson said.

M. W. McClure, local office manager, said that there are now 783 customers in Chelsea. They consumed more than 115 million cubic feet of gas in the past 12 months.

Mr. McClure, recalled that Chelsea was first served by manufactured gas in 1912. In 1939 natural gas was introduced by Michigan Consolidated, a year after it had acquired the Washtenaw Gas Company.

Atomic Survival To Be Explained in Public Film

Donald Alber, Civilian Defense director here, has arranged to show the picture "Survival Under Atomic Attack" to the general public next Tuesday evening, Oct. 8, at 7:30 p.m. The picture will be shown at the fire hall in the Municipal building. Everyone in the community is urged to see this picture, Alber said.

Monday night there will be a special showing of the picture at the firm's meeting and Tuesday at 8 p.m. Alber will show the picture at a meeting of the Chelsea Child Study club at the home of Mrs. Wally Grossman.

Civilian Defense Director Alber said he is planning the distribution of posters telling what to do in case of atomic attack, giving the air raid warning signal and other pertinent information. He said Boy Scouts will deliver the posters and he suggests posting them in easily accessible spots where they can be studied frequently by all members of the family.

Alber said the fire department, auxiliary police and warden service has been organized and workers will take their oaths of office at a special meeting next week.

"EASY DOES IT"

COPPER-BOTTOMED utensils can be easily cleaned if you sprinkle the bottoms with salt, then rub with lemon juice or vinegar. A half-lemon used for this makes easy work of the rubbing. Rinse with clear water.

Carry a small, stiff-bristled brush as you go about your housework, and you'll find it handy for brushing off pieces of lint on the upholstery, fluffy rugs or bedding.

When storing your pressure saucepan in the cupboard, invert the lid loosely in the pan. Never close the pressure pan with the lid as musty odors can easily develop.

Glasses which have had ice beverages in them should be first rinsed in cool water which is then gradually warmed for washing so the glasses do not break.

Only soap with water should be used to wash rubber plates like pads, storage racks, sink drainers or drainboard pads. Let them dry thoroughly and let some sunlight through to them so they will not mildew.

RECIPE OF THE WEEK
Liver Sandwich Spread
1 chopped onion
1 tablespoon butter
2 hard-cooked eggs
1/2 pound steamed pork liver
1/4 cup cream
Salt and pepper
Steam liver for 25 minutes in tightly covered pan. Cool and put liver through meat grinder. Mince eggs. Brown onion in melted butter. Mix all ingredients together, seasoning to taste with salt and pepper. Keep spread refrigerated until ready to use, then spread on white or whole wheat bread.

For musty mattresses, use a solution of water and disinfectant and brush on the mattress, standing up. Let one side dry before doing the other side. Dry in the sunlight.

To prevent dish clothes from acquiring an odor, wash and rinse in clear water after each use, and hang to dry. If you are looking for a remedy for the dish cloth problem, place in a bleaching solution with water and let stand for an hour. Wash in suds, then boil in soapy water for 10 minutes. Rinse and dry in the sun.

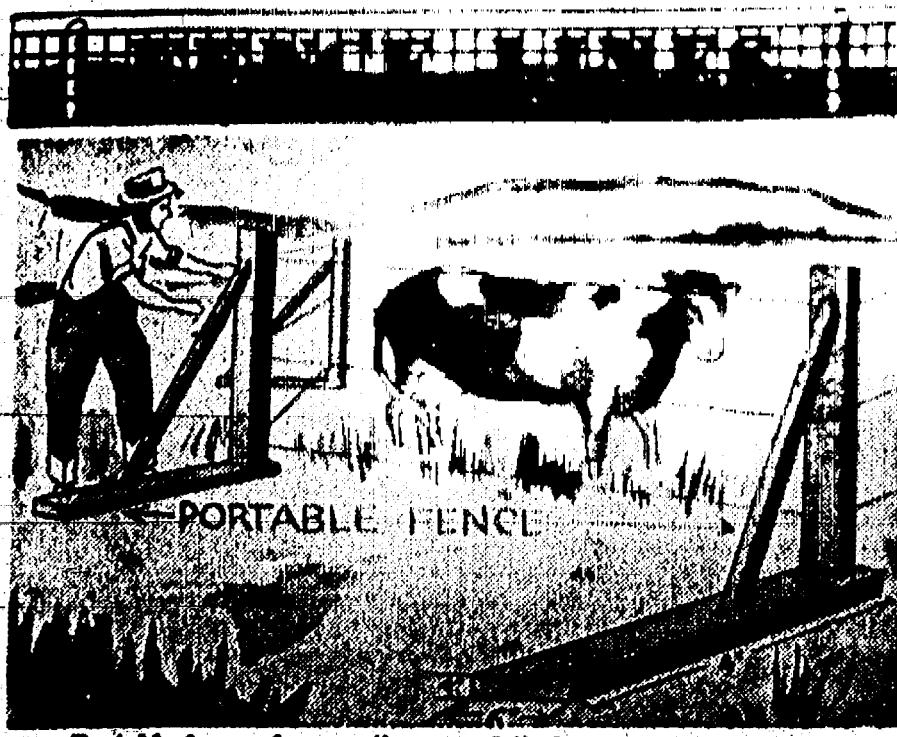
34 Years Ago ...
