## Village Slate Unopposed for Monday Vote

### All Candidates Are Independents But Listed as Republicans, Democrats

There is only one slate of candidates for the annual Chelsea village election Monday, March 13. All candidates are members of the independent party and all support the independent party platform. Because of recent changes at the state level in election laws, name of the independent party will not appear on the ballot. It is now necessary for all candidates to be listed as Republicans, Democrats or members of the independent party and the independent party ineligible to appear on the ballot. This change makes the traditional parties, the people's party and the independent party, ineligible to appear on the ballot. Members of the village council discussed the possibility of changing village laws to specifically allow local parties on the ballot, but no action on the proposal could be taken before this election.

In Manville, some of the independent candidates are running as Republicans while others have been to be listed as Democrats. Six of the nine candidates are independents. The new members of the slate are three trustee candidates.

Donald Baldwin, listed as a Republican, is the incumbent candidate for village president. He was elected to the post last year. George Winnans is the incumbent candidate for village clerk. He has been clerk since 1959 and is also running in this election as a Republican.

Wallace Wood, who is running as a Democrat, was elected to his post as village treasurer in 1959. The incumbent candidate for the office, Thomas Smith, was also elected in 1959. He is running this year on the ballot as a Republican.

Village president, clerk, treasurer and assessor are elected for two-year terms.

The three candidates for trustee are not incumbents. All are running as Republicans.

Gene T. Miller, 30, 160 E. Summit, is a dentist. He is a Kiwanian and a member of the Chelsea

Community Chest and a former co-chairman for that organization, and vice-president of the Chamber of Commerce. He graduated from Western Michigan University and the University of Michigan dental school. He served in the Air Force for two years, earning the rank of Captain. Miller is married and he and his wife, Mary Jo, have two children. George F. Heydlauff, 33, 151 Orchard St., is employed at Fright Products. He graduated from Chelsea High and from Western Michigan University. Heydlauff is president of the Zion Lutheran Church Council. He is a member of Kewanee, the Chamber of Commerce, the recreation commission and Community Chest. He is a past president of the Community Chest. Heydlauff and his wife, Wanda, have three boys.

Athel E. (Mac) Fulks, 45, 405 Madison, is a foreman in the University of Michigan plant department. He is a member of the Masonic Lodge and is on the official board of First Methodist church. He served with the U. S. Air Force from 1940-46 and again from 1951-52. He was awarded the Air Medal. Fulks and his wife, Janice, have one daughter, Kathy, 16. The trustees will be elected for two-year terms.

Jean Eaton and John Thomson are incumbent candidates for two three-year positions on the McKune Memorial Library Board. Both Thomson and Mrs. Eaton are listed on the ballot as Democrats.

A party platform, issued this week by the independent party and supported by all candidates in the election, contains five major points.

The platform states that the independent administration will investigate the feasibility of employing a village administrator to handle steadily increasing administrative demands.

The platform offers a policy of opposition to the proposed Mill Creek Impoundment and also promises efforts toward adoption of

## Council Briefs

Invocation by the Rev. Craig. Discussion was held regarding a request to construct an automatic car wash in the restricted business district. A formal request and plot plan must be presented to the council for consideration at a future meeting.

Discussion held with Joe Merkel, Sr., regarding the possible renovation of the Sylvan Hotel to a motel-rooming house, which would require the reconstruction of the sidewalk to provide access for customer parking in the area now occupied by the bowling lanes. He was advised that the sidewalk contract has been let and that the village engineer will contact him.

Discussion held with Claude Arnett regarding many dogs running loose in the village. He was advised that the problem has been discussed and that the police department has been instructed to do whatever possible to minimize the problem. Any dogs running at large will, if at all possible, be picked up and held until either claimed by the owner or turned over to the Washtenaw county dog warden. It is suggested that any village resident who is concerned about this problem should call the police department and inform them of the individual dog owner's name in specific cases.

The Chelsea Village Planning Commission recommended that the village enter into an agreement with Parkins, Rogers & Associates as planning consultants for the Village of Chelsea for one year, effective March 15.

A public hearing will be held April 4 to establish zoning regulations for the industrial districts of the village. A hearing will also be held at the same time to amend Section 309 of the village zoning ordinance. A third hearing on the same date will be held regarding construction of curb and gutter in the village.

The council approved President Baldwin's appointment of Patrolman Earl Willis as acting police chief, effective March 16.

Motion to appoint Dahue Riker and Paul Niehaus to act on the village board of review with Thomas Smith, village assessor, March 13 and 14.

A discussion was held regarding village garbage and rubbish collection.

Carl Mayer Dies Suddenly Wednesday

Carl J. Mayer, who was Chelsea postmaster for nearly 16 years before his retirement in September, 1965, died suddenly late yesterday afternoon after an apparent heart attack. He was 87.

At the time he was stricken, Mayer was returning to Chelsea from a fishing trip at North Lake. A companion brought the car in which Mayer was driving to a stop.

He was rushed to Chelsea Medical Clinic, where he was pronounced dead on arrival.

Mayer had been a Chelsea resident all his life. He was born here April 20, 1889, the son of Joseph and Caroline Wacker Mayer. He had been connected with the banking business in Chelsea since February, 1917, before his graduation from Chelsea High School.

Mayer was cashier for Kemp Commercial & Savings Bank before its merger with Chelsea State Bank. He was appointed as assistant cashier for Chelsea State Bank to accept the appointment as post master, effective Jan. 1, 1950.

He had attended classes at the American Institute of Banking in Ann Arbor, and received a certificate from the Institute in 1938.

He was a veteran of World War I.

He married Oleta H. Seitz in Chelsea Sept. 4, 1937. She preceded him in death June 2, 1965. Both Mayer and his wife had been members of St. Paul United Church of Christ for many years. Mrs. Mayer was organist at St. Paul's for 30 years.

He was also a member of the Masonic Lodge, Olive Lodge No. 156 F&AM and Olive Chapter No. 140 RAM, and had held offices in both organizations.

A member of the American Legion, Herbert J. McKune Post 31, he had served in all offices of the local post, including post commander. He was also a member of "40 at 8" the American Legion social organization.

He was a member of Chelsea Rod and Gun Club.

Mayer lived at 358 Washington St.

He is survived by two daughters, Mrs. Charles (Lynda) Catell of Chelsea and Carol at home; a son, George of Davison; two grandchildren, and two sisters, Mrs. Howard (Anna) Farley of Chassell and Mrs. Elmer (Ella) Lehman of Chelsea. Five brothers predeceased him in death.

Funeral arrangements are being handled by Staff Funeral Home and will be completed later today.

## State Representative

Where Michigan Revenue comes from follows, assuming the Governor Romney tax package or a close version of it's approved by the legislature (which will only satisfy our need for one year let's not attempt to fool anyone) Sales and Use tax \$332.2 million or 27 percent.

Business Activities Tax \$142.5 million or 12 percent.

Corporation Franchise fee \$103 million or 8 percent.

Revenue (liquor and other state enterprises) \$100.8 million or 8 percent.

Other taxes (Inheritance, Sev- erance etc.) \$254.1 million or 21 percent.

Fiscal Reform Package (including 2 1/2 percent Income Tax) \$255 million or 21 percent.

Where it goes: Education \$605.6 million or 52 percent.

Mental Health \$147.6 million or 13 percent.

Social Services (Health, Welfare etc.) \$159.4 million or 14 percent.

Natural Resources \$35.1 million or 3 percent.

All other general government (salaries, capital outlay etc.) \$178.3 or 15 percent.

## Plan Commission Studies Action on Rezoning Requests

The Chelsea Village Planning Commission spent the majority of their regular meeting Thursday, March 2, in discussing a contract with their professional planning consultant, Parkins, Rogers & Associates.

The commission also formally passed a recommendation to the village council that the consultant be hired.

Meeting dates were also discussed, with a tentative schedule of the first Thursday of the month for regular commission meetings and the third Thursday for "working sessions" with the planning consultant.

On Feb. 23 the commission held two public hearings to consider petitions for zoning changes. Both petitioning parties had been notified earlier that it may be some time before the commission is able to recommend action, pending advice of the newly-hired planning consultant.

The first hearing considered the petition of Edwin Oram, Gerald Oram and Mischa Sachs for rezoning of the former Lynn Kern farm from Agricultural to R-3 Multi-Family.

It is understood that the rezoning would allow Oram to proceed with plans for a 50-unit mobile home park. In order to develop this facility, Oram would also need to procure a special use permit from the village.

No one in the audience spoke in opposition to the rezoning request.

The commission will refer the rezoning request to the planning consultant for study and advice before a recommendation is made to the village council.

The second hearing involved a petition of the A. D. Mayer Agency, represented by Robert Pawlow, to rezone the property located at 214 South St. from R-3 Multi-Family to General Business.

Four persons in the audience expressed reservations on opposition to the proposed change. A letter to this effect was also received by the commission. The immediate next-door neighbor present at the meeting was not in opposition.

This rezoning request will also be referred to the planning consultant before a recommendation is given to the village council.

During the special planning commission session following the hearings, the commission publicly expressed appreciation to Fred Barkley of the Washtenaw County Planning Commission for his help and guidance of our commission since its inception."



This is the most critical moment in the history of gun legislation. Those were the words of Lansing attorney Harold Glassen, vice-president of the National Rifle Association.

Gassen's cause for alarm is a vicious anti-gun bill just introduced by President Lyndon Johnson through Senator Thomas Dodd of Connecticut. It replaces Dodd's infamous bill S. 1.

In a bit of fancy maneuvering, the contents of S. 1 were pulled out of the bill. In place of Dodd's bill the new LBJ Gun Bill has been substituted—and it is a Jolt! In the House of Representatives an identical bill has been introduced as H.R. 5384.

The bill termed "far worse than anything Dodd ever dreamed of" contains a preamble which claims that guns (not people) are the cause of crime, juvenile delinquency, etc. Among other things the LBJ Gun Bill would:

- Prohibit the purchase of any type of firearms by mail.
- Prohibit the purchase of any pistol except in the state of residence.

- Allow "over the counter" purchase of rifles and shotguns. However, the Secretary of the Treasury would be given dictatorial powers to regulate gun sales or ownership as he sees fit. Since the Treasury Secretary serves at the pleasure of the President of the United States it would give President Johnson full control of every type of firearm. In so doing it would override the Constitution of the United States.

- The new bill would also repeal the entire Federal Firearms Act (Title 18) which now offers reasonable protection. This



**Extra Measles Clinic Scheduled Next Saturday**

An extra free measles clinic has been scheduled by the Washtenaw County Health Department and the county medical society for Saturday morning, March 11, at 11:30 a.m.

The extra clinic will be held in the Ann Arbor City Health Department Office in the City Hall, Fifth and Huron Sts., Ann Arbor.

This is the last free measles clinic planned. None are scheduled for next year.

Dr. Otto K. Engelke, director of the county health department, said in announcing the clinic that consideration of the effect of unfavorable weather on attendance at the previous clinics had prompted scheduling of the extra session.

In the series of earlier clinics, which ended with the March 4 Ann Arbor High school clinic, a total of 2,502 children were vaccinated.

The measles clinics are designed to reach children between the ages of one and 13 who have not had the red seven-day measles or the vaccine.

By law, children entering school for the first time in the fall of 1967 will have to present evidence of having had measles or the vaccine.

Area Peace Corps Placement Test Slated March 18

Area residents interested in putting their skills to use in developing nations around the world are invited to take the Peace Corps Placement test at 1:30 p.m.

on Saturday, March 18, at Civil Service Room, U.S. Post Office, Downtown Station, 220 N. Main St., Ann Arbor.

The Peace Corps uses the Placement Test to determine how an applicant can best be utilized overseas. The test measures general aptitude and the ability to learn a language, job education or achievement. If test scores indicate limited language-learning ability, for example, the Peace Corps tries to place the applicant in an English-speaking country.

The Placement test requires no preparation and is non-competitive—an applicant can neither pass nor fail.

The application form for the Placement Test is the most important factor in the selection of volunteers. Persons interested in serving in the Peace Corps must fill out an application. If they have not already done so, and present it to the tester before taking the test. Applications may be obtained from local post offices or from the Peace Corps, Washington, D.C., 20252.

The Placement Test takes about an hour and a half.

**Federal Funds Not Available for Snow Removal**

Local governments administered the national disaster act, administered through civil defense are not available to the many communities of the state which have asked for aid in meeting the skyrocketing cost of snow removal following the record storm which began Jan. 26. Col. Frederick E. Davies, State Police director and state civil defense director, said.

Federal funds are available when a major disaster is declared and then only when the state as a whole has spent in excess of \$3,500,000 beyond and above the normal expenditures for disaster relief work during the 12 months prior to the date of the disaster.

The difficulty in this instance, however, is that a snowstorm severe as it may be and expensive as its cost may be does not classify as a disaster.

This is disappointing news to those who have applied for relief in paying the cost of clearing up the snow but federal help is not in sight, he said.




## IN THE OPEN


We stood on the north shore of Lake Michigan one sharp morning and watched a skyfull of mallard, southbound, leaving the prairies ahead of a cold front. The hens go first and these were mostly greenheads. In Saskatchewan we had seen flocks of hundreds in the grain fields and on the pot holes, and there wouldn't be a hen mallard in a hundred. This was in the early fifties and Canadian biologists said that probably there never again would be a flight as big.

They're gone, the procession of flocks that poured through the flyways, spring and fall. They're gone, the dense rafts, covering square miles of water. This is hard to believe, for anyone who doesn't bear in mind the ways of wildfowl. For example, Harold Titus, of Field and Stream magazine, got all excited when he viewed close to 200,000 redhead, wintering in Texas waters of the Gulf of Mexico. Then a pilot who flew transects for the Fish and Wildlife Service reminded Titus that he had seen almost all of the redhead left in the world.

Titus later toured the pothole regions of the Dakotas and Canada, making hand counts, collecting data from professionals on the spot. He made calculations from maps and came to a dismal conclusion.

There is no possibility that wildfowl can ever be restored to the abundance they reached before the drainage mania swept the continent. Large-scale drainage got under way during World War I. It kept mounting in scope and intensity; on both sides of the border until a point of no return was reached. Ducks Unlimited, supported by American sportsmen, is doing a magnificent job up in the Canadian northwest, establishing and maintaining nesting areas.

In the United States, federal projects, financed with hunting fees, are preventing final obliteration of wildfowl wetlands. Michigan is one of the more fortunate states, with numerous wildfowl refuges, including the big Fish and Wildlife refuge on the Seney marshes and the state-federal development south of Saginaw in the Shiawassee Valley.
