3 Candidates Seek Posts on School Board

Voters Asked To Choose 2 Board Members, 1 Mill for Vo-Tech Facility

The annual school board election will be held Monday, June 8, in the large group instruction room at Beach school. Polls will be open between 7 a.m. and 8 p.m. for school district electors to select two of the following three candidates for four-year positions on the school board: Herman L. Koenn, Harold C. Powers, or Mrs. Carolyn Smith.

In addition to selecting two school board members, electors will be voting on a one-mill proposal to establish and operate a county-wide vocational-technical school facility.

Last week, each candidate was supplied with a form requesting pertinent biographical information and his position on three questions which The Standard felt were important to the community at this time.

The following is their response to this questionnaire.

Mrs. Alfred C. (Carolyn) Smith of 8529 Hanked Rd., is 36, a homemaker, wife, and the mother of six children.

She is a former nurse, having graduated from the Mercy School of Nursing; is a past officer and an organizer of St. Mary's School Association; is a teacher in St. Mary's religious training program at both elementary and high school level; and is an officer in Beta Sigma Phi, a nationally affiliated sorority.

Her responses to our questions were as follows:

Question No. 1: Suppose there were to be a student protest or uprising at Chelsea High sometime during your tenure in office, how would you advocate handling it?

Answer: "In the event of a student uprising or protest, I feel the causes and people responsible must be determined immediately and measures taken to see that the school system, which cannot function with disorder, can get back to its business of educating our children."

Question No. 2: What are your feelings about the "White Panthers" influence upon Chelsea area students?

Answer: "What I have heard about the 'White Panthers' frightens me. I think children should be taught at an early age that life is not all sweetness; that society does have many ills. However, you cannot improve a bad situation by indulging in violent acts. It is difficult now to observe the inequalities and unfairnesses going on around us today without becoming impatient to correct them immediately. I think it is necessary to face the fact that they may not even be corrected in our lifetime. But, to say, in essence, 'if you (our generation) don't take care of it, we (the White Panthers) will do it our own way,' is very immature and senseless. Often times, we must sustain ourselves by constantly working at a problem even though we only make a small dent in it. This is the philosophy my husband and I try to impart to our children and can only hope that it is the right one. In a couple of years, we will know. I also hope that the young people of Chelsea have learned their lesson well and will pass the test and not be influenced by the White Panthers and be their followers."

Pamela Czarnecki Expulsion Upheld At Board Hearing



The decision to exclude Miss Czarnecki culminated the 6½-hour hearing before the board and officially closed the matter.





Action on Principal's Request Deferred Until Next Monday

Business at the regular meeting Monday night of the Chelsea Board of Education was anything but routine. Three separate matters were presented to the Board and the action, or lack of action on each, seems to have widespread ramifications for the residents of the Chelsea area.

Early in the meeting, board member Herman L. Koenn turned over to his fellow board members a sealed envelope given to him earlier in the day by a group of "concerned citizens." When opened, it revealed a series of petitions containing 142 signatures requesting the "immediate reinstatement of Richard Bareis as head wrestling coach.

Following the board's examination of these petitions, Koenn presented a motion stating, "I move that Richard Bareis be reinstated as head wrestling coach with periodic evaluations of his performance to be held during the coming school year. I do so on the basis of testimony presented at the open hearing on his case last week and the lack of documentation of the charges."

Koenn emphasized that his motion was not the result of the petitions presented, but rather was made on the evidence offered

at the hearing itself. After some discussion, the board members were polled by President Irwin and the motion passed 4-3.

Somewhat later, Superintendent Cameron presented to the board three grievance petitions from the Chelsea Education Association regarding the recent dismissals of Bareis and Jon Schaffner and one in behalf of the CEA grieving, "not the dismissals but the evaluation procedure." After some discussion, action on these grievances was deferred for one week until a special session of the board to be held Monday, June 8.

Shortly before the meeting adjourned, Superintendent Cameron requested the board's permission to present to the board with a matter not on the agenda. He then proceeded to read a letter from Charles Lane, principal of Chelsea High, requesting that "effective June 30, 1970, I be released from my duties as principal of Chelsea High for personal reasons and be reassigned as a classroom teacher in the system." No further explanation was given for this request and, obviously taken by surprise, the board declined to act immediately upon it and tabled the matter until the special board meeting set for next Monday night.

Gen. Beach Blasts Forces of Violence

An estimated 1,500 persons turned out Saturday, May 30, to participate in or watch the traditional Memorial Day parade and observance at Oak Grove Cemetery.

Chelsea Police Chief George Meranuk's mobil car, with its lights flashing, led the parade of American Legion and VFW representatives, Boy, Girl, and Cub Scouts of the area, the Firing Squad, and the high school and junior high school bands accompanied by hundreds of village children on their bicycles.

At the cemetery, master of ceremonies Ray Lutovsky welcomed the residents of Chelsea and introduced the Rev. Fr. Francis Wahowiak who gave the invocation and benediction. A wreath was placed at the soldiers' monument by the Woman's Relief Corps and the school bands joined together in playing several selections.

Following this, Lutovsky introduced Gen. Dwight E. Beach, of the United States Army, a Chelsea native, who gave a short address, speaking of this as the 102nd annual Memorial Day celebration and reminding his audience that this traditional observance dates back to 1868 following "the most devastating war ever."

Gen. Beach likened America 1970 with America during Civil War days and said that, "Not since the Civil War has our country been so torn by dissension, rioting, and hostility."

He likened the position of President Nixon with that of President Lincoln and drew several vivid parallels between this country's

present attitudes and the problems that led to the explosion of our nation 105 years ago.

He vehemently condemned the forces in America that are now trying to "tear our nation to pieces" and asked his audience to reflect upon the soldiers who have gone to war for her, fought, and in some cases, died for her.

"Did they," he asked, "fight so that we might be overwhelmed with drugs and drug users?"

Did they fight so that the rioters and student protesters might bring this great land to its knees?

Did they fight so that 3,000 acres of land in America could be ruined every day by an industrial society bent upon its own destruction?

Did they fight to see pollution (Continued on page six)

Washington Report

The dialogue between the federal government and the public, particularly our youth, is far from being what it should be but it has improved in recent days.

I am very pleased that President Nixon met with the presidents of eight leading colleges and more recently with leaders of 15 black institutions.

This is one thing I had in mind when I wrote the President on May 6, "it is now time for us to lower our voices and open channels of communication between the institutions of government, the campus, the young people, and society as a whole. The dialogue is now weak, limited and excessively emotional."

Meanwhile, in keeping with my long-standing practice, I have met with hundreds of persons both in my Michigan district and in Washington. Many have been young, but others have been adults from many walks of life.

As an added factor I and several House colleagues have introduced legislation urging the President to establish a commission to study the causes of campus violence.

If we are to keep open and widen all these channels there must be a willingness by all to listen as well as speak. And there must be an understanding that the freedom to express our opinions does not and cannot carry with it a guarantee our views will be followed. Such a guarantee would not be possible since many groups with a range of viewpoints compete for an action that can go only one direction at a time.

There is no assurance that talking to each other with proper respect and consideration will solve our country's problems or even partially solve them. But it is quite certain that injustice cannot be significantly and permanently reduced without effective communication.

Mercury Future Uncertain
 No one knows when or if the current restrictions on fishing in Lake St. Clair, the St. Clair River, the Detroit River, Lake Erie and part of Lake Huron will be lifted.

When he announced the program under which fish in these waters can be caught but then must be thrown back, Gov. William G. Milliken said the restrictions would apply "indefinitely."

"I don't think it can accurately be said the mercury situation is getting better," he said. "It will inevitably get better, but when, nobody knows."

"I don't have any plans to modify it at the present time," he said.

The ban on eating applies to all fish caught in Lake St. Clair, the St. Clair River and the Detroit River. It applies to all wall-eyes, white bass and sheepshead caught in Lake Erie and on Lake Huron south of Port Sanilac.

Anyone wishing to fish in these waters must have a special, free permit, even if they are 16 and under and normally need no fishing license.

When the permit is given to the person, he also receives a warning as to the hazards involved in eating the fish due to the high levels of mercury in them.

There are 500 permit outlets in the southeast Michigan area.

Health officials say there is no way to clean or cook fish contaminated with mercury to make them safe to eat.

Persons who eat too much mercury contaminated food can suffer brain damage and this is why the extra cautious approach has been taken on the problem.

"We don't want to see dead bodies before we start moving to protect the public," explained one state official recently.

Milliken said he thinks it is "clear in the public mind" that mercury does pose a hazard to the public health and that the ban is therefore necessary.

4 Years Ago . . .
 Thursday, June 2, 1966—
 In honor of the 25th anniversary of his ordination, the Rev. Fr. Francis Maleszewski of St. Mary's parish received a "money tree" from the students of St. Mary's. The tree, containing coins and bills, was earned by the students for his building fund.

Chelsea police went into action during the past week and nabbed two 21-year-olds who have been arraigned on charges of larceny. The pair later pled guilty to stealing two tires and wheels from G. A. Motor Sales.

A full scale information campaign to promote passage of the 11.25 mill additional school tax is underway. Complete newspaper liaison, brochures, and a telephone campaign will be included in the program to finance six new elementary classrooms, 10 new high school classrooms, and seven additional classrooms for the coming year. The millage election is scheduled for June 13.

Weight Watching Diet Should Include Bread, Cereals

When most women decide to trim away a few extra pounds, they make the mistake of cutting entire groups of foods out of their diet.

"Two common diet eliminations are milk and dairy products and breads and cereals. But these foods have to be considered in relation to nutrients as well as calories contributed to any diet," according to Michigan State University Nutritionist Anita Dean.

"We depend on bread and cereals for much of the B vitamins and iron which are essential to health," she says. "Be sure such foods are enriched or made from whole grains, so you get the most nutrition for the calorie cost."

Mrs. Dean advises checking labels for the word "enriched" or the ingredient "enriched flour" on such items as muffin mixes, pancake flour, macaroni or frozen bread dough.

"Dieting includes counting nutrients as well as calories," Mrs. Dean says. "Minimum servings from the four basic food groups (milk, meat and eggs, cereals and breads, and fruits and vegetables) will provide all the nutrients you require and can contribute as few as 1,150 to 1,200 calories."





Fire Destroys 2 Cottages at Half Moon

"It's lucky no one was home!" was the comment of onlookers at the scene of an explosion early Monday morning at Little Half Moon Lake off Whitewood Rd., in Hamburg township, where one summer cottage was leveled and another was extensively damaged. Both dwellings were considered a total loss. There were no injuries.

Firemen said no one was in either cottage when the explosion occurred at 10:37 a.m. on Dr. Ann Arbor.

According to a neighbor of Hicks, there was a loud explosion and then the front of the cottage and the roof lifted up and the front blew out.

He said there was not much fire immediately following the explosion, but some flames from the burning house spread to an adjacent cottage which has an address of 10384 Half Moon Dr. That cottage is owned by Mrs. Alice Knapp of Detroit.

Forty firemen, representing the Pinckney, Hamburg, and Dexter fire departments were at the scene. They were able to prevent the blaze from spreading to nearby residences. An old station wagon parked near the Hicks cottage was also heavily damaged.

Although cause of the explosion is undetermined, Hicks said that there was a leak in his propane gas tank located at the front of the cottage.

He estimated that the value of his cottage was \$35,000 and while he could not give a dollar estimate of its contents, mentioned that there were many antiques in the cottage at the time of the fire.

The arson squad from the Livingston County Sheriff's Department was also at the scene and is investigating the explosion and the fires.

Dress Code Ruling Not Effective Here

Within the last week, information has appeared in both the Ann Arbor News and Detroit Free Press involving a decision by the Supreme Court that it is not legal for a board of education to dictate length of a student's hair.

In order to check the accuracy of this information, a call was made to Chief Justice Thomas Kavanagh of the Michigan Supreme Court. Since this was a federal rather than state ruling, Justice Kavanagh referred the matter to the United States Attorney General and the following answer was obtained:

"Late last year, in the case of Kahl vs. Breen, a high school boy was suspended from school when he refused to comply with the school regulation that his hair should be washed, combed, and cut so that it did not cover his collar line, extend over his ears, or fall below his eyebrows and that he must be clean shaven with no long sideburns."

"The case was taken to court where the school board ruling was upheld; however, on Dec. 3, 1969, an appellate court in the seventh circuit reversed the decision stating, 'the right wear one's hair at any length is a part of due process and is an inviolable right.' On June 1, 1970, the Supreme Court, with dissent, ruled that it would not review the case at this time and allowed the appellate ruling to stand."

It should be pointed out that the seventh circuit district, includes the states of Wisconsin, Illinois, and Indiana only. Michigan is in the sixth circuit along with Ohio, Kentucky, and Tennessee and as such, this ruling has no immediate application to our local boards of education. It does, however, pave the way for those persons dissenting from regulating school dress codes.

★ **Welfare Curb**

Paying the cost of supporting welfare recipients isn't going to improve by the looks of increasing numbers receiving benefits. Taxpayers will continue to finance the multi-billion dollar program to aid the poor.

In Michigan, it is estimated that there are more than three quarters of a million poor people in our rural and urban areas. Nationally, there are more than 30 million, and of these there are some 14 million rural people in this category. Being poor means, by most authorities, earning an income of less than \$3,400 annually.

A solution to ease welfare payments is jobs for the poor, but most poverty victims lack required skills to get them. One plan is to train people before they get out of school.

A revision of the school curriculum would begin with a program to orient school children in primary school to the reality of the work world. Later in secondary school opportunity to learn skilled work would be available. The plan could be an important stopgap to the booming welfare rolls in the younger age bracket.

But yet, machinery and other tools to teach useful skills to growing citizens is more expensive than reprints of Shakespearean texts. Vo-ed is the most expensive type of education, but can we afford to do less? Our aim is to make taxpayers, not future tax dependents.

In Michigan, last year alone the cost of welfare was \$537,650,000 to the state, \$288,100,000 federal, and \$17,800,800 to the counties.

Many predict that the welfare road is the direction that many underprivileged students will head without proper training. As it is, many tune out and drop out, because of not being able to relate to studies. There's no real guarantee that many won't do the same in Vo-ed programs, however, state officials do report, encouragingly, many successes of students after training.

An idea being adapted in some communities in Michigan is multi-district vocational centers to offset the high expense of a single community sponsoring its own program. Advantages include affording a more varied vocational curriculum for a greater choice of learning skills for working careers, for solid citizens for tomorrow.







A motion was made and approved to authorize and direct the clerk to issue checks in payment of bills as submitted.



What the June 8 Ballot on Vocational Education Means

Exactly what will the successful passage of the June 8 county-wide election on Vocational Education mean for the students and tax payers of Washtenaw county?

First, it will mean that some 2,000 students will have available to them courses which are meaningful in meeting their needs in preparation for the world of work.

The following courses are being proposed and will be made available to all students who need and can benefit from them: auto-body repair, automotive mechanics, building and grounds maintenance, business machine repair and service, carpentry and millwork, commercial foods preparation and service, cosmetology, data processing machines operation, drafting, electrical repair and maintenance, electronics, phone equipment mechanics, horticulture and floriculture, industrial machine repair maintenance, industrial machine shop operation, medical-office assisting, nursing aid, pre-nursing, printing, retail sales, secretarial and office machine operation, and welding.

These are occupational fields in which well paying jobs exist in Washtenaw county, in Michigan, and in most parts of the country. They are also occupations in which Washtenaw county high school students are interested, if the training is made available during high school periods. Other courses will be added as the needs are identified.

The programs will help the forty-seven percent of our young people whose educations end at the high school level to get and hold a worthwhile job.

While the bulk of the students will be drawn from the 11th and 12th grades, programs are being planned for some students who will not have reached the 11th grade. Every effort will be made to serve those students with social and learning difficulties, and those who seem likely to drop out of their regular school program, regardless of their grade level. In addition, opportunities will be made available to youth who have already dropped out of school.

Secondly, this program and the hundreds like it, being planned

across the country, will eventually save the taxpayer the expense of patch-up remedial programs, such as the Job Corps, which last year spent more than \$2 billion from our Washington pocket trying to make young people employable.

It will also, over the long haul, mean a much more efficient use of local tax money. Good vocational programs and facilities are tremendously expensive and must be utilized fully in order to be economically feasible. This county-wide pooling of student and financial resources will make it possible to utilize such resources fully. The locations of the main facility—the area vocational center—on the Washtenaw Community College campus, at US-23 and the Huron River, will make it possible to use the same building and equipment for both high school and post-high school students. This will ultimately represent a huge savings in site, buildings, and equipment.

In addition, part of the one mill being requested, will be used to support the operation of qualified vocational programs in existing high schools in the county. They, too, will be serving part of the area need for vocational education.

Thirdly, the availability of this broad range of vocational-technical programs, at both the high school and post-high school levels will benefit the business and industrial economy of the county. Business and industry must have trained young workers in order to survive and grow. The U. S. Congress considers the shortage of these trained workers a national crisis.

In summary, the benefits to be gained from the June 8 election on Vocational Education are: 1) the availability of a range of vocational courses sufficiently broad in scope to attract and serve the occupational needs for all Washtenaw county, junior and senior students who seek and can benefit from such training; 2) the displacement of a projected 2,000 students from Washtenaw county high school laboratories and classrooms to the vocational technical center by the mid 1970's thus in-

creasing the flexibility of Washtenaw county high school building and faculty utilization; 3) The availability of greatly increased numbers of skilled young workers, which has proved to be a positive stimulant to business and industry in other communities where such programs have been established; 4) the vocational millage allows a stable support for existing Washtenaw county vocational programs as well as for those offered at the area vocational center. (The vocational millage is a "charter millage" and thus continues for as long as the area vocational program is in operation.) 5) a reduced need for expensive vocational facilities in the future Washtenaw county high school, especially in those vocational areas which result in a high per student cost factor due to minimal enrollments; 6) economically efficient utilization of existing vocational facilities, supported by a county-wide tax and student base; and 7) a more efficient coordination of planning and programming between the high school districts and the community college can take place, enabling individual students to plan a four-year sequence of programs.

All registered voters may vote on the important vocational education propositions, Proposition No. 1 authorizes the establishment of the area vocational program for Washtenaw county and the one mill necessary to construct additional facilities and operate the program through the 1970's. Proposition No. 2 authorizes the use of part of the mill for repaying bonds necessary for construction of facilities. Proposition No. 2 means no additional taxes; all costs will come from the one mill.

Chelsea School Superintendent Charles Cameron states "he endorses the program fully and hopes for a favorable vote."

2. Section 6, Article II, of the Michigan Constitution of 1963 reads in part as follows:

"Whenever any question is required to be submitted by a political subdivision to the electors... for the issue of bonds, only electors in, and who have property assessed for any ad valorem taxes in any part of the district or territory to be affected by the result of such election or electors who are the lawful husbands or wives of such persons shall be entitled to vote thereon..."


Several recent United States Supreme Court decisions have indirectly raised questions as to the validity of the above constitutional provision. For this reason, all resident qualified school electors who are registered with the city or township clerk of the city or township in which they reside shall be allowed to vote on the proposition of borrowing and issuing bonds of said school district. The votes cast by those electors who have property assessed for ad valorem taxes within the district or are the lawful husbands or wives of such persons and the votes cast by registered electors who do not have property so assessed will be tabulated separately.

Any resident qualified school electors who are registered with the city or township clerk of the city or township in which they reside are eligible to vote at this election.




