Track Team Wins Over Tecumseh

Chelsea High school's track team got off to a running start by winning its first league dual meet of the year. An earlier meet scheduled for last Thursday against Dexter was postponed until May 15 because of inclement weather. However, the layoff certainly did not affect the squad as they swept the relay events and went on to best Tecumseh, 63 1/2 - 54 1/2.

Coch Bert Kruse was pleased with the team's performance but didn't think Tecumseh measured up to other competition they will face later in the season. Tecumseh had some fine individual athletes, but over-all is not as strong as Saline which is seen as Chelsea's stiffest opponent for the league title.

Chelsea won the 880-yd. relay in a time of 1:39.5 when the Tecumseh team was disqualified for exchanging the baton outside of the exchange zone. The winning team consisted of Marty Cashdollar, Craig Coltre, Dan Berke, and Lee Ferguson.

The 440-yd. relay was also won by the Bulldogs in a time of :48.9. This team was comprised of Lee Ferguson, Ishmael Picklesimer, Carl Gauss, and Tim Lancaster.

Completing the sweep of the relay, Chelsea took the mile relay event in 3:41.9. The team of Dan Hoover, Jeff Marshall, Dan Berke, and Dave Buxton turned in the winning performance.

Field specialists also tasted victory this week as junior Bill Tite placed first in the high jump with a leap of 5' 8" and Tim Lancaster won the pole vault event with a jump of 12'. Don Pierson finished second in the event with a jump of 11'.

In other field events, Randy Seitz and Ishmael Picklesimer finished second and third in the shot put with tosses of 47' 3" and 42' 4", respectively. Craig Coltre and Lee Ferguson finished second and third in the long jump with 18' 11" and 18' 1 1/2" efforts.

Chelsea did extremely well in the running events with senior Dave Buxton winning both the 440- and 880-yd. runs with times of :55 and 2:14. Lee Ferguson finished second in the 440 with a time of :55.3. The 100-yd. dash was won by Marty Cashdollar in :10.8 with Ishmael Picklesimer finishing third at :11.1. Cashdollar also placed third in the 220-yd. run with a time of :25.1. Chelsea's Jim McGinn took a third in the mile run with a time of 5:41.9. Howard Schenk placed second in the two-mile event with a time of 11:48.

Craig Coltre did yeoman duty in the hurdle events, winning the 180-yd. jumps with a time of :22.3, and finishing second in the 120-yd. high hurdles with a time of :18.2.



LIMA TOWNSHIP HISTORICAL SPOTS:

Denham Home Built in 1864 By Son of Pioneer Family

Editor's Note: This article is the second in our series of stories dealing with some of the older homes and pioneer families in the area. Much of the information has been unearthed in conjunction with Lima township's land-use study.

In the autumn of 1831 Richard and Ellen Smith, their seven-month-old son, and Ellen's two teen-age brothers set out for the New World from Yorkshire, England, a journey which was not to end until they had reached what was then the Territory of Michigan.

They bought some land from the government and settled down on property which stayed in the hands of relatives for well over a century. Their farm is now given the address of 9741 W. Liberty, Chelsea, and belongs to Harry and Virginia Denham.

The Smiths had six children, but only one of their descendants, great-grandson Neil Smith of Dexter, remains in the area.

The home in which the Denhams are now living was built by Ebenezer, Richard and Ellen's second son, about 1864. Previously, the family had lived in the home of Richard's brother, Thomas, an earlier settler. In 1841, only a decade after immigrating to Michigan, Richard Smith died, as did his wife six years later; the six children continuing to live at home until their marriages.

Of the six children, Ebenezer is perhaps the most famous as a founding resident of the area. The first of the clan to be born in Michigan, he married Isabella B. Mains in 1857. Seven years later he built the family home and continued to live in the area until his death in 1930 at age 97.

In addition to farming, Ebenezer was active in the community as a teacher, a township officer, a Baptist deacon, and a writer. In his later years he published a religious tract and at the age of 95 was working

on a book he called "The Rise of Religious Liberty." He served as township justice of the peace three times, as supervisor once and as township superintendent of schools for two terms.

In a newspaper interview at age 95 Ebenezer reported he had never used tobacco in any form, played cards, danced, or indulged in liquor "except to the extent of determining that I didn't like the stuff."

But alcohol, he admitted, was a familiar part of the farm scene. "I can remember when the whiskey bottle was just as important to farm work as the water jug," he told the reporter.

He also spoke of the popular practice of "raisings," when the people would get together and help their neighbors put up houses or barns. "Liquor always flowed freely at those affairs, and sometimes, when it was passed around before the raising started, half of the help was in no condition to raise anything but Cain," he was quoted as saying.

Ebenezer and Isabella Smith had two children, Arthur, who died in infancy, and Samuel, who married Carrie Egeler and was the father of Neil, now living in Dexter. The farm was sold to George Egeler, the brother of Carrie Egeler Smith, and remained in that part of the family until the early 1950's, when it was sold to Millard Dockery and in turn to the Denhams.

Since the Denhams took possession a decade ago the appearance of the old farmstead has changed somewhat. One of the big barns built by Ebenezer has been torn down, its beams and sidings used to add onto the main house. The Denhams have also added a living room and garage and have dug several farm ponds.

Special Millage Issues OK'd By School Board

In a special meeting Friday, April 7, the Board of Education passed three motions calling for increased millage appropriations. The new proposals will go to the voters in the special election to be held May 8.

The first proposal raised by G. Straub and supported by R. Schaefer was to request 10.98 extra mills for the next two years. The motion was passed unanimously.

The second motion was supported by Don Irwin and called for a one mill levy for the next three years to establish a building and site fund. The additional money will be used to buy new sites, construct facilities, and renovate existing facilities. The motion was carried by a 4 to 2 margin.

The third proposal concerning millage assessment was raised by Howard Haselschwardt and seconded by Irwin. It will request of the voters one mill for the next two years for capital outlay and was approved by a 5 to 1 vote.

Washington Report

One of the most frustrating things about the 1970's is the realization that we have the technical capability to solve almost all of our problems. If man can walk on the moon, the argument goes, then why can't he cure cancer, clean up the slums, stop water and air pollution, stop hunger, and provide quality medical care for all, stop birth defects, etc., etc., etc.

The answer is, of course, that man probably can solve each of these problems; but he can't solve them all at once. That is where the difficult questions of choice face our decision makers. Should we make an all-out effort to solve one major problem and let the others stagnate; should we divide our resources to give a little bit of attention to every problem, thus realizing that we will not solve any of them. If we divide our resources, which problems should receive the most attention?

These are the kinds of questions and the kinds of choices which the Administration and the Congress make each year when they write the budget and approve appropriations. These choices are not easy ones. They are not choices between effective programs and ineffective programs, but between good programs and better programs.

Let us take just one area—health—as an example. Assume for the purposes of this column that the United States this year had \$1 billion more that it could spend on health programs. Should it be


spent on research? If so, should it be spent on curing cancer, heart disease, sickle cell anemia, birth defects, kidney disease, or mental disease? Or perhaps, instead, it should be spent on health care delivery. If so, should it provide a medical and dental checkup for every child under six? Or should it be used to improve the care of millions of senior citizens who lack essential health services? Or should it be used to establish medical clinics in our slums and poor rural areas? Or perhaps, instead of research and care, the money should be spent on training new doctors, nurses, and allied health care personnel. Or maybe we should build new and up-to-date facilities.

But the choices don't stop there. Perhaps, after all, instead of spending that extra billion dollars on health, it should be spent on education, or pollution control.


The point, I think, is obvious. There are hundreds, perhaps thousands, of important programs which the government could, and perhaps should, undertake. But they cannot all be undertaken at once, with maximum funding and attention. Some will have to be diminished in scope from the optimum; others will have to be deferred altogether.

The President has submitted to the Congress a budget which will spend \$25.5 billion more than we take in in taxes. There are undoubtedly programs which should be cut back, others should be eliminated altogether. Even after these actions are taken, however, there is still not going to be enough money to undertake all the important and good programs which have been proposed.

It is essential that the Congress, as well as the President, set priorities. We simply can't accomplish everything at once. There is a limit to the amount that the government can spend. That is why I cannot support increases in every program which I believe is a good one. I simply must make choices and give my support to those programs which are the most important and which have the highest priority. Congress must make hard choices and that sometimes means personal favorites get left behind.

Restrictions Added

The legislature took a couple of steps forward in opening the political process when it enacted a presidential primary for Michigan, but it took a step or two backward, too.

While it gave Michigan voters a direct voice in how their state delegations will vote in Miami Beach and San Diego this year, it cut a bit of a crimp in the time honored petition process.

Incorporated into the new law setting up the primary was a provision barring the circulating of petitions within 100 feet of a polling place. The primary bill was an opportune time for the lawmakers to do it, since the primary itself received all the attention.

It was accepted procedure, until now, to circulate petitions at polling places, and the attorney general's office had drawn guidelines to make sure petition circulators didn't interfere with the voting.

The presidential primary on May 16 is early enough that the various groups working to put propositions on the November ballot this year may use the day to circulate petitions.

Polling places are especially valuable as petition circulation spots because the circulator is assured the signatures of registered voters and a steady supply of potential signers all day.

There was some suspicion in Lansing that one of the main reasons for the new restriction was the drive for a one house legislature conducted by State Rep. Joe Swallow, R-Alpena.

A blitz was planned by Swallow and his followers for May 16 to secure the needed names. Since his proposal would unseat at least 72 of the incumbent legislators, it hasn't drawn much favorable comment in the legislative chambers.

The new restriction is unfortunate on a much broader scale. If these days of increasing alienation between the citizen and his government, the petition route remains one last resort, the disgruntled voter can take when all else fails.

Unwillingness or inability has been apparent in recent years for the legislators to handle such controversial topics as abortion reform or property tax relief. With a \$107,000 a year salary on the line, many legislators have been reluctant to go out on a limb on such issues.

It seems terribly unfortunate that the lawmakers, after being unable to do it themselves, make it harder for the people to secure needed reforms.

Mistakes Begin

The age of computerized mailing lists has resulted in a rapid increase in instances of candidates receiving letters asking for contributions to their opponent's campaign or to another member of the opposition party.

The long series of mixups has begun again in Michigan. State Rep. Thomas Guastello, apparently was the first recipient of such a mailing this year. Guastello reports he received a letter from former Commerce Secretary Maurice Stans, chairman of the Finance Committee for the re-election of the President, and a membership card for the committee.

The letter asked for money to help President Nixon's try for a second term. Guastello, a lifelong Democrat, refused.

Animal Fatalities

A more intriguing, though perhaps less useful, bit of information to come along recently: the raccoon appears to be the worst jay-walker in the animal kingdom, at least in Ionia county.

That report comes from the State Highway Department by way of the Ionia County Road Commission, which is the only county in the state to keep such records.

The commission reported picking up 445 raccoons which were killed crossing 114 miles of state highways in 1971.

The second worst, or most unlucky, species was the squirrel, which had 163 of its species killed by motor vehicles.

Other species were found in the following order: turtles 140, opossums 137, skunks 82, deer 77, cats 67, dogs 66, woodchucks 55, muskrats 49, rabbits 45, foxes 22, mink 5, and one lonely badger.

The bird kingdom lost the following numbers: pheasants 16, owls 12, partridges 10, crows 8, hawks 7, and one quail. No record, though, on whether they were walking or flying when they were struck down.

Elector Unable To Make Personal Application, Procedure
SEC. 504. Any elector who is unable to make personal application for registration because of physical disability or absence from the Township, City or Village in which his legal residence is located, may be registered prior to the close of registration before any election or primary election by securing from the Clerk of the Township, City or Village in which is located his legal residence, duplicate registration cards and executing in duplicate the registration affidavit before a notary public or other officer legally authorized to administer oaths and returning such registration cards to the Clerk of the Township, City or Village before the close of office hours on the last day of registration prior to any election or primary election. The notary public or other officer administering the oath shall sign his name on the line for the signature of the registration officer and designate his title.

Unregistered Persons Not Entitled To Vote
SEC. 491. The inspectors of election at any election or primary election in this State, or in any District, County, Township, City or Village thereof, shall not receive the vote of any person whose name is not registered in the registration book of the Township, Ward or Precinct in which he offers to vote. (As provided under Act 116, P. A. 1954.)

Transfer of Registration, Application, Time
SEC. 506. Any registered elector may upon change of residence within the Township, City or Village cause his registration to be transferred to his new address by sending to the Clerk a signed request, stating his present address, the date he moved thereto, and the address from which he was last registered, or by applying in person for a transfer. The Clerk shall strike through the lost address, ward and precinct number and record the new address, ward and precinct number on the original and duplicate registration cards, and shall place the original registration card in proper precinct file. Such transfers shall not be made after the Fifth Friday preceding any election or primary election (unless such Fifth Friday shall fall on a legal holiday in which event registration shall be accepted during the next full working day.)

Transfer of Registration on Election Day
SEC. 507. Any registered elector who has removed from one election precinct of a Township, City or Village to another election precinct of the same Township, City or Village and who has not had such removal with the local Clerk shall execute a transfer of registration request, listing the new residence address thereon over his signature, with the election board in the precinct in which he is registered at the next ensuing primary or election. The inspector of election in charge of the registration records shall compare the signature thereon with the signature upon the applicant's registration record and, if the signatures correspond, then the inspector shall certify such fact by affixing his initials upon said request. The applicant for transfer, after having signed an application to vote as provided in Section 523 of this act, shall then be permitted to vote in such precinct for that primary or election only. The application for transfer shall be filed with the Township, City or Village Clerk who shall then transfer such voter's registration in accordance with the application. When the name of any street in a Township, City or Village has been changed, it shall be the duty of the Township, City or Village Clerk to make the change to show the proper name of street in the registration records, and it shall not be necessary for the elector to change his registration with respect thereto in order to be eligible to vote.





When complete, divisional organization will number about 30 persons. Prospect contacts are slated to begin this month.


Holmes, a native of Chelsea, is a vice-president and director of

THE LANSING REPORT FROM Senator GIL BURSLEY

If I were limited to stressing just one basic point, in my efforts to make the role of the state legislator more clearly understood by the citizens he serves, it would be this:

The difficulties that confront state government today are so complex in their nature and so awesome in their magnitude that they are compounded rather than diminished by demands for simplistic solutions.

In other words, there are no easy answers for tough problems. And those who insist upon easy answers do a double disservice to themselves and to the government that represents them:

- 1) They hinder the work of the elected and appointed officials who are responding to the challenges of our era in a responsible manner.
- 2) They fail to see the political opportunities which loudly promote, for their own personal advantage, simple and appealing answers that have no chance of working.

This is true in every major area of present-day public concern, including our new awareness of the fragility of our environmental heritage, our alarm at the scope and intensity of the drug-abuse problem, and our rebellion against ever-rising property taxes.

Congress May Enact New Farm Legislation

Congress is at it again. Many times our United States Congress passes legislation and then reverses it or passes a new bill on the same issue before the first piece of legislation has time to be evaluated for its effectiveness. Such is the case with the Agricultural Act of 1970.

A major revision of the Agricultural Act of 1970, which would drastically change the current government farm program for wheat and feed grains, may be considered by the Senate Agricultural Committee as Congress reconvenes.

The proposed legislation (H. R. 1183) sometimes called the "Strategic Grain Reserve Bill" was passed by the House of Representatives on Dec. 8, 1971 by the close vote of 182 to 170.

This being a political year, the bumper 1971 corn and wheat crops and low grain prices provided some of the impetus for the proposed legislation. If passed, which is far from certain, the measure would change the direction of recent government policy which has been somewhat aimed at making farm production and prices more market oriented.

This bill would create a government strategic reserve of 300 million bushels of wheat and 25 million tons of feed grains. These commodities could be released for sale by the government at a price of 120 percent of the average price farmers received in the U.S. during the preceding five marketing years for the commodity involved. The loan level for 1971 and 1972 crops of wheat and feed grains would be increased by 25 percent.

The proposed legislation would almost totally nullify the 1970 farm act as far as wheat and feed grains are concerned.

The American Farm Bureau Federation, with a membership of more than two million farm families, would like to have the 1970 Act run through the 1973 crop year to determine whether its effect is beneficial to our economy.

Before we leap to something else, let's give the 1970 Act a chance.

Thanks to plenty of food and nutrition know-how, protein deficiency in America is relatively rare. Where it exists, however, there are some of the symptoms: premature aging, poor muscle tone and posture, anemia and slow recovery from illness or surgery.

District Judge Elden Will Seek New Circuit Judgeship

The Honorable S. J. Elden, Judge of the 15th District Court, Ann Arbor, has announced that he is a candidate for Judge of the 22nd Judicial Circuit, comprised of the County of Washtenaw. Two judges will be elected in this circuit this November.

Judge Elden explained the reason for his decision to seek promotion to the higher court by noting that "The legislature has recognized the ever increasing caseload in the county by allocating an additional judge. Many people have urged me to bring my record of expertise, gained through extensive experience, to bear on the greater responsibilities and breadth of issues at the circuit court level."

Judge Elden is a 35-year veteran of Boy Scouting and is himself an Eagle Scout. From Mrs. Ethel A. Moffett, Maryland: Around this time of year, I remember how my grandmother was taught to color Easter eggs. There was either a scarcity of bright color dyes or they were too expensive a luxury for the poor to buy.

About a month before Easter, my grandmother would gather and preserve the skins from the onion. When she had a pound of onion skins, not onions, she would put them on the stove to boil. After boiling they would simmer as one by one the hard-boiled eggs were placed in the small pot and covered over with the juice and the skins themselves. If the onion skins remained on the egg for any time, a beautiful lighter shade than the surrounding color would appear. The color depended on the length of time they remained in the onion water. Colors vary from deep brown to delicate tawny shades. To this day I follow the old way, and the results are beautiful.



The notary public or other officer administering the oath shall sign his name on the line for the signature of the registration officer and designate his title.

Unregistered Persons Not Entitled To Vote
 SEC. 491. The inspectors of election at any election or primary election in this State, or in any District, County, Township, City or Village thereof, shall not receive the vote of any person whose name is not registered in the registration book of the Township, Ward or Precinct in which he offers to vote.

Transfer of Registration, Application, Time
 SEC. 506. Any registered elector may upon change of residence within the Township, City or Village cause his registration to be transferred to his new address by sending to the Clerk a signed request, stating his present address, the date he moved thereto, and the address from which he was last registered, or by applying in person for a transfer. The Clerk shall strike through the last address, ward and precinct number and record the new address, ward and precinct number on the original and duplicate registration cards, and shall place the original registration card in proper precinct file. Any registered elector who has removed from one election precinct of a Township, City or Village to another election precinct of the same Township, City or Village shall have the right to make application to have his registration transferred on any election or primary election day by executing a request over his or her signature for such transfer and presenting the same to the election board in the precinct in which he is registered. Upon receiving such request the inspector of election in charge of the registration records shall compare the signature thereon with the signature upon the applicant's registration record and if the signatures correspond then the inspector shall certify such fact upon said request and the applicant for transfer shall then be permitted to vote in such precinct for that election only. The application for transfer shall be filed with the Township, City or Village Clerk who shall transfer such voter's registration in accordance with the application. When the name of any street in a Township, City or Village has been changed it shall be the duty of the Township, City or Village Clerk to make the change to show the proper name of street in the registration records, and it shall not be necessary for the elector to change his registration with respect thereto in order to be eligible to vote.
