HEARTBURN. . a A Common Ailment

Heartburn is one of the most common of all ailments. Nearly everyone has experienced it at one time or another; its description as a glowing fire beneath the sternum (breastbone) is familiar.

Perhaps this has occurred after eating a large or spicy meal and accentuated by lying down or by bending over.

A Bit of Anatomy

The story of heartburn focuses on the esophagus (foodpipe) just above the point where it leaves the chest by passing through the diaphragm to join the stomach.

The LES (lower esophageal sphincter) is that area of "muscular squeezing" by the wall of the lower esophagus that determines whether or not irritating stomach juices will back up into the esophagus.

When the LES is too weak, backflow will occur. Irritation of the lower esophagus by acidic stomach juices is termed *reflux* (meaning a

CONTROLLING HIGH BLOOD PRESSURE (HYPERTENSION)

High blood pressure has been associated with an increased incidence of heart attack. When high blood pressure is not treated, it becomes a major health problem, and the result may be damage to the heart, kidneys, and other organs. Studies show that high blood pressure increases the risk of having a heart attack, a stroke or kidney failure. When high blood pressure is combined with other conditions such as obesity, cigarette smoking, high blood cholesterol levels, or diabetes, the risk of heart attack or stroke is multiplied several times.

Blood pressure is simply the pressure put on the walls of the arteries as the heart pumps blood through them. In all human beings, it varies from minute to minute, going up when we are excited, and going down when we rest. However, in some people blood pressure goes up too high and stays that way.

Question: What malady is likely this winter to leave millions of Americans "deaf in the ears, hoarse in the throat, red in the nose, green in the gills, damp in the eyes, twitchy in the joint and fractious in the temper?"

Answer: The common cold.

If someone were looking for a description of the misery brought to millions of people each winter by the common cold, that person would be hard pressed to find one more lucid than that made by Charles Dickens over 100 years ago.

Perhaps no other illness has been the object of more serious medical investigations, speculations, and superstitions than the common cold. It also remains one of man's most puzzling maladies. No doubt, many people in the clutches of a bed-confining cold have offered the same lament that Dr. James D. Watson voiced in 1962, when, in accepting the Nobel Prize with two British scientists for discovering the molecular structure of

"backward flow") esophagitis (meaning inflammation of the esophagus).

In brief, heartburn is best understood as the symptom perceived when reflux of stomach juices occurs excessively, as a consequence of a *weak* LES.



When you have a headache, should you take a preparation that will not only ease headache pain but relieve an upset stomach and calm your nerves?

Not unless all of these symptoms' are present simultaneously,

APhA, the national professional society of pharmacists, recommends that you take medicines, including non-prescription medicines, only when you need them, and only for the specific ailment present.

Never leave medicines where children can see or reach them. If a child can see a box or a bottle, he'll often figure out a way to reach it. A safe, useful 'medicine for you can be a poison to a child; keep all medicines hidden and out of reach-in a locked cabinet

If your husband had a Heart Attack in bed tonight, would you know what to do?

It may go on for a little while before you notice. He may say it's indigestion. Or nerves. He may have a feeling of uncomfortable pressure, fullness, squeezing or pain in the center of his chest (that may spread to the shoulders, neck or arms) and last for two minutes or more.

Dizziness, fainting, sweating, nausea or shortness of breath may also occur, but these signals are not always present. Sharp, stabbing twinges of pain are usually *not* signals of a heart attack.

Call your emergency medical service immediately. Or, if you can get him to a hospital with emergrency cardiac care faster in any other way, do so.

He may refuse to accept the possibility that he is having a heart attack. Many heart attack victims do just that. Don't let him make you wait. Because seconds count. Get help and get it fast.

Remember, if it isn't a heart attack, it doesn't matter. If it is, nothing matters more.

The label on home medicines contains information of the utmost importance. It is a *vital message* from the manufacturer to the consumer, a message which identifies the medicine by name, lists the active ingredients, and states the conditions or symptoms for which it should be used and NOT used.

Always follow label instructions carefully. Do not exceed the recommended dose. If you should have any question concerning the product which the label does not answer, consult your physician, dentist or pharmacist.

Warning: Never take or give medicines in the dark. Know exactly what you are doing in order to prevent an accident. Read the label before using. Read it again when restoring the medicine to its proper place in the medicine chest, where it belongs immediately after use. And, most important, keep all medicines out of the reach of children. In case of accidental overdose, contact a physician immediately.

Reminder: *Read and follow the label.* Keep yourself within reach of your children and make your home a healthier and happier place in which to live!

DNA, noted, "It is an important thing we have accomplished, but we have not done away with the common cold—which I now have."

Although Dr. Watson may have made his remark in jest, the common cold is no laughing matter. For many people, the fall and winter months are nothing more than one big runny nose and cough. common cold will force more people to visit their doctors than any other illness. They will use more than 100 different cold and cough remedies at a cost of over \$750 million.

According to the U.S. Public Health Service, at least every third American will acquire a cold during the coming months. While most adults will have only two or three colds a year, those with young children may suffer six or more, and some children may end up suffering a dozen.

Although the common cold has been around since recorded time, it has only been within the last 20 years that researchers have been able to learn about its origin, mode of transmission, prevention and treatment.

The common cold is a "grab bag name" given to a variety of viral infections in the upper respiratory system, according to Dr. Bruce Ribner, assistant professor of medicine and microbiology at the Medical College of Ohio. More than 100 viruses are known to cause colds, with the most common being the rhinoviruses, influenza and parainfluenza viruses, adenoviruses, corona, and respiratory syneytial viruses.

The infectious agents most clearly associated with the common cold are rhinoviruses, which are nothing more than small amounts of protein and nucleic acid bound together.
