

Ordinance No. 85

AN ORDINANCE PROHIBITING THE USE, PURCHASE, AND TRANSPORTATION OF ALCOHOLIC BEVERAGES BY MINORS, THE SALE AND FURNISHING OF ALCOHOLIC BEVERAGES TO MINORS, AND THE USE, SALE, PURCHASE, AND TRANSPORTATION OF ALCOHOLIC BEVERAGES BY PERSONS UNDER THE AGE OF TWENTY-ONE (21) YEARS IN THE VILLAGE OF CHELSEA, AND TO REPEAL ORDINANCE NO. 75.

The Village of Chelsea Ordains:

Section 1. "Alcoholic Beverages" as used in this Ordinance is defined as:

Any spirituous, vinous, malt or fermented liquor, liquids or compounds, whether or not medicated, whatever name called, containing one-half (1/2) of one (1/2) percent or more of alcohol by volume which are fit for use for beverage purposes.

Section 2. No person shall sell, furnish, give, or deliver any alcoholic beverage to any person under the age of twenty-one (21) years.

Section 3. No person shall furnish any false information, or make any false representation, to any police officer, or to any person engaged or employed in the business of selling alcoholic beverages, for the purpose of obtaining any alcoholic beverage for any person under the age of twenty-one (21) years.

Section 4. No person under the age of twenty-one (21) years shall, in the Village of Chelsea, do any one of the following acts or any combination of the following acts:

a. Purchase, offer, or attempt to purchase, transport, or consume any alcoholic beverage.

b. Transport or move any alcoholic beverage into any establishment licensed to sell alcoholic beverages.

c. Furnish any false information or make any false representation as to his or her age to any law enforcement officer, or to any person in charge of or employed in an establishment licensed to sell alcoholic beverages, for the purposes of obtaining a sale of any alcoholic beverage to himself or herself.

Section 5. Ordinance No. 75, adopted April 10, 1972, be and the same is hereby repealed.

Section 6. Any persons, persons, firm, or corporation who shall violate any of the provisions of this Ordinance shall be punished by a fine of not more than ONE HUNDRED (\$100.00) DOLLARS, or by imprisonment not to exceed ninety (90) days, or both such fine and imprisonment or such portions thereof, in the discretion of the Court.

Section 7. This Ordinance shall not apply to a person who is employed by a licensee of the Michigan Liquor Control Commission, the Michigan Liquor Control Commission, or an agent of the Michigan Liquor Control Commission, who shall transport or have in his or her possession alcoholic beverages or liquor during the person's regular working hours, and in the course of the persons employment.

Section 8. The within Ordinance shall be in full force and effect twenty (20) days after its passage and publication.

Ordinance No. 84

AN ORDINANCE TO REGULATE THE STANDING AND PARKING OF VEHICLES UPON THE PUBLIC STREETS AND TO PROHIBIT, LIMIT, OR RESTRICT "ALL NIGHT" PARKING OR PARKING DURING THE EARLY MORNING HOURS, TO PROVIDE FOR THE POSTING OF SIGNS, TO GIVE NOTICE OF SAID RESTRICTIONS, AND TO PROVIDE PENALTIES FOR VIOLATION OF SAID RESTRICTIONS.

The Village of Chelsea Ordains:

An Ordinance to prohibit the parking or standing of vehicles upon the public streets of the Village of Chelsea between the hours of 2 A.M. and 5 A.M. nightly:

Section 1. It shall be unlawful for any person to park or stand any motor vehicle upon the public streets of the Village of Chelsea between the hours of 2 A.M. and 5 A.M. nightly.

Section 2. Upon the effective date of the adoption of this Ordinance, the Chelsea Village shall post signs giving notice of such local regulation as may be most appropriate and sufficiently legible as to be seen by an ordinarily observant person, approximately three feet by four feet, posted on the facades of the corporate limits of the Village of Chelsea.

Section 3. The Police Officers of the Village of Chelsea are hereby authorized to issue citations to persons who violate this Ordinance, which shall require their appearance before the Court having jurisdiction of the same, or file a Complaint and seek a Warrant for the arrest of any person violating said Ordinance from the Court having jurisdiction of the same.

Section 4. In any proceeding concerning the violation of this Ordinance it may be presumed that the owner of the motor vehicle was the person who parked said motor vehicle or had the same under his control at the time it was parked in violation of this Ordinance.

Section 5. Any person who shall violate this Ordinance shall be guilty of a misdemeanor and shall be punished by a term of imprisonment not to exceed ninety (90) days, a ONE HUNDRED (\$100.00) DOLLAR fine, both, or any part thereof.

Section 6. The within Ordinance shall be effective twenty (20) days after publication.





Floyd Roderick Retires As Supervisor of Village Landfill

Retirement usually means one of two things: either you did such a good job that everyone notices when you hang up your hat, or you did such a good job that almost no one notices that you're gone.

The second case is certainly true of Floyd Roderick, who supervised the village landfill so well for 15 years that, when he retired last month, his smoothly-oiled operation never missed a beat.

Which isn't to say that Floyd won't be missed. He has been a mainstay at the landfill since

1964, when he accepted the supervisor position at the then three-year-old site. There was hardly anyone to supervise, though, since Floyd was the only employee. For seven years he drove and repaired machinery, organized and landscaped the fill alone.

The salary back then for the job was \$1.90 an hour, Floyd recalls with a smile.

Roderick was born in Illinois and moved to Michigan when he was about 11 years of age. He was schooled in Ann Arbor and moved to Chelsea soon after his marriage, at age 19 in 1934.

He worked for a number of years with Ted Balmer in his auto repair shop, was employed by Kramer Freight Lines and worked in a few smaller shops, all around Chelsea.

Then, in 1964, he heard that the village was seeking someone for the landfill job, made application with the council and began his village career.

Conditions eased after a while. In 1971, Floyd received some assistance in the form of a part-time helper. The fill now employs a supervisor in addition to one full-time and one part-time employee.

The work was never easy, with snow to be plowed off in winter and muddy conditions in the spring and fall. Floyd remembers the biggest business day for the fill—436 loads in seven hours one exhausting Saturday last year.

Every job has its idiosyncracies and land fill supervision is no different. Floyd said that he came to dislike bed springs and

rubber tires. "Bed springs are hard to push under," he explained, "and rubber tires just work their way up to the surface of the sand. They won't stay buried." Now that all the driving and fixing and bedspring-burying is over, what does Floyd plan to do with his retirement? "Goo' off as much as I can," he vows.

Ann Arbor Trust Co. Opening Third Branch

Ann Arbor Trust Co. has received approvals from bank regulators to open its third branch office, at S. State St. and Ellsworth Rd., near Ann Arbor.

George H. Cress, Trust Company president, indicated that remodeling of an existing building on S. State St., just beyond the I-94 overpass, would begin as soon as final plans are prepared and local permits secured. Opening of the branch is scheduled for late this fall.

In his quarterly message to stockholders, Cress reported that Ann Arbor Trust will move into new branch office buildings in Chelsea and Brighton Monday, April 30, and on May 21, respectively. These are the first branch banking offices established since Ann Arbor Trust became a full service commercial bank in August of 1974.

Total assets of the Trust Company at March 31, 1979, were \$75,285,478, compared to \$70,610,749 one year ago, Cress noted, while deposits increased from \$64,939,831 to \$63,364,134 on the same dates. Outstanding loans from March 31, 1978 to March 31, 1979, increased from \$38,774,317 to \$48,660,311, up approximately 25 percent.

Total earnings for the first quarter of 1979 were \$182,842, compared to \$179,844. On a per share basis the first quarter earnings amounted to 89 cents compared to 88 cents for the same period in 1978, after giving effect for 2-for-1 stock split payable April 12, 1979.

"We are experiencing increased costs of funds and increased expenses due to the start-up of two new branches," Cress noted. "We are confident these locations and the new branch office on S. State St. will be positive contributors to future earnings," he added.

Good Things Growing In Michigan

After the long winter, you may wish to try a Michigan wine and cheese tasting party to welcome spring. Our state's 14 wineries produce every type of wine, including appetizer, dinner, sparkling and cooking wines, to rank Michigan sixth among wine producing states, according to the Michigan Department of Agriculture.

Michigan's 15 cheese factories produce about 33 million pounds of natural cheeses annually, with each variety distinctive in flavor, body and texture.

There are no firm or definite rules in matching cheeses and wines. Try mixing and matching to discover new combinations! For a perfect blend between cheese and wine, be sure neither flavor dominates. Light, dry white wines should be served with light cheeses that are delicate in flavor. Heavy, full-bodied wines should be served with cheeses with pronounced flavor.

When preparing a tasting party, allow four to six ounces of cheese and a half bottle of wine for each guest. Open red wines an hour before serving to allow them time to "breathe" and develop a full bouquet.

Cheese, with bread and crackers, helps to neutralize the palate between wines. Offering cheese in large portions permits guests to slice the amount they wish. Be sure to provide plenty of knives to avoid mixing various cheese flavors.

When serving wines, have guests sample dry wines first, white and red, then sweet wines, again offering white before red. Tasting a glass of sweet wine first spoils the tastebuds for drier wines. To keep from combining wine flavors and aromas, you will need to rinse out each glass after each wine.

For anticipated wine tastings, building a "library of bottles," a small wine cellar, is not a difficult task. A clean, dry, well-ventilated dark corner away from hot water pipes will do. Corking allows wine to continue maturing in the bottle. Store bottles horizontally so wine is in constant contact with the cork. This prevents the cork from becoming too dry and shrinking, which would let air seep into the bottle. If air should reach the wine, it begins to oxidize, losing its color, bouquet and aroma.

Hospital Child Care Center Plans Month

Chelsea Community Hospital Child Care Center has a variety of activities in May planned for the children enrolled.

The first week, children will be learning about zoo animals and wild animals. They will be discussing the names of the animals, what they eat and what types of homes they live in. In conjunction with the nutrition unit, the center will have its spring parents' meeting, Tuesday, May 22 at 7:30 p.m. Julie Say, Chelsea Community Hospital Nutritionist, will present information on nutrient requirements for preschoolers, and food acceptance problems and suggestions for handling them.

The center's teachers will also present information on nutrition education activities planned at the center.



These were the considerations faced during long evening hours last week by the budget committee of Chelsea United Way, principal fund raisers for social services that depend on Chelsea area citizens and businesses for support.

Jeanette Tobin, Daphne Hodder, Dick Rigg, Bill Spade, Eleanor Hall and Tom Valliencourt, along with committee chairman Jerry Dresselhouse, spent eight hours listening to presentations by agency representatives who came before the panel during two evening sessions in the Union Hall of Local 437 UAW on Main St. One member of the committee, Sandy Ellenwood, was absent because she was out of town.

The United Way committee received information and asked questions about the management of these social service organizations. The members wanted to know how well the money is being spent, how much of Chelsea area gifts actually reach the people for whom the money is intended.
