
Fire Destroys J. Miller Home

Early Tuesday morning, Jan. 12, a fire at the home of Mr. and Mrs. John Miller of 17376 Cassidy Lake Rd. broke out in the chimney area and spread to the rest of the two-story wood frame farm house resulting in an estimated \$85,000 in damage to the house and its contents. No injuries were reported.

The house is located between Roe and Waterloo Rds. in Lyndon township approximately seven miles northwest of Chelsea. A total of 22 firefighters from both the Chelsea and Dexter Fire Departments, battled the blaze

for about four hours before bringing it under control. Seven pieces of equipment were used in the firefighting attempt.

In another fire on Tuesday evening, a Scio township horsebarn was leveled and three horses destroyed though Dexter firemen were able to save a larger barn that was attached to the one that was destroyed. Four other horses were also saved. Located on Marshall Rd. and owned by John Mersereau, Jr., the three horses killed in the barn fire, included two registered thoroughbreds and a registered quarter horse.

Two More Charges Filed Against Harden

Two additional complaints of sexual molestation of young girls were made to Chelsea Police last week and, on Friday, Jan. 15, John Harden was arraigned before Judge Kenneth Bronson of 14th District Court on two separate counts of first degree criminal sexual conduct stemming from the complaints filed by the parents of a four-year-old girl and a seven-year-old girl.

Upon arraignment, bond was set at \$3,000 per charge. If eventually convicted of the sex charges, Harden could face a maximum sentence of life imprisonment per charge.

According to Chelsea Police Chief Robert Aello, following Harden's initial arraignment on similar charges Thursday, Jan. 7, parents of children who had been babysitting charges of the Hardens questioned their youngsters regarding any incident of possible sexual misconduct. Two complaints were later filed by the Chelsea families. The alleged crimes were reported to have been committed over a period of four months.

An investigation ensued and, because of the sex and age of the

children involved, Chelsea Police went to the Washtenaw County Sheriff's Department and retained the help of a female deputy to interview and secure statements from the alleged victims. A three-page report was submitted to the Chelsea Police who notified Harden's attorney, William Rademacher, of the additional charges.

A preliminary examination on all three counts of first degree criminal sexual conduct will be held Tuesday, Jan. 26 at 1:30 p.m. at 14th District Court.

The Chelsea orchestra is one of only two high school orchestras in Michigan invited to perform at this year's conference. Regarding the selection, Kevin Miller the orchestra's director stated, "This is a tremendous honor for the high school orchestra and a tribute to the phenomenal growth it has made. It reflects well on the quality of the entire music department and the support for a strong music program in the Chelsea schools."

The orchestra will perform on Saturday, Jan. 23 at Hill Auditorium, beginning at 9:30 a.m. Performing with the orchestra as a guest soloist will be Ann Ourada, a violinist with the Detroit Symphony Orchestra. She will be featured in Mozart's Violin Concerto No. 5.

Also on the program will be works by Beethoven, Tschalkovsky, Dvorak, Vaughan-Williams, and Saint-Saens.

Last Saturday, the CHS symphony orchestra performed a preliminary concert at Eastern Michigan's Pease Auditorium for the enjoyment of students and professors.

Bitter Cold Weather, High Winds Combined Make Living Difficult

For the second week-end in succession the Mid-west was blanketed in a shroud of bitter cold, snow and wind chills up to 58 degrees below zero.

For those of us in Chelsea, the weather was no better as winds drifted snow across roads, sheeting the pavement with ice and blocking many back roads thereby making them impassable.

Mother Nature dropped a couple new inches of snow on the area and high winds caused near blizzard conditions for much of the week-end. Travelers' advisories attempted to keep drivers off the icy roads and strong gusts of wind did a good job of blowing pedestrians into the streets and motorists onto the road shoulders and into ditches along the roadside.

Short-circuited electric blankets, multiple pairs of wool socks, hot drinks, Kleenex, and over-worked furnaces did what they could to minimize the westerly wind that found its way through even the most protected windows and doors. Cookie-baking, soup-making and snuggling close to the fireplace with a good book were some of the "warm" things to do while per-

sons who ventured outdoors were greeted by skin-chapping and bone-piercing Arctic air that was scheduled to subside for the time being by Monday.

New record lows were reported throughout the state as Detroit set a record low for Jan. 17 with a temperature of minus 17 in the early morning hours. Outlying areas were hit with even more severe temperatures.

Crime was reported to be down while traffic accidents were up, both because of the frigid weather. Still, with over-worked furnaces and fireplaces in use to maximize warmth, house fires were fairly prevalent during this latest cold spell.

So, for the second consecutive week-end, rest, relaxation and keeping warm were the activities of the day and night.

Pair Charged With Sexual Misconduct

Before Judge Kenneth Bronson in 14th District Court, Saline, Tuesday, Philip and Mark Robson, the father and son accused of raping a 17-year-old retarded woman under their care at a Dexter foster care home, waived their right to a district court preliminary examination during which time prosecution would be forced to prove that a crime was committed and produce evidence to show reason to believe that the person(s) charged committed the offense.

The Robsons, ages 51 and 17, respectively, have been charged with first degree criminal sexual conduct in the alleged assault of the woman residing in the Great Oaks foster care home where the pair served as houseparents. They were arrested last week following investigation by the Washtenaw County Sheriff's Department, resulting from a report given to them by the woman's mother.

The Great Oaks home, located on Wylie Rd., is operated by Kinship Homes, Inc.

The Robsons have been bound over for arraignment in circuit court on Jan. 26. Both are free on \$1,000 bail each.

Push for Economic Recovery

To Continue in Legislature
Legislative agendas for 1982 will continue to push for legislation aiding the state's economic climate in order to make the state more attractive to business and industry.

Governor William G. Milliken believes the state's recovery is so important, that his running for re-election or for the U.S. Senate could hamper any efforts and has decided not to seek any elective office so he could concentrate fully on the problems facing Michigan.

House Speaker Bobby Crim of Davison also may not seek re-election (he earlier announced he would not be a candidate for the Democratic nomination for governor) and he too, would be free to work solely for economic recovery without possible charges of politics surfacing during deliberations.

Senate Majority Leader William Faust of Westland, although expected to seek re-election to the Senate, has been able to work well with the governor and other legislative leaders to forge legislation for the betterment of the state.

And House Minority Leader William Bryant of Grosse Pointe Park, said completing the state's recovery package—including changes in unemployment compensation and the single business tax—will be the main priority for legislative action in 1982.

Bryant, however, said working on some of those issues may prove difficult to get the backing of the so-called "dissident" Democrats, who helped Republicans pass the major portion of the worker's compensation reform package last year.

He said especially sensitive to Democrats will be the governor's proposal that unemployed worker wait a week before receiving benefits.

Such a proposal could save business and industry as much as \$115 million each year.

He noted that earlier reforms in unemployment compensation enacted in 1980 are sunsetted for 1983 (will expire unless re-enacted) at which time benefit levels would be rolled back to the pre-1980 levels.

Bryant said with the sunset approaching, it may be possible to negotiate some agreement with the Democrats on cutting compensation cost to business.

Bryant said another priority for the year will be the continuing search for a property tax reform proposal.

He suggested the public likely will not agree with Governor Milliken's veto of legislation providing an additional \$150 million in property tax cuts.

Bryant said it would be difficult this year to consider any tax increase designed to prevent further state budget cuts.

If any tax increases are considered, however, it would be politically easier to increase nuisance taxes such as the cigarette tax, but he added almost any other tax increase would have to be tied to a property tax cut.

Everyone agrees. Economic recovery issues remain the most important for the Legislature to address with the opening of the 1982 session.

With enactment of the tough worker's compensation reform package, labor Democrats have proven they can work with business oriented Republicans putting together a coalition to

make some hard decisions to better the state, keeping it a viable place to live and do business in the future.

Student Council Collects Coins To Help Needy Families

Members of Chelsea High school's Student Council made their contribution to the Chelsea United Way and the needy children in the community by collecting loose change from fellow students during the two days prior to Christmas vacation.

During lunch hours, Student Council members collected a total of \$73, money that was later distributed to needy families in Chelsea to assist with Christmas expenses.




Woman's Club Hears of Help For Handicapped



No Selective Grain Embargo on Russia Promised by Reagan

President Reagan told Farm Bureau officials Jan. 8 that he would not consider imposing a selective grain embargo on the Soviet Union because of the Soviet role in Poland's martial law.

American Farm Bureau President Robert Delano said Reagan told him that a total embargo on all exports to Russia remains one

of his last resorts in dealing with the situation.

"I don't think there will be an embargo," Delano said following the White House meeting. "There certainly will not be a selective agricultural embargo. If there is an embargo, it will be an across-the-board embargo."

Delano reminded Reagan that since agricultural exports to Russia in 1981 accounted for

nearly three-fourths of total U. S. exports to the Soviet Union, a total embargo would still place a heavier burden on agriculture than on other industries.

Delegates to the American Farm Bureau Federation annual meeting, scheduled for Jan. 10-14 in San Diego, Calif., are expected to determine policy on this issue for the nation's largest farm organization.

Vietnam-Era Vets Given More Time on GI Bill

As many as 39,000 Vietnam-era veterans are expected to take advantage of a one-time, two-year extension of their GI delimiting date, the Veterans Administration estimates.

Extended eligibility for certain training programs was included in the Veterans' Health Care, Training and Small Business Loan Act of 1981 signed into law by the President Nov. 3. The extension period, which opened Jan. 1 and runs through Dec. 31, applies to educationally disadvantaged or unskilled Vietnam-era veterans who allowed their 10-year delimiting date to expire before using all their entitlement for educational training.

Eligible veterans may use their remaining entitlement to obtain a high school diploma, or its equivalent, or pursue a program of apprenticeship, other on-the-job training or a program with a vocational objective.

Enrollment in college degree, flight or correspondence courses is not included in the extension. Veterans who have already earned college degrees are ineligible for the extension.

VA is urging all potentially eligible veterans to get complete information on this program at VA offices and through organization service officers.

Police Report Busy Month Of December

Chelsea Police Department made a total of 240 radio runs last month as compared to 230 during the preceding month. Types of runs made included 24 suspicious vehicles, 13 property damage accidents, four assault and battery, and four malicious destruction of property.

Twelve arrests were made as compared to nine in November and December's arrests involved six misdemeanors, four warrants, one felony and one juvenile.


Types of arrests made in Chelsea during December include three incidents of driving under the influence of liquor, four warrant arrests, two incidents of assault and battery and one case of criminal sexual conduct. The juvenile arrest made was in regard to the malicious destruction of property over \$100.

A total of 26 case reports were written in December as opposed to 11 in the preceding month. Types of reports written included four instances of assault and battery, five larceny of property, two drug overdoses and five occasions of found property.

Sixteen as compared to 12 accident reports were taken and a total of one hour and 20 minutes were spent assisting the Washtenaw County Sheriff's Department on three separate accidents.



Dear Editor:

I recently joined with two other Michigan legislators in proposing that Michigan convert its 110-member House of Representatives and 38-member Senate into one compact and more efficient 72-member unicameral Legislature. There are at least five strong arguments in favor of this proposal which I will outline below. Most important is the common-sense reality that governmental structures, like businesses, must change from time to time if they are to keep pace with the demands of modern society. A great deal of citizen discontent with the Legislature could be addressed through some structural changes in the way we do business.

First, there are so many "choke points" in the present lawmaking system that it's easy for lobbyists to prevent the passage of needed legislation. A bill must survive the following hurdles: 1) After introduction, it must be approved by a subject-matter committee (for example, the Judiciary Committee for Friend of the Court reform). 2) It must then be passed by the full house. 3) It is then sent to the other chamber, where it must be approved by yet another subject-matter committee. 4) If it survives that second committee, it must be passed by the full second chamber. 5) Since most bills get changed as they pass through this maze, a conference committee made up of legislators from both houses must put together a compromise bill. 6) The compromise bill must then be passed, in exactly the same form, by both chambers. 7) The bill must be signed by the Governor.

At any of these points, a much-needed bill can be sidetracked by lobbyists who have the ear of just one or two sympathetic legislators. Sometimes, even when legislators of both parties and the Governor are in basic agreement, nothing will happen on a measure because it's so easy for pressure groups to gum up the works. One case on point would be the popular "auto lemon law" which was enacted into law only after eight years of opposition from the automobile dealers' association. The previous sponsors had given up hope.

Another example: Michigan's very popular "bottle law" approved as a ballot proposal, was originally a legislative idea. It never had a chance in the Legislature, there were too many of those "choke points."

Second, a lot of time and effort would be saved if there were only one legislative chamber. In the 1979-80 session of the Michigan Legislature, for example, there were 2,159 bills introduced in the State House of Representatives; 477, or just 22 percent, became law. There were 1,333 bills introduced in the State Senate; 287, or 20 percent, became law. When four out of five bills die, the lawmaking process needs streamlining.

In Nebraska, on the other hand, which has a one-house Legislature, about two-thirds of the bills introduced often make it into the statute books.

Third, the original reasons for having a two-house Legislature no longer exist. The Michigan Legislature was patterned after the U.S. Congress with its two chambers. Those familiar with American history know that the federal Congress was given two chambers (with the Senate having two Senators from each state without regard to size or population) as a compromise between the interests of the populous states such as New York and the smaller states like Rhode Island.

If these arguments were ever applicable to Michigan, then the situation was changed by the Supreme Court's "one person, one vote" decision in Baker v. Carr and Reynolds v. Sims. All citizens are now equally represented in Congress and in state legislatures, regardless of where they live. Two chambers are thus a historical anachronism.

Fourth, we should consider the monetary savings. Having one house of just 72 members would save millions of dollars per year in legislators' salaries and staff salaries. Perhaps 40 percent could be saved, without degrading the professionalism of the Legislature, and in these times every dollar counts.

Finally, we have to recognize that, like private organizations, government must be restructured from time to time to keep up with modern realities. There is no reason to believe that a cumbersome two-chamber system established 200 years ago is adequate to meet the needs of modern society.

Long ago, before chemical pollution threatened our lives, before technology changed at a rapid pace, and when social institutions changed only over centuries rather than decades, a legislative process that was slow and cumbersome was appropriate. But slow, incremental change is no longer the norm—it is the exception. We must have governmental structures that can adapt to that change. Converting to a unicameral legislature would be one step in the right direction.

Cong. Dunn Posts 99% Voting Record On Roll Calls

Congressman Jim Dunn (Mich-6) had one of the highest voter participation records during the first session of the 97th Congress, registering a vote on 99 percent of all roll calls, according to the Jan. 9 issue of Congressional Quarterly.

Only seven House members recorded a vote on all roll calls during the first session of the present Congress, according to CQ, a weekly report on Congressional activities.

Voter participation, as defined by CQ, is the percentage of recorded votes on which a member votes "yea" or "nay." Voting participation is the closest approach to an attendance record, according to Congressional Quarterly.

Members of Congress on average voted on 92 percent of the votes taken, the highest score since CQ began keeping such records in 1951. The previous high was 91 percent, established in 1975.

As is traditional, according to CQ, Republicans voted more often than Democrats last year.



Mercywood Outreach Center Moving to Maple Medical Center

Mercywood Outreach Center, now located at 405 Jackson Rd., will move to the Maple Medical Center, 501 N. Maple, where it will be housed in a new 10,000 square foot addition. The center is a satellite of Ann Arbor's St. Joseph Mercy Hospital and used the outpatient mental health programs of Mercywood Neuro-Psychiatric Hospital. Both Mercywood and St. Joseph Mercy Hospitals are owned by the Sisters of Mercy Health Corp.

The director's decision to approve the project followed the recommendation of the Comprehensive Health Planning Council of Southeastern Michigan.

MICHIGAN FARM BUREAU
★ *The Sacred Entitlements . . .*

During the past several months, we've been hearing a lot about federal "entitlement" programs. They are so sacred in the minds of many in Congress and so loaded with political dynamite, that it takes a special brand of courage to suggest that they need to be cut back as part of the effort to bring federal spending under control and the budget into balance.

The so-called entitlements are various kinds of social benefits that have been adopted by Congress over the years, that people have come to think of as guaranteed by our Founding Fathers shortly after the signing of the Declaration of Independence. They include such things as full indexation of federal employee pensions—something no one in the private sector can even dream about. They include early retirement for federal workers and for those who want to draw Social Security before reaching 65, and they include all kinds of social and welfare programs, sometimes called "transfer payments," many of which are indexed to inflation.

A letter to the Washington Post recently, written by a sophomore in an affluent Virginia suburb, complained bitterly about the fact that President Reagan had cut the size of his school lunch and local school officials had increased the cost from 70 cents to \$1.25. Said this sophomore: "The school system is supposed to provide us with a nutritious meal once a day, and the meal they give us is not good enough for growing teen-agers."

Where is there written in the National Archives that taxpayers are supposed to provide a free or subsidized meal to school children? And who has decreed that it must be a hot meal? Whatever happened to the brown bag or lunch bucket carried from home?

A lot of us taxpayers who still carry those brown bags wonder about those "entitlement" programs.





Varsity Cagers Win Two Before Falling To Lumen Christi

Chelsea managed to continue its winning streak to two games Tuesday, defeating the Howell Highlanders, 59-56. In game plan, the team played exactly as it had against Lincoln Saturday, controlling the tempo and leading the entire second half.

The major factor in the win was the combination of David Wojcicki and John Welton, who provided excellent leadership and scored 17 points each.

According to Coach Robin Raymond, the Bulldogs exhibited excellent guard play and good inside play to pace the team to its second consecutive win. Bareis, Steinhauer, Kiel and Pate provided a good combination of inside and outside play in controlling the tall Howell cagers.

The necessary combination of good scoring, good rebounding and good defense was there as the Bulldogs won the non-league contest.

To compensate for their weaknesses, the Chelsea team played a half-court zone defense in combination with a man-to-man and full court zone press to keep the opposition off guard.

From the floor, Chelsea was 26 for 55 for 48 percent while at the free throw line, the Bulldogs completed 7 of 11 for a 64 percent rate. Howell, on the other hand, was 24 of 52 for 46 percent from the floor while, at the line, the Highlanders managed eight of 19 for 42 percent.



Accepted for Pro Golf Management Course at Ferris





ment. At this point, Prince explains that the girls participating in the study are eating poorly and there are serious concerns raised with their nutritional status. Boys, on the other hand, are taking in at least their minimum daily allowance of the 16 essential nutrients and some are even over-eating. According to Prince, ninth graders are in a period of growth and consuming of the essential nutrients is crucial to future development.

***Return of the Steam Locomotives**

Most residents of rural America carry fond memories of the lonesome sound of locomotive whistles in the middle of the night. They were a part of the American way of life until the late 50s and early 60s when diesels replaced steam motive power on the rails.

As far as the public was concerned, the biggest problem with diesels was that they lacked the glamour and the visual impact of raw power projected by the steamers. And their sounds were unique as well; up close and at great distance. A steam whistle never has been successfully imitated.

Now there is the possibility that coal fired steam engines might return to the rails. The major reason is cost of fuel. When diesels were first introduced, fuel oil was cheap, but obviously that is no longer the case.

Now the economical fuel is coal, and American Coal Enterprises, Inc., of Akron, O., has a design on the drawing boards for a truly modern steam engine. This one will not pollute like the old timers, no cinders and noxious gases in the exhaust, and it will recycle its water which will mean fewer stops. What is more, at today's fuel prices, it will be more efficient to operate than diesels.

The designers don't say what kind of whistle will be installed on the new machines, but where there's steam under pressure, it's always possible that sounds from the past may return to the countryside.


After that meet, Chelsea must face state powers Cherry Hill, Battle Creek Lakeview and Adrian.



During pregnancy, women tend to be busier preparing for the upcoming birth. Once the baby arrives, she is even busier. Instead of six months, it may be a year or more between visits. Obviously, more dental work will be discovered in a period of one or two years than in a six-month checkup.
