# Land of Oz comes to Stockbridge

The Town Hall Players (THP) brought Kansas and the Land of Oz to the stage this past weekend with their rendition of L. Frank Baum's 1900 novel and MGM's 1939 motion picture, The Wizard of Oz.

Selected by the American Film Institute's number one fantasy movie of all time, The Wizard of Oz is the tale of Dorothy Gale (played by 10 year old Sarah Cattell) a Kansas farm girl who lives with her Auntie Em (played by Judy Lentz) and Uncle Henry (played by Wes Lentz) along with three farmhands.

When Dorothy's dog Toto (played by the Lentz's terrier fittingly named Oz) bites neighbor Miss Gulch (played by Dawn Clark), she gets a sheriff's order to have the dog destroyed. Fearing for his life, Dorothy runs away with Toto and the well-know story begins.

On the yellow brick road Dorothy is joined by the scarecrow (played by Mike Miller), the tin man (played by Mike Henderson and the cowardly lion (played by Steve Woerner)

Jeff Boyer, the Artistic Director with THP's "Wizard of Oz" explained this has been one of the most expensive plays to date. At a cost of \$2,000 for the rights to do the play along with another \$2,000 for costumes, sets and props, the group has relied on donations, sponsors and many volunteers to get the show in action.

Managing an Oz cast and crew of over seventy people, Boyer claims this has been one of his most challenging plays since the inception of THP in 2001. Since many are familiar with the Oz storyline, Boyer pointed out there were many obstacles in making it a unique THP production. "You want to stay true to the movie, but you don't want to look like you are copying so I was cautious to make sure we had our own twist on things," said Boyer.

Dorothy is played by ten year old Sarah Grace Cattell, a fifth grader at Daycroft Montessori of Ann Arbor. She lives in Dexter with her parents, Steve and Paula Cattell and siblings Reagan and Stevie. This is her first performance with the Town Hall Players.

"I have really enjoyed the choreography and the singing and dancing with this show," expressed Cattell. She admitted that working with Toto has proved to be challenging as she is allergic to the dog and he can be heavy to carry at times. "He broke the basket today," added Cattell.

The Lentzs' are no strangers to The Wizard of Oz. The high

# Chelsea School Board Moves Forward With Campaign Against Proposal 2

"This is a non-partisan board and this is a very divisive issue," said Chelsea resident and schoolteacher Elise Merkel at the Chelsea School District (CSD) board meeting October 8th. Emotions ran higher than normal as school board members voted to move forward with passing a resolution to promote a "No" vote on Proposal 2 that includes "calling on all citizens

of Chelsea to vote in the best interest of all Michigan school districts by voting no on the proposal."

The proposed resolution, which will be voted on at the next school board meeting, states that Proposal 2 could "negate recent legislative reforms to the Teachers' Tenure Act that have given school boards greater ability to terminate ineffective teachers - Continued on Page 3

# Village Of Pinckney Residents Lose Dog To Coyotes

Subdivision in Pinckney
Village, pleaded with Pinckney
Village Council members
last week to help create an
awareness of coyotes roaming
the village and how dangerous
these predators can be.

The Stones claim their dog was killed in their backyard by a coyote recently and would like to establish some kind of control over these predators within the village. Further, they pointed out that people may inadvertently be feeding the animals. "Dogs are possessions, but there are kids-it could happen to anybody," said Linda Stone.

According to Village Clerk, Amy Salowitz, the current ordinance prohibits the discharge of a firearm in village

Bob Stone went on to request a provision in the ordinance to allow the discharge of firearms circumstances such as this. "If there is a coyote in my back yard, I am more than willing to violate the ordinance to shoot that rascal," claimed Mr. Stone.

According to the Michigan DNR website, statewide coyote hunting season is from July 15-April 15 for residents possessing a valid small game license. However, a coyote may be taken on private property by a property owner or designee all year if they are doing damage or about to do damage on private property - a license or written permit is not needed.

Village of Pinckney Police Chief Jeffrey Newton indicated that per the DNR, the Stones would be permitted to shoot the coyote, however, they would be in violation of the village ordinance.

"My biggest caution to anybody when it comes to discharging a firearm is that once you make the decision you are responsible for the round, the pellets, the arrowwhatever you choose to use," warned Chief Newton pointing out close proximity of others.

The council did not take any further action on the request but, according to Salowitz, will consider putting information on safety with regards to wildlife and children/small pets in the next newsletter.

# Fugitive Arrested After Four Years On The Run

A fugitive from justice who has been on the run for 4 1/2 years was arrested by the Blackhawk County Sheriff's Department in Waterloo, Iowo for disorderly conduct and public intoxication.

According to Unadilla Township Police, Varnet Amaro Brito, a 31 year old Mexican National was charged with sexually assaulting an incapacitated victim in Unadilla Township March 19th, 2008.


During the investigation, Township Police recovered forensic evidence from the crime scene which was sent to the Michigan State Police Crime Lab.

The evidence linked the man to the victim. Officers would not elaborate as to what the evidence was.

Monday, October 15, Unadilla Police were notified that deputies from the Blackhawk County Sheriff's Department arrested Brito on local charges as well as a deportation detainer from the Department

of Homeland Security, Immigration and Customs Enforcement (ICE) for having illegal immigration status.

Unadilla Township Police requested that the Livingston County Prosecutor's Office authorize extradition proceedings so the suspect can be returned to Michigan to face local charges. The prosecutor's office has initiated the extradition process.

In other meeting news, Cedars of Dexter resident William Kincaid asked Council to reverse last month's vote against a financial contribution to Dexter Township for one of sixteen soon-to-be installed outdoor warning sirens. Village Council declined the township's request to pay 25%, or about \$6,000, toward a siren planned for the shared coverage area of Island Lake and Wylie Road. The vote ended in a 3-3 tie, with "rustee Smith absent, resulting in a defeated motion according to standard procedure.

"I don't know how to reconsider a 3-3 draw," responded Keough. "To me it was a no-brainer: - a shared opportunity toward the public good."

Kincaid said the current village siren could only be heard faintly, if at all, in the Cedars retirement community while other trustees reported different opinions from Cedars residents.

Regardless, a new siren will be purchased and installed in the area by Dexter Township as part of the township's project to install sixteen new omnidirectional outdoor warning sirens in the near future. The village currently has two sirens, one located at Dexter Ann Arbor Road and the other at Dan Hoey Road.

The council decided to wait until the next regularly scheduled meeting October 22 to respond to the Ann Arbor Transit Authority (AATA) invitation to participate in a county-wide transit system.



Discounted Dog And Cat Vaccination Clinic Coming To Stockbridge

Ingham County Animal Control will be conducting a dog and cat vaccination clinic as well as dog licensing Friday, October 26 from 11am-4pm at the Stockbridge Area Emergency Services Authority (SAESA) ambulance base located at 125 S. Center Street in Stockbridge.

Vaccination prices for feline rabies and distemper shots begin at \$5 for Ingham County residents and \$15 for non-residents.

Licensing and rabies vaccinations for dogs will also be available starting at \$14 for spayed/neutered dogs and \$50 for non-spayed/ neutered dogs.

Proof of spay/neuter is required to receive discount rate. Delinquent license fees will be waived this day only and dog licensing is limited to Ingham County residents as Ingham County Animal Control is not authorized to write licenses for other counties. Pet micro chipping will also be made available at a special rate of \$15.

# Stockbridge **Police Urge Parents To Get STOPPED**

Information from Stockbridge Village Police Chief

It is no secret to parents of children in the process of obtaining their driver's license - or those whose children already have a license - that getting the license is a milestone in that young person's life.

It is a symbol of a child's progression into adulthood.

However, did you know that motor vehicle crashes are the leading cause of death for persons 15 to 20 years of age? Annually over 3,000 drivers ages 16 to 21 years-old die in the U.S. as a result of these crashes.

The Michigan Sheriffs' Association has developed a notification process allowing parents to be notified when police have stopped their

The STOPPED (Sheriffs Telling Our Parents and Promoting Educated Drivers) program was first developed in 2005, and its goal is to reduce the number of young drivers who are injured or killed in motor vehicle crashes each year. Since its inception, teen driving fatalities in Michigan have decreased significantly.

It is simple and free. Parents can register any motor vehicle that will be operated by a driver under the age of 21. Once registered, a decal is issued by the Michigan Sheriff's Association (MSA) and should be affixed to the front windshield of each vehicle. If the vehicle is stopped by police while being operated by a person under 21, a notification card is filled out and sent to the registered owner to that provides the date and time of the stop, driver's name and number of passengers, reason for the stop, and whether any citations were issued.

The Stockbridge Police Department is urging parents to register their vehicles that will be driven by persons under 21. This is an opportunity for police to partner with parents and assist them in extending a watchful eye on their kids and at the same time raise awareness of young drivers.



Two Chelsea Students Hit by Cars By Lucy Silverio

Two Chelsea high school students were recently hit by cars within ten days of each other. Although each student was taken to the hospital, as of October 9 they were both back in school and expected to make full recoveries.

The first incident happened Thursday September 27 at approximately 4:30 pm at the Freer Road traffic light entry to Chelsea High School. The second was on Friday October 5 at 6:40 pm at the Washington Street Education Center. On both occasions the students were waved into the intersection by one driver then hit by another.

After the first incident Chelsea Superintendent Andrew Ingall met with City Manager John Hanifan. Hanifan said that the city would be initiating a review of the light, the signal and the timing.

After the second accident Ingall had a conference call with Hanifan, police chief Ed Toth, and mayor John Lindauer. The four men discussed more options to promote maximum safety at a crossing to a school on a major

Ingall pointed out the crossing is particularly hazardous because there are four left turn lanes and traffic is coming from four directions. It is possible that the pedestrian crossing sign will be upgraded to a new one that blinks as time is getting short. There may also be more street lighting installed at the intersection.

The main focus for the schools regarding the incidents is to impress upon people the importance of obeying the traffic signals. Chief Toth outlined in an interview the three main aspects of traffic safety: engineering, education, and enforcement.

Upon independent investigation it turns out that the pedestrian crossing signs at the Freer Road intersection only work if a button on a pole is pushed. If the button is not pushed the sign will never change, leaving pedestrians to determine when it is safe to cross the street.

There are signs at some of the buttons alerting pedestrians but the button at the northeast corner does not have a sign. Toth said that a new sign has been ordered that neither of the incidents occurred from that corner.

He also said the traffic light has been in place for six to seven years and Midwest Consulting LLC (MCI) has been contacted.

A traffic safety expert from MCI has been hired by the city of Chelsea to reassess the situation and chart the traffic flow.

"Deciding upon the appropriate light settings, crosswalk and signage is not like flipping coins... there are uniform standards." Toth explained.

'The signage and devices used are there for a reason and follow the Michigan Manual of Uniform Traffic Control Devises."

Since the accidents occurred, police officers have been on scene at the intersection to observe traffic but Toth points out that education was key in both incidents.

"Basically the two accidents were driver error and pedestrian



# **Chelsea School Board Against Proposal 2**

Continued from the Front Page - and retain effective teachers in layoff and recall situations, supersede recently enacted laws that have alleviated the financial burden felt by school boards in paying for employees' health insurance, and that a no vote

would still allow school boards and teachers to continue to bargain on wages, health insurance benefits, class size, and the length of the school day." Tim Heim, a member of the

Michigan Education Association

(MEA) representing Region 3 which includes Chelsea, cautioned the board that even considering a resolution supporting a no vote could be considered partisan and the school board was not elected as Republicans or Democrats, but

as Independents. He urged the board not to consider the issue and to instead allow the voters to decide for themselves without the advisement of the school board.

"With the changes and with the new superintendent we were so happy to be moving into a new era," said Merkel. "I was disappointed when I saw this come up. It is not an appropriate thing for a non-partisan school board to be voting on. As teachers we will be paying very close attention if you do decide to vote on this and how each of you individually will vote."

Chelsea Board of Education President Steve Olsen said he felt all ballot issues attempting to amend the constitution are a badidea. "Our constitution should be our sacred document," he said. "It should be simple and state how our government is organized. It should state the right of people and leave our duly elected legislature to pass laws and adjust things as time goes on. I totally disagree that this is a Democrat - Republican issue for this board. We are a non-partisan board, but we have a duty as elected officials to tell our legislators when we disagree with what they are doing. When they are doing something that is going to harm our school district or our children and we have the same obligation to our constituents when it is a constitutional amendment or a referendum on a statute. I think we should bring it up and if

the board disagrees with these

resolutions fine, but I think we should look at it."

"We have multiple constituencies, our constituencies are not democratic or republican, they are the students, the parents. the teachers, the staff and the taxpayers," said board member Jeff Crowder, "Those are the people that we represent and are concerned about, so however I would vote I would be concerned with all of those constituencies."

It was also suggested that the board vote no on Proposal 5, which no one took issue with. Proposal 5 requires a super twothirds majority to pass any tax changes meaning just thirteen representatives could block over a hundred.

The board decided to send the issues through policy committee to improve the language before the next meeting.

In other school news, the orchestra, choir and band teachers requested permission to take students to the Heritage Music Festival in Philadelphia, April 17 through 21. The teachers have already obtained a \$100 deposit from most students interested in going. The total cost of the trip is \$650 per student and they would have an opportunity to participate in clinics at Pennsylvania State University and play at the World Strides Heritage Performance Program in Philadelphia.



Friday night lights showed a great first quarter for the Bulldogs, with two touchdown runs by Berkley Edwards to rack up 14 points at the end of the first.





The ensuing drive after the free kick the Pirates drove down the field and made it 14-0 on a two yard run by Chapman.


The lead stayed that way until Walled Lake made it 14-87 with a touchdown run with eight minutes left in the third.


Continued from the Front Page Although Act 196 dictates each municipality to opt out by November 2 or automatically be considered part of the authority, Keough felt strongly that doing nothing was not enough. "The responsible thing to do is pass an actual resolution and send it back to the AATA as part of our response," he said. "If we're subjecting our residents to a millage vote, they should at least be able to point back to action made by the board as to why they're being taxed."

Keough added that written feedback from village residents indicated that most support having an opportunity to vote on a transit millage.


Village resident Julie Boyd requested council direct the neighborhood adjacent to the Wellness Center needs a thicker buffer zone for the

benefit of both homeowners and future patrons of the fitness center. "It is the wonderful small-town feel that brought me to Dexter," shestated. 

# To our neighbors —

As many are aware, there are various projects underway to replace our Line 6B pipeline in Indiana and Michigan. We are replacing certain segments of Line 6B this year and we plan to replace the remaining segments of Line 6B by the end of next year. The goal of these projects is to assure the continued use and security of Line 6B as well as to meet the energy demands of refineries in Michigan, Ohio and eastern Canada in the least disruptive manner possible. These projects will benefit the community by increasing the reliability of the pipeline, lessening maintenance activities, increasing access to stable North American crude oil supplies for local refineries and providing additional jobs associated with the projects' construction.

In recent months, we have heard directly from community members who have questions about our Line 6B replacement projects. You have told us that you want to know more about the projects including how agreements are made with landowners, the safety and integrity of the construction process, the operation of the pipeline, and the role of regulatory oversight of pipelines and their construction.

There has been much discussion involving information from various sources that are not necessarily familiar with the pipeline industry or our projects, so over the next four weeks we will use space in this newspaper to share project updates and to address some of these questions. We will expand on the purpose of the projects and what community members can expect from us. We will present our process for reaching right-of-way agreements with landowners. We will also provide insight into the regulatory process and requirements guiding the projects' development.

As part of our commitment to open communication with the community, we have enhanced our website with more details on the projects and our toll-free hotline is always available for community members who may have additional questions about the projects.

We value the relationships we have developed over more than 40 years of pipeline operation in Michigan and we look forward to continuing those relationships, which are built on trust and ethical dealings with all stakeholders.
