In late June of 2011, three buddies set off on bicycles from the shores of the Arctic Circle for the crosscontinental adventure of a lifetime. The trib would pedal diagonally across the continent from Prudhoe Bay, the northernmost tip of Alaska, to Key West, the southernmost tip of Florida.

A roughly 5,900 mile trek. the journey would be divided into two legs over the course of two summers, with Edmonton, Alberta Canada serving as the midpoint. But, after completing a grueling first leg in 2011 and the bulk of the second leg the following summer, only two of the three made it back home to family and friends.

Approximately 700 miles from reaching the end of the epic journey, one of the three adventurers' lives came to a tragic end. And the two remaining lives will never be

> quite the same. Joe Muscato, 60, and Tom Clark, 62, avid cyclists from the Stockbridge area, pedaled an unforgettable 5,200 miles with friend and touring partner Pete Cornell, 64, before the unthinkable happened - Pete, an elite cyclist, was killed just before daybreak on July 26, 2012 when a semi-truck hit him while riding his bike in Dawson, Georgia.

Joe and Tom were also struck from behind by the rig and were thrown into a ditch. Tom suffered extensive injuries requiring weeks of hospitalization while Joe suffered minor physical injuries.

Just four months later, Joe guided Pete's son and non-cyclist Dan Cornell, 41 of South Lyon through the last 700 miles of the original trio's journey. Honoring Dan's request for help in finishing what his dad started, Joe returned to Dawson, Georgia where he last pedaled alongside Pete.

Following Pete's maps, Joe. and Dan left Dawson by police escort December 7, 2012 and seven days later entered Key West in bittersweet triumph.

Finishing a Mission, Honoring the Life of a Friend Arrests Made In Connection With Alleged **Armed Robbery In Stockbridge**

Two Stockbridge men were arrested last Thursday in connection with an alleged armed robbery of Hungry Howie's in downtown Stockbridge that took place April 9, 2011. Matthew Klann and Jerome Burger, both 20, were arrested in their shared apartment in the 800 block of Clinton Street.

Stockbridge Village Police Chief Johnnie Torres said police were called to Hungry Howie's after a 911 call from the gas station across the street. The caller, Mathew Klann, then employed by the pizzeria, told dispatchers he had just been robbed. Torres said Klann's statement seemed suspicious. Police secured the scene and brought in K-9 to investigate.

Police believe Klann and Burger and another man traveled to California shortly after Torres approached Klann requesting he submit to a polygraph test. The pair later returned to the Stockbridge area.

Torres indicated several individuals have come forth with information that Klann and Burger together staged the entire crime.


Information suggests that Klann and Burger waited for an opportune moment to stage the armed robbery during a time when customers and other employees were not around. Burger allegedly came in through the side door, took an undetermined amount of cash and left before Klann made the 911 call.

Both were lodged in the Ingham County Jail. Klann is charged with the felony of making a false report of a felony and misdemeanor embezzlement. His bond was


set at \$25,000. Burger is charged with the felony of making a false report of a felony and conspiracy to commit embezzlement. His bond was set at \$15,000.

At press time, neither had posted bail and remained in jail awaiting a court date.


According to Torres. there is no evidence that suggests Burger and Klann were involved in a robbery of a patron outside the same pizzeria that occurred Christmas Eve 2010

County Road Commission Halts Installation of Dexter's Warning Sirens

Dexter Township residents will have to wait a little longer than anticipated for all sixteen outdoor warning sirens to be installed throughout the township. Although the installation process was nearly complete as of December 18, contractor Front Line Plus. Inc. workers were literally told to "pack it up and go home" by the Washtenaw County Road Commission (WCRC) with two left to install, reported township clerk Harley Rider at the December 9 board meeting.

The Frontline crew had already installed fourteen of the sixteen sirens when the WCRC instructed them to cease all installation due to the lack of appropriate permits. The remaining two sirens, designated for McGuiness Road and the intersection of Fleming Road and Dexter-Pinckney Road, are assembled and sitting in storage, said Rider.

He strongly disagreed with WCRC's action, saying Frontline had numerous verbal contacts with WCRC to ensure the project's timeline for installation was mutually agreeable.

Rider reported both he and Frontline provided the county with all of the requested. documentation, including

permit applications, location maps, addresses of homes located near the sirens. and longitude and latitude coordinates for the siren sites. "[Frontline] checked in with the county once again on December 10 and received assurance that everybody was still on track for December 14 installation," said Rider. "They gave us no cause for concern. We had every assurance to

move forward."

WCRC representative Matthew MacDonnell said there was a miscommunication between Frontline and the county because "sirens were going up in locations that were undesirable to us and before we issued permits." MacDonnell said the WCRC had approved only five of the thirteen permits for sirens located near roads in the county's right-of-way, and that the remaining proposed siren locations did not meet the county's setback requirements. Public utilities are required to be 28 feet from the center line of the roadway, said MacDonnell.

WCRC has since approved all permits, however, Frontline Plus, Inc., a Minnesota-based company, will not be available to return to Dexter until January. Further, MacDonnell said the county will reassess

the locations of the sirens and send a written letter to the township advising which sirens need to be relocated.

"It doesn't make sense," said Rider. "We went through the map thoroughly with the road commission.'

In similar news, acquisition of property at 11485 North Territorial—the proposed future home of the voter backed fire substation-is also on hold while Supervisor Pat Kelly waits for a response from property owners PJK Dexter, LLC.

An offer on the property was tabled at the November 20 regular meeting when Trustee Carl Lesser requested clarification of the purchase agreement executed October 1 from township attorney Peter Flintoft. Upon receiving Flintoft's opinion, the board voted 6-1 to authorize Kelly to finalize the purchase at a special meeting November 30. However, Kelly reported the property owner has not returned her phone calls to date. The majority of board members agreed their next move is for Kelly to send a written letter to PJK Dexter, LLC expressing their continued interest in the property under the original terms. "Doing things orally just doesn't work," commented newly elected trustee Bill Gajewski.

Meanwhile, Public Safety Advisory Committee member Dominic Treglia suggested looking for other potential properties for the substation. "I don't want this to delay construction. That wouldn't be fair to the firefighters. Just give us the word and we can start working on this tomorrow."

get the bids in, award the contract - we miss the construction window to remove the trees before spring. We are going to delay this right out of being able to afford it," Klein was quoted in the article.

The Panthers struggled in the first quarter as the Cougars took an 8-2 lead after one period.







Could That Be the Case?





The council - referred to informally as the Youth Conservation Council - was created by NRC resolution earlier this year to provide a



Finishing a Mission, Honoring the Life of a Friend

Veterans of the road, Joe and Pete tackled four previous cross-country bicycle tours together prior to the final tour that was to be Pete's last. It was Tom that was the newcomer to the group and to the extensive mileage to which

Joe and Pete were accustomed.

A long-time friend of Joe's,
Tom first met Pete at the
Anchorage airport on their way
to Prudhoe Bay. "I was a bit
intimidated," admitted Tom,
keenly aware of Pete's high
standards for touring partners,
"But something snapped, the
three of us were a magical
blend. We connected instantly
and we stayed connected.
Everybody took care of
everybody."

The threesome successfully navigated the Alaskan wilderness for weeks with no support crew, including the renowned Dalton Highway featured in the History Channel's Ice Road Truckers reality show. They powered up steep grades, traveled across gravel the size of grapes, while enduring flat tires, constant rain, mosquitoes, black flies and the occasional grizzly.

They conquered Atigun Pass, the highest mountain pass in Alaska reaching nearly 5,000 feet where the Dalton crosses the Continental Divide. Arriving in Edmonton six weeks later with 2,500 miles behind them, they said goodbye — with a promise to meet there again in early July 2012.

Despite a glitch at the airport preventing Joe from meeting Pete and Tom in Edmonton, the three reunited in a matter of days when Joe rode his bike across the border to get to his friends. From Canada, they pointed their bikes south toward Florida and began blazing through one of the hottest U.S. summers in

recorded history. On a mission and in a groove, the comrades were blind-sided with disaster 700 miles from the Florida finish.

While Tom continues to recover physically with the help of physical therapy and at least two upcoming surgeries, both men struggle to heal those injuries that are invisible to the eye.

Reflecting back on the tour, Joe is comforted in his belief that "it is not so much the accomplishment that matters, but the living it day to day." And Joe has a treasure-trove of memories to remind him that he and his friends did, in fact, live their touring days to the fullest.

He laughs remembering the string of 110-plus degree days where highway overpasses were the only available shade-except for the day, of course, when he and Pete spotted a shade tree on someone's front lawn and made themselves comfortable. It wasn't long before the homeowners approached the two exhausted, dehydrated men with huge glasses of ice water and cheesecake to boot.

He cries when he remembers riding alongside Pete on a rolling Midwest road singing Buddy Holly's "That'll Be the Day."

Joe, a group and personal fitness instructor, and Pete, a three-time NCAA All-American wrestler are both highly goal-oriented men by nature. Often heard quoting Thomas Huxley in saying, "The great end to life is not knowledge, but action," Joe finds the words particularly meaningful today.

The simplicity of Jimmy
Buffet's words ring truer for
Joe these days as well: "Some
of its magic, some of its tragic,
but I've had a good life along
the way."

Tom likes to remember the day Joe and Pete, after six days of not showering on the Dalton Highway, invited Tom to join them in jumping into a refreshing brook by the side of an Alaskan road, sans clothing. "I said no way and sat on the bank watching the two of them. They got refreshed all right...it was glacier water!"

Tom felt honored to be included in the group and accepted by Pete, even though he kept a consistently slower pace than his friends. He typically would arrive for lunch or the motel several minutes behind the more experienced cyclists, but in the end could match every mile.

From what Joe can tell and unbeknownst to Tom, it was Tom's attitude that played a significant, albeit unwitting role in what seemed like Pete's personal transformation during his last tour. A driven, focused man determined to meet the day's timeline. Pete was different this tour. He was more relaxed, "more in the moment than presiding over the moment," said Joe. It seemed this new friend was giving Pete an enormous gift just by being himself.

After Pete's death, Tom desperately wanted to ride those last 700 miles with Joe and Dan since Dan spoke of the idea in July, but his body was not ready. "I will finish the trip someday. That is my commitment to myself," he vowed.

As for Joe, he's not sure if he'll ever tour again. He usually takes a year off to reflect, but suspects this respite may last indefinitely.

"Maybe a dirt road with no traffic and fat tires on my bike. And I'll take my time." he said wistfully. One got the sense that, well, that'll be the day when he says goodbye.
