Report Endorses Change Of Village to City, Lists Many Advantages

to be little to lose and a lot to gain from the Village of Chelsea becoming a city, according to a final report from the committee studying the question.

The seven-page report was scheduled to be presented to village council last night by the committee, appointed last summer by council to study the ramifications of changing to a city.

"It is the recommendation of the committee that Chelsea pursue incorporation as a Home Rule City," the report concluded in its preamble.

When the committee began its work in July, it appeared there was little support among its members for the change.

"I don't think anyone was in favor of the idea," said committee chair Jack Merkel.

"Some members were ambivalent about it. and some were outwardly opposed to it. But as the information came in, we began to think it was a good thing to do. I've talked to a lot of people about this, and there seems to be the feeling that maybe the time has

The greatest drawback to such a change, Merkel said, would probably be "the psychological impact" on Sylvan and Lima townships. With city status, the townships would lose a portion of their tax base. They might also feel somewhat intimidated by a city, which is a primary unit of government in the state. A general law village, such as Chelsea, "really doesn't have any authority," Merkel said, and is subservient to the townships. One area in particular is in property assessments. Each township is responsible for their areas within the village. Each township has a board of review.

Merkel also said that a "village" seems "small, safe, and quaint" while a city "is something you see on the evening news." The report indicated

For village residents, there appears there is apparently no reason Chelsea can't continue to call itself the Village of Chelsea, even with city status.

> "We'll recommend that we keep the title of village," Merkel said.

> Each of the nine members of the committee had a particular subject to research. In addition, the group heard presentations from David White. Saline city manager and former manager of the Village of Capac, and Dr. Lynn Harvey, associate professor at Michigan State University.

According to the report, the main advantage of becoming a city is that citizens can create a city charter that best serves the specific needs of Chelsea. A general law village derives virtually all its power from state law and has little flexibility.

The charter, for example, can specify the maximum millage a city may levy, to a maximum of 23 mills.

"Incorporation as a home rule city would not require or create the need for any increase in taxes." the report concluded.

according to the report, are: · Residents would only have to deal with one form of government, rather than two;

• There's assurance that statecollected, locally-shared taxes are returned to and used in the most densely populated areas;

• Elimination of township taxes and

duplicated services. Townships do not contribute, for example, to road projects within the village limits, yet residents there pay township taxes;

· Contracted services, such as fire protection, can continue to be provided to the townships:

 There is less state interference with home rule cities:

 Cities and townships may negotiate to share tax revenues when property is annexed.

There are some additional longterms costs associated with the change. The city would have to hire an assessor and the average salary, the report says, is about \$24,000 plus fringe benefits. The city would have additional elections to conduct, including county, state, and national elections, at an estimated cost of \$2,400 per election, or an estimated annual cost of \$3,600. It would have to collect school and county taxes and maintain voter registration lists.

"There is little evidence to indicate that the long-term financial implications of incorporating as a home rule city would be appreciable." the report concludes.

With the change, Sylvan township would lose about \$79,500 in taxes, leaving it with \$83,616. Lima township would lose \$9.389. leaving it with **\$**56,330.



Mr. Gast said a two-year budget could be adopted easily, crafting as precise a budget as possible for the first year and essentially adopting a continuation budget for the second year. But while many say the change would give legislators time to focus on other issues, Mr. Gast said nothing is as important as making sure the 19 departments and their programs are run efficiently and properly.





Breast Cancer Study Participants Needed By Health System

Women who are at risk for developing breast cancer are still needed to participate in a five-year study being conducted by McAuley Cancer Care that will help determine if the disease can be prevented through drug treat-

The breast cancer prevention trial study, funded by the National Cancer Institute (NCI), has been approved by the Food and Drug Administration and is endorsed by the American Cancer Society. Nation-wide, 16,000 women will participate in the study, which will test the preventive effects of the drug tamoxifen on women at risk of developing breast cancer. Tamoxifen has been used after breast cancer surgery to prevent development of recurrent breast cancers.

"Recent media reports regarding the side effects of tamoxifen are disturbing because many paint a misleading picture of the drug," said Philip Stella, M.D., McAuley Cancer Care Program medical director and principal investigator of the study. "After careful study, the NCI has determined that tamoxifen is a very safe drug. Far more serious are statistics that show 46,000 women will die from breast cancer this year, and that one out of every eight women will

develop this terrible disease."

The study will also evaluate whether tamoxifen reduces heart attacks and blood cholesterol levels and prevents osteoporosis in women.

"The benefit potential for participants far outweighs the minimal, if any, risks associated with tamoxifen," Stella continued. "Study participants face the distinct possibility of developing breast cancer at some time during their lives, and tamoxifen may very well prevent them from becoming victims. I hope that women do not allow misinformation to prevent them from volunteering for this critical study."

Half of women who participate in the study will be randomly chosen to take tamoxifen daily for five years; the remaining participants will be given placebos. All participants will be closely monitored for the duration of the study and will receive yearly mammograms and physical exams.

Potential participants' risk of breast cancer will be based on many factors, including:

-If they are 60 years of age and

-If the woman is 35 years of age or older and has close relatives who have been diagnosed with breast cancer, or if they themselves have been diagnosed with non-invasive cancer or have had a number of breast lump biopsies.

Their age at the onset of menstruation. -The age at which they delivered

their first child. Women who have been diagnosed with breast cancer are not eligible to

Microwave Your Holiday Dinner To Save Time

can cook in 30 minutes or less. But with your microwave oven and a little planning, you can microwave away F many holiday cooking hassles.

A day or two before the holiday meal, you can microwave vegetables for casseroles, ingredients for the stuffing, fresh cranberry sauce and desserts. Refrigerate these items. Then on the big day, use them to save cooking time.

Small turkeys and birds can also be cooked in the microwave. Use the microwave for small turkeys—12 to 14 pounds-turkey breasts or parts, and boneless turkey. Oversized birds sit too close to the oven's ceiling and cook unevenly. As an alternative, consider microwaving Cornish game hens. Microwave Defrosting Poultry

If you've selected a frozen bird, your first step is to thaw it. If time permits, the best way to thaw poultry is in the refrigerator, which takes a minimum of one day per 5 pounds.

It's possible, but not desirable, to micro-defrost a whole turkey. Because food absorbs microwaves unevenly, thin parts of the turkey can begin to cook while thick areas are still frozen. If you choose microdefrosting, first check your owner's manual for advice and defrosting instructions. Remove the turkey's wrapping and metal clip or tag. Leave in place the hock lock or wire restraining the legs.

You'll have to rotate and turn the bird over several times during defrosting. Use the times recommended in your oven manual or about 6 to 8 minutes per pound on mediumlow (30 percent power). Shield areas that begin to warm by crimping small pieces of aluminum foil over them to

prevent cooking. Use the same procedure to thaw turkey parts, boneless roasts and other poultry or follow package in-

structions. After micro-defrosting poultry, cook it immediately.

Microwave Cooking Turkey Once the turkey is defrosted. remove the giblets and rinse the bird under cold running water. Pat dry with paper towels.

It's perfectly safe to microwave dish, but the USDA does not recommend stuffing a turkey to be microwaved. Foodborne bacteria might survive the shortened cooking

Rub the turkey with cooking oil and brown gravy coloring. Then place it in the appropriate size oven gooking bag. These nylon bags assure a moist-heat method that will help prevent

uneven cooking.

Close the end of the bag loosely using a strip of plastic wrap or dental floss. Don't make slits in the bag because you'll need to turn the turkey over. Place it in a baking dish breast

Microwave the turkey on medium power (50 percent power) 9 to 10 minutes per pound. After half the cooking time, rotate the dish and turn the turkey breast side up to finish

Then let it stand 20 minutes.
If your turkey has a pop-up timer, it should indicate doneness at this time. Use a thermometer and check several places to be sure the turkey has reached an internal temperature of 180 degrees F. Also look for visual signs of doneness: juices should run clear and the leg joint should move freely. Add cooking time if it hasn't reached this

temperature. To use turkey drippings safely, bring them to boil, either in the microwave or on top of the stove. To make gravy from the drippings, measure the liquid. Make a paste of 1 tablespoon each of flour and water per cup of liquid. Stir into drippings; heat until thick.

Pre-cooked Accompaniments
If you've planned and prepared accompaniments to your holiday poultry, dinner's almost ready. While the entree is resting, microwave the accompaniments.

If you pre-cooked vegetable cas-

By Debbie Barrow, Extension Home Economist seroles such as mashed potatoes, A holiday feast is not something you squash or green vegetables, reheat for 1 to 2 minutes per cup on high power or until they reach 160 degrees

> Stuffing should not be made ahead of time but the ingredients for it can be pre-cooked. Place onion and celery in a glass measure covered with vented plastic wrap. Butter is not needed when micro-sauteing, which eliminates calories from fat. Microwave on high power 2 minutes per cup or until softened. Refrigerate up to three or four days.

Sausage for stuffing can be microwaved on high power 5 to 6 minutes per pound. Stir or rotate midway through cooking. Drain fat; refrigerate as above.

Measure other ingredients for the stuffing but combine them just before heating on the feast day-about 30 seconds per cup on high or to 160 degrees F. If you desire a brown crust, heat stuffing in a conventional oven for 20 to 30 minutes.

If you like warm fruit or nut pies, reheat the pre-baked pie according to package directions or 20 seconds per slice. Frozen unbaked pies cannot be microwaved, so bake them ahead of time in a conventional oven. Pies in metal pans must be transferred to glass pie plates or microwavable plates for reheating.

After dinner, debone the turkey and return leftovers to the refrigerator within two hours after cooking. Store gravy only one or two days; leftover turkey, three to four days. Or freeze the foods for longer storage. **Microwave Giblets**

Place turkey neck, gizzard and heart in a 2-quart casserole with 3 cups of water. Cover with lid or vented plastic wrap. Microwave on medium (50 percent power) 35 minutes. Add liver, re-cover and microwave on medium 10 minutes. Strain broth to use in making gravy or for moistening stuffing.

Deciding How Long To Microwave Foods

.In the microwave, literally every second counts. When recipes give a range of time, such as 8 to 10 minutes per pound, which timing do you use for your oven so food gets cooked safely? This test from the International stuffing separately in a casserole Microwave Power Institute can help you determine your oven's cooking speed.

Time-to-Boil Wattage Test From a container of half ice and half water, pour exactly 1 cup of water (no ice) into a 1-cup glass measuring cup. Place in the center of the microwave oven. Heat on high power for 5 minutes or until water begins to boil. If water begins to boil in less than 3½ minutes, consider your oven "bigh power"; if longer the oven "high power"; if longer, the oven is "low power."

When using recipes and package direction, set a high power microwave oven for the minimum time recommended. If your oven is low power, it probably will take longer. However, always check for proper doneness by using the indicators that recipes and packages describe, such as internal temperatures and appearance.

AN OPEN LETTER FROM THE

NORTH SHARON BAPTIST CHURCH As pastor and congregation of the North Sharon Baptist church, we would like to take this opportunity to express our feelings concerning allegations of criminal wrongdoing on the part of two of our church members.

First, let me say that this letter is not intended as a defense or a rebuttal; rather, it is a sincere effort on our part to speak to our community concerning this extremely sensitive situation.

North Sharon Baptist church has been active in serving our community for a very long time. For over 25 years your church has been providing free bus transportation for children, as well as for adults, to our Sunday school programs. We operate our bus ministry in a fashion typical of thousands of other Baptist and denominational churches. These traditional methods have been used safely and effectively by churches for many years.

We have worked with the community in helping with all sorts of needs-physical as well as spiritual. We would like you to consider the

following facts: 1. The moment we were made aware of these allegations of misconduct, the church requested and the men voluntarily agreed not to be involved in any of our ministries that have to do with children until this matter is resolved. This decision was made in spite of the fact that the church has always known the men involved to be of extra-ordinarily good character. This decision was not based on any assumption of guilt; it was based on our desire to act carefully and prudently, and to co-operate fully with law enforcement officials.

2. We dedicated ourselves to give law enforcement officials our 100% co-operation with their investigation. We have attempted to go to any effort to be sure information requested by police investigators was available as quickly as possible. Church secretaries put in extra hours in the gathering of records and preparing of any other information requested by police authorities. We are committed to continue co-operating until this situation is fully resolved. We have been commended for our thorough and complete co-operation with all authorities in the current investigation.

3. North Sharon Christian school is not involved in any of these allegations. Our school is in its 21st year of operation.

4. Pastor and congregation of North Sharon Baptist church are extremely concerned for our entire community. To the best of our ability, we endeavor to help anyone in the community who

We, as a long-established church in this community, ask for your prayers and understanding during this extraordinarily difficult time. We want the privilege of continuing to help with the physical and spiritual needs of our community. We extend an invitation to you to attend our services and ask that you come see our church for

yourself. We also want to take this opportunity to express our appreciation for the many letters and telephone calls of encouragement that we have received during this time. God bless you.



Q. Can you tell me what is the difference between the New York Stock Exchange, the American Stock Excange and the NASDAQ systems?

A. All three are designed to provide a market so that people who want to sell stock and people who want to buy can come together conveniently and get the best price at the lowest cost.

The New York Stock Exchange and the American Stock Exchange are auction markets. That is buyers and sellers go to brokers who have access to listing their orders on the Exchange and when a buyer and seller agree on the price a sell or a buy takes place. Orders on the floor of the Exchanges are handled by specialists who bring all the buy and sell orders for one stock together in one place. To smooth The process they may buy and sell for Mileir own accounts when buyers and

sellers prices do not match. The NASDAQ system differs from an auction market and is called a dealers market. When you want to buy or sell you give your order to a broker, who checks with the brokers Swho handle the stock you are in-Iterested in. These brokers do what is Scalled "make a market" for the stock. ~ They buy their stock for their own ineventory and sell from their inventory. If the market is active they may match orders, but the transactions on the market are for dealers' accounts. NASDAQ provides the facilities so brokers can check orders with one another.

If the broker makes a market in a security, they make their profit from buying and holding in inventory and seding at a mark up in price. If your ker does not make a market in a ecurity, they will trade with a prokerage firm who does make a narket. Your broker will add its egular commission to the transac-





Assistant Pastor Faces New Allegation, Charges Against Deacon Stand

All seven Washtenaw county charges of child sexual molestation against North Sharon Baptist church assistant pastor Timothy L. Leonard were dismissed last Wednesday in 14th district court at a preliminary examination

amination.

Judge Thomas Shea would not hear testimony from three children age three and four. A similar ruling earlier in Jackson county resulted in charges there being dismissed against Leonard by Judge Carlene

Both judges said the children are too young to testify and cannot discriminate between telling the truth and telling a lie.

Before Leonard could be released, however, he was arraigned on an additional count of first-degree criminal sexual conduct against a nine-year-old girl, allegedly at the church. He was ordered held without bond in the Washtenaw County Jail. He faces a Dec. 23 preliminary examination.

However, deacon Mark R. Foeller, a Chrysler Corp. engineer, will stand trial in Washtenaw County Circuit Court on two charges of first-degree criminal sexual conduct. Arraignment was set for Tuesday, Dec. 29.

A nine-year-old boy testified that he was sodomized by Foeller in the restreery of the church's Sunday.

A nine-year-old boy testified that he was sodomized by Foeller in the restroom of the church's Sunday school as other children used the restroom during class breaks. He also claimed that he was forced to perform oral sex on Foeller during a camping trip. On the same trip, which included several other boys, he said Foeller sodomized him and performed oral sex on him.

The boy, from Saline, said, "I didn't think what he was doing to me was right."

Additional testimony from a five-year-old boy resulted in the continuation of a second-degree criminal sexual conduct charge against Foeller. It also resulted in one count each of first and second-degree criminal sexual conduct being dismissed. The boy said Foeller took him out of his Sunday ing s







Chelsea was 25-54 from the floor for 46 percent, while Milan was 28-57 for 49 percent.


The Bulldogs, again, were beaten badly at the line, 6-12 compared to 16-28 for Milan. Dunham had five steals and eight

The hearty spirit of Paul Bunyan remains here, still hovering above this wooded region of the state. He burst into being during the mid 1800's, a glowing imaginary figment from the fertile minds of hardy loggers who toiled mightily to harvest the great forests of the northeast. Resting companionably around permits are on sale at all Metropark flickering campfires, after a day's offices and at the administrative of- hard work, these robust men entertained one another with hilarious whoppers, especially of Paul Bunyan

> How many people know that the first man to write down some of the amazing episodes of Paul Bunyan lived in Oscoda? This was a Canadianborn newspaperman, James Macgillivray (1873-1952), who heeded his editor's demand for a story for the Sunday section of his newspaper. Thereupon, the inventive Macgillivray went to his typewriter and composed "The Round River Drive" which appeared in that paper in July 1910. This is the earliest known reference to Paul Bunyan in print.

> and his tremendous feats of strength.

Macgillivray's prose version of the Paul Bunyan saga contains many of the better known tales of this giant who has so vividly captured the awed admiration of generations of loggers and readers fascinated by folklore. That long-ago era produced its share of incredible men who stood up against back-breaking toil and unbelievable hardships to furnish the civilized world with lumber.

At the age of 79, James Macgillivray died. His home in Oscoda, where he lived for 17 years after his retirement from newspaper work and his job with the Michigan Conservation Department, still stands on the main street. This modest gray building is presently occupied by a real estate of-

To commemorate the spirit of Paul Bunyan, years ago the city fathers of Oscoda arranged to have a huge statue of this mythological figure erected on a playing field just off US-23, in the heart of town. Posed with his famous axe, the statue has long been a fond landmark of the area, forever reminding citizens and visitors of Paul Bunyan's importance and prominence in the enduring folk-

Then, during this past summer, the statue was removed from its pedestal by order of the superintendent of the Oscoda Area School system. The land upon which Paul stood belonged to the school. In need of a paint job and touch-up, the papier-mache figure was hauled off to one of the township's

garages where a trio of volunteers completed the renovation in about two weeks of part-time work.

However, the intent was not to have the statue returned to its original spot. The Oscoda Area Schools has reseeded the plot of land where it once stood, and an impressive soccer field sprawls across the area.

It did not take the townspeople long to sense something was amiss in the center of town. Soon, irate calls began to flood the township offices with questions surrounding the disappearance of the statue.

Within days, a petition drive gathered steam with the intent of returning Paul to his place of glory. However, the school system did not want the statue on its property, and so it began a campaign to find a new plot for Paul to stand. Keeping Paul in town was a priority for the town, but no one was offering the needed real estate. In a last chance effort, petition organizers descended upon the school board with demands that Paul be returned to his rightful place.

With much reservation, the school board relented and preparations began to erect the statue upon a new foundation. And where is Paul now? With a coat of new paint and standing comfortably upon a solid base, Paul overlooks visitors and locals less than 200 feet from his original site.

Now if only this kind of heart and soul goes into keeping the town intact after Wurtsmith Air Force base closes next July, the area will surely become legendary in itself.

Keep Holiday Foods Safe By Following Simple, Basic Rules

By Debbie Barrow, Extension Home Economist Keep your holiday food safe by following basic safe food handling principles throughout the holiday week-end.

 Keep hot foods hot, cold foods cold and everything clean, and don't leave any food in the danger zone (between 40-140 degrees F) for more than two

 Foods containing meat, poultry or dairy products are perishable and must remain refrigerated until you're ready to use them. These include pumpkin, custard or cream-type pies, and cakes with cream cheese or eggwhite icings.

• You CAN leave out for most of the day raw fruits, fruit pies, most cakes (see above for exception) and sweets. · Save space in your refrigerator by

cooking foods from the frozen state. Just cook 11/2 times the recommended cooking time.

• Don't try to save time by stuffing your turkey ahead!

• If you're buying a cooked, readyto-eat turkey, pick it up within two hours of serving time.

· Finally, put leftovers away as soon as possible.

Trial Scheduled For Seven Charged In Hunter Harassment

Seven men and women are scheduled to stand trial March 1 in Chelsea 14th District Court on charges of hunter harassment.


The charges, specifically "interfering with a hunt," stem from incidents in the Pinckney Recreation Area on Oct. 3 during deer bow hunting season. The group allegedly went into the woods and intentionally tried to drive deer away from hunters using loud noises and other tactics.

The seven are charged with varying numbers of misdemeanors. They are Michael E. Chiado of Plymouth (four counts), Karen A. Elwert of Plymouth

(five counts), Patricia Dodson of Auburn Hills (eight counts), Heidi Prescott of Gaithersburg, Md. (seven counts), Cecilia A. Lash of Mason (six counts), Charles D. Ogar of Holt (one count), and Joseph Taskel of Pittsburgh, Pa. (three counts).

After a pre-trial hearing Dec. 2, the seven were released on personal recognizance bonds with the stipulation that they could no longer interfere with hunters.


An attorney for the group is scheduled to file a motion this month. which will be ruled on in February.





And then to top it off, my missionary companion Dennis and I went to the Rosecrans Shopping Center to do a little shopping, and the Santa Claus there was wearing-are you ready for this?-short sleeves and Bermuda shorts.

Bermuda shorts, for Pete's sake! No wonder I was so uptight.

We wandered around the shopping center for a while. I think Dennis bought a toothbrush or something, I don't remember exactly. I just remember being totally surrounded by the sights and sounds of the season, and totally oblivious to them. It was Christmas, but neither one of us was feeling very Christmasy.

Until we started wandering back toward Santa the beachcomber. That's when we noticed a little girl, no more than 5 years old, standing by one of Santa's teen-age elves, sobbing. For no particular reason I drifted over and asked if everything was OK.


of our means.

Earlier this year the residents of North Lake presented the Dexter Township Board of Trustees with petition signatures indicating a large majority of North Lake residents were interested in looking into the possibility of installing sewers in the North Lake Watershed area.

At the request of the North Lake residents, Dexter township has agreed to fund a feasibility study to define potential service areas around North Lake, study the topography and soils and provide, maps and data regarding population, sewage flow and a recommended sewer system.

McNamee, Porter & Seeley of Ann Arbor has been awarded the contract for performing the study as they were the lowest bidder of five engineering firms responding to a request for proposals sent out by Dexter township. Other services to be provided in the contract include evaluating potential treatment sites, providing estimates of engineering, construction and operation costs based on the recommended treatment system. One of the most important aspects of the study is to meet with affected citizens and local officials to receive input from them on their needs and to further determine interest in a sewer for the area as well as to discuss costs.

Raymond Smit of McNamee, Porter & Seeley has begun work on the feasibility study and as a part of gathering public opinion, a meeting was held at the Dexter Town Hall on Dec. 16. Also invited to the meeting were lake association representatives from Half Moon and Silver Lakes.

Forty-seven people attended the meeting and they heard a presentation by Smit on the different types of sewage treatment and collections systems available. They also reviewed maps which have been prepared showing how a proposed collection system might look around all three lakes. Smit explained there is economy of scale and the more lakes included in the system the cheaper for all concerned. Silver Lake was heavily represented at the meeting and there appeared to be a great deal of interest and enthusiasm.

Many issues were discussed including increased property values, climination of health problems and for some people it may make it easier to obtain a mortgage once the on-site

Residents wanted to know the cost but unfortunately until the study progresses further it is difficult to quote costs. Smit did offer that the cost to the property owners might be a little higher than the cost of the Portage Lake Project but he did feel based on his preliminary information that cost would be reasonable and affordable.

Because there have been no petitions from either Half Moon or Silver Lake presented to the township, the lakes association leaders are going back to their areas and will be contacting people both by mail and door-to-door visits to obtain signatures expressing interest in the project. The township will not proceed in any area where there is not a strong majority of interest shown.

Many more meetings will be scheduled and the association leaders will be notifying area residents so they may be kept informed of the progress and the study should the area residents show interest in continuing the project.

Your vision is one of your most valuable

possesions. None of us would purposely neglect, eye care. However, there is one eye disease that has no symptoms, until it is far advanced. This disease is glaucoma. Glaucoma is a condition in which the pressure inside the eye is abnormally high. Slowly, over a long period of time, this pressure gradually damages the nerves in the eye, and causes, blind areas in our peripheral, or side, vision. You cannot feel this pressure, and the defects in the side vision are not noticed until they are far advanced. Once vision is lost from glaucoma, it cannot be recovered.

How can I tell if I have glaucoma? There is no way you can tell on your own. You cannot feel the pressure. You must have an examination by your eye doctor to detect glaucoma.

Does glaucoma affect only older people? No. Glaucoma can affect anyone from an infant to the elderly. It is more common in persons over 40 years old.

Is glaucoma hereditary? It tends to run in families. If there is glaucoma in your family, it is more likely that you could have glaucoma, but if it is not in your family, you can still have it.

Is there treatment for glaucoma? With modern methods, nost cases of glaucoma can be controlled. This is usually done using eye drops. The laser can also be used for some cases of glaucoma.



Martha Musson . . . Christmas was a delightful time at "Spring Valley" farm where nine of us were born and lived many years.

After dinner we all went into the parlor and after a little program we had our presents. One year I remember best I received a doll in a cradle and the cloth for a new red dress. I was as pleased with the dress material as I was with the doll as being the youngest in the family, a lot of my dresses at that time were made over from my older sisters'


